MAYOR AND COUNCIL:

The governing body of Cheverly consists of a Mayor and a six-member Council, who are elected on a non-partisan basis, for terms of three years and two years respectively. Elections for all Councilmembers are held in odd-numbered years; The Mayor is elected every three years. To vote in Town elections a resident must be 18 years of age, must have resided in Cheverly at least 30 days prior to the election, must be a United States citizen and must be registered in the Town or County election books. Contact the Town Office (301-773-8360) for information. Town elections are held on the first Monday in May.

The Mayor and Town Council enact the policies, regulations and local laws to provide for the proper planning, management and development of the Town. The televised **TOWN MEETING of the Mayor and Council is held on the second Thursday of each month** and the more informal **WORKSESSION is held on the fourth Thursday of each month**. Town meetings are televised and replayed on Comcast Cable Channel 71B. Residents may subscribe to get the meeting agendas on the website . All citizens are urged to attend and participate in the democratic process of governing the Town.

The Mayor and Council appoint a Town Administrator, Chief of Police and Public Works Director to carry out policies, run the day-to-day operations, enforce ordinances and regulations, and to handle the supervision of employees.

POLICE:

The Cheverly Police Department is responsible for providing 24-hour protection in the enforcement of Federal, State and Local laws. In addition to vehicular, bicycle and foot patrol and investigations, the department devotes a great deal of the time to community policing crime prevention, such as home security surveys, and security checks of unoccupied homes. Residents planning to leave town should notify the police to have their homes checked during their absence. Voluntary bike registration, traffic safety and parking enforcement are some of the other activities performed by the Police Department. The speed limit on all town streets is 25 MPH, unless otherwise posted, and radar is used as a means of enforcement.

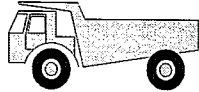
Routine calls for police information, house checks or complaints, etc. should be made to **301-341-1055**.

Non-Emergency calls that require an officer to respond should be made to Prince George's County Communications, (who dispatch our officers), **301-333-4000**, (*ask for the Complaint Room*).

EMERGENCY or **HEARING IMPAIRED (TTY) CALLS** should always be made to: **911**.



PUBLIC WORKS:



The Public Works Department includes the Maintenance and Sanitation Divisions.



The **SANITATION DIVISION** collects garbage from each residence twice-a-week. To ensure less clutter on town streets, all residents are encouraged to take advantage of regular trash pickup at the side or back yard. Garbage must be placed in a suitable metal or hard plastic container not to exceed 32 gallon capacity, with a tight-fitting lid, and must be readily accessible to the collectors.

Note: Cheverly Avenue divides the Town into East & West Sides
(Community Center is on East side — P.G. Hospital Center is on West side)

If you place garbage cans at the curb they should be **at the curb before 7:00AM** on the day of pick-up, **but not before 7:00PM the day prior to pick-up** and be removed by 7:00PM on the day of pickup.



Do not leave any trash or containers in front of your house except the day of pickup. This is a municipal code violation, and you can be fined.

SPECIAL TRASH COLLECTIONS: large/bulky items

(old furniture, rugs, small appliances, odd junk, etc...)

collected Thursdays (East Side) & Fridays (West Side)

Items must be placed at the curb **before 7:00AM** the day of pickup, but **not before 7:00PM** on the day prior to pickup. All loose materials must be in containers and not exceed 50 lbs. *

Materials that WILL NOT be accepted for collection:

APPLIANCES (see note below)	CONSTRUCTION MATERIALS
AUTO PARTS (including TIRES)	HAZARDOUS WASTES (such as oils & paints)
BRICKS, CONCRETE, ROCKS, etc.	RECYCLABLES (Wednesdays only—see next pg.)

*Special Pickups of very Large amounts, or at a special time can be arranged for a FEE based on the amount of trash. Call Public Works (301-773-2666) to make arrangements.

LARGE APPLIANCES (washers, dryers, stoves, refrigerators, air conditioners, etc.) **cannot** be included in special trash pickups. Residents must make special arrangements for pickup and pay a **\$20 fee for removal**, due to E.P.A. processing requirements.



The **MAINTENANCE DIVISION** of Public Works maintains the physical facilities of the Town and provides: maintenance and repair of streets; construction and repair of sidewalks, curbs and gutters; snow and ice removal; maintenance of Town buildings, parks and playgrounds; care of trees between the sidewalk and curb.

Other special services include fall leaf vacuuming; collection & recycling of yard waste; collection of mixed paper and electronic equipment. (See instructions next page).

YARD WASTE

Yard waste is collected every **MONDAY**.

- Tree limbs and brush** must be cut to no more than 4 feet in length, and tied in bundles.
- Leaves and grass trimmings** should be placed in clear plastic bags which can be purchased for cost at Town Hall.
- All loose materials** must be placed in containers and not



exceed 50 pounds.
Yard waste should NOT be placed out before 7:00PM on Sunday.

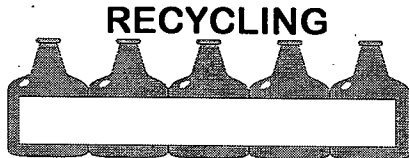


In the Fall, LEAVES are vacuumed from the curb. Check Fall newsletters for a vacuuming schedule.

Leaves and Yard Waste are ground and processed into **MULCH** at the Public Works Yard (Recycling Facility) and can be delivered to residents in the spring & summer (for a nominal fee).

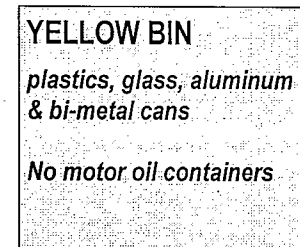
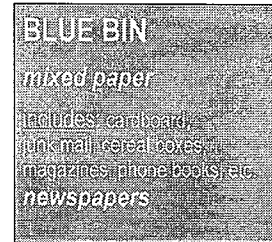
HAZARDOUS WASTE:

Household hazardous waste, tire dumping, and battery recycling allowed at the Brown Station Road Sanitary Landfill (11611 White House Road, Upper Marlboro) Thursday, and Friday. . For more information please call 301.883.5045.



Cheverly has a tradition of being environmentally conscious. **Blue and yellow bins** are used for recycling and are available at Public Works if you do not have them. Bins should be placed at the curb before 7:00AM on Wednesday, but not before 7:00PM on Tuesday evening, and removed by 7:00PM Wednesday.

RECYCLING pickups - EVERY WEDNESDAY



There is an electronic equipment (televisions and computers) pick-up. On Wednesday with you other recycling pick-ups. There is no charge for this service.

REMINDER: The Public Works Crews **DO NOT** work on holidays. **ALL** trash collections are **CANCELLED**.

TOWN ACTIVITIES:

CHEVERLY DAY: is held each year, commemorating the founding of the Town. The celebration includes children's games, activities, concerts and a fireworks display. We also try to have a parade every 5 years. Annual dates vary.



EASTER EGG HUNT: an Easter Egg Hunt is held by the Cheverly Recreation Council in Town Park for children (third grade and younger), accompanied by a parent. Details are published in the newsletter.



HALLOWEEN: "Trick or Treating" is always on Halloween, October 31, from 6-8PM for children through 8th grade/13 yrs old. (*Turn your porch light on if you want to participate*). The Cheverly Recreation Council sponsors a Halloween parade & party for Town children, on the weekend nearest Halloween. Details are published in the October newsletter.



TREE LIGHTING CEREMONY: in early December the citizens of Cheverly are invited to attend the annual holiday tree lighting ceremony (at Legion Park), and join the singing of carols. Details, date & time is published in the newsletter.



HOLIDAY HOUSE DECORATION CONTEST: the Mayor and Council sponsor an annual, holiday house decoration contest. Recognize outstanding displays and present the winners at the January Town Meeting. Results are published in the newsletter.

GENERAL INFORMATION:

SWIMMING POOL: The *Cheverly Swim and Racquet Club*, located at 5600 Euclid Street, is a **private club** that offers a handicap accessible pool with lap lanes, two diving boards, a slide, a fenced in baby pool, a snack bar, six tennis courts, wall ball, basketball court, sand volleyball court, putting green, ping pong, shuffle board, swim team, private and group swim lessons, water babies, tennis team, private and group tennis lessons. — The *Ellen Linson Swimming Pool*, at 5211 Calvert Road off Kenilworth Avenue is the closest County Public Facility.



ICE RINK: *Herbert Wells Ice Rink*, located at 5211 Calvert Road offers many ice-skating programs during the winter.

RECREATION CENTERS: Cheverly residents have easy access to 3 Prince George's County Community Centers that offer gym and exercise rooms as well as a host of recreation pro-

grams. **Cedar Heights Comm. Cntr.**, at 1200 Glen Willow Drive (off Sheriff Road just east Cabin Branch); **Bladensburg Comm. Cntr.**, on 57th Avenue just North of Bladensburg High School; and **PG Sports and Learning Complex**, at 8001 Sheriff Rd next to Fedex Field.

TOWN ORDINANCES:

Following are some Town ordinances of particular interest to residents. Further information about the Town Code can be obtained from the **Code Enforcement Officer (301-341-1055)** and on the website at <http://www.municode.com/resources/gateway.asp?sid=20&pid=10544>.


ANIMALS: Owners or custodians must control all animals so as to prevent them from molesting the persons or property of any other person. No domestic fowl, bees, livestock or wild animals may be kept within the Town. All cats and dogs must have a valid rabies vaccination and be licensed by Prince George's County. They must be securely confined or effectively restrained from running at large. When "walking" dogs or cats off the



owner's property, they must be kept on a leash, and any fecal material left by the dog must be removed by the animal's owner. It is unlawful to keep any dog or cat in Town which disturbs the peace and quiet of the neighborhood by creating excessive noise, offensive odors, or unsanitary conditions. The only Pit Bulls allowed in Prince George's County must have been owned & registered by the resident prior to February 3, 1997.

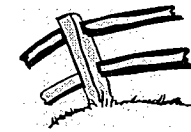
BICYCLES: It is unlawful to ride a bicycle at night without a white light on the front, visible for 200 feet, and a plainly visible red light or reflector on the rear. All persons 16 and under riding a bicycle must wear a helmet. Riding two or more persons on a bicycle is prohibited unless the bicycle is designed for that purpose. Bicycle riders are required by the State of Maryland to obey all traffic laws.



BURNING: It is unlawful to burn trash, branches, rubbish or leaves at any time, within the corporate limits of the Town. 

DRAINAGE: Water may not be diverted so as to flow across sidewalks, driveways, or adjoining property.

FENCES: Fences in front yards are prohibited, as are fences in front of the building restriction line, on corner lots. No barbed wire or chicken wire fences may be erected. Building permits are required for fences over 4 feet and a County variance is required for fences over 6 feet. Before erecting a fence, citizens are strongly encouraged to consult town staff for advice and clarification regarding restrictions.



FIREARMS: The discharge of any firearm or BB gun within the Town limits is prohibited. It is unlawful to supply any persons under 18 years of age with any type of firearm or BB gun, or to supply anyone under 21 years of age with any firearm, other than antique.



NOISE: It is unlawful to disturb neighbors by loud noises.

During the nighttime (9:00PM to 8:00AM), any noise that can be heard from 30 feet away is prohibited.

During the daytime (8:00AM to 9:00PM) continuous noise heard from 30 feet away; intermittent, or impulsive noise that can be heard from 50 feet away is prohibited.

Daytime use of lawn mowers and other power tools is allowed; noise due to construction or repair is exempt during daytime hours.

It is also unlawful to allow a house or vehicle alarm to sound, continuously or at intervals, for over 30 minutes. For purposes of enforcement after the 30-minute period, the owner of the house or vehicle is presumed to be aware of the sounding alarm. Church bells, and vehicles used by public safety, government, and public utility officials are exempt from the law.



Noise complaints should be called into the Non-Emergency police line (301-333-4000). Ask for a Cheverly Officer. For barking dogs, refer to it as a "Noise Complaint."

PARKING: Parking trailers, mobile homes, buses or commercial vehicles, on any street in Town, other than while loading or unloading, is prohibited. A trailer, camper or boat must be parked behind the front setback line of a property. Leaving a vehicle unremoved for over 72 hours on the street is prohibited. Storing of unlicensed or disabled vehicles is prohibited.



RESIDENTIAL PARKING ZONES:

Residential parking zones have been established in areas adversely impacted by excessive non-residential parking (Metro & Hospital areas). Residents of these areas must purchase parking stickers at the Police Department (\$1.00).

PERMITS / LICENSES:

Building permits are required from the Town (in addition to Prince George's County) before any construction, alteration or repair of any structure may begin. This includes driveways, fences and walls.



A **Residential Business License** is required for anyone operating a business out of their home. This license is renewed on a fiscal year basis (7/1-6/30). No retail trade/business is allowed in the residential areas of town. Only an administrative office or daycare, etc., that will not change the residential nature of the neighborhood is allowed. Check with the Town Office if you wish to run a business out of your home.



Rental Licenses are required for all rental properties (including rooms rented). These permits are valid on a fiscal year basis (7/1-6/30). All rental properties are inspected by the Town Code Enforcement Officer.

A **Solicitor's License** from the Town Office is required before soliciting for money or goods of any nature within the Town.

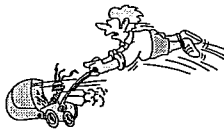
PROPERTY MAINTENANCE: It is unlawful to allow dirt or debris to accumulate on any sidewalk, plant material to encroach on any sidewalk, road or other public space. The accumulation of trash, garbage, waste material, etc. on private property is also prohibited. Property owners must also remove doors from refrigerators before discarding them. In addition, grass, weeds and brush must be kept no more than 8" high, and dead or dangerous trees/tree limbs removed.

SIGNS: Signs may not be attached to trees, street or traffic signs, or utility poles. Special regulations



cover incidental signs on residences, temporary signs, and real estate signs. Check with the Town Office for details.

SNOW/ICE: Residents are required to clear their sidewalks of snow within 12 hours after the end of a snowfall, or 12 hours after sunrise following a night snowfall; and to sand or salt icy sidewalks within 6 hours after any ice has formed.



SNOW/PARKING: No parking is permitted on even-numbered sides of Town streets when snow has accumulated to a depth of 1" or more.* (This does not apply to one way streets or streets with parking limited to one side only). *Until completion of plowing.

SPEED LIMITS: Speed limits on all Town Streets are 25 mph unless otherwise posted. Radar is used to enforce speed limits.

TAX COLLECTION:

Properties in Cheverly are subject to real estate taxes by both Prince George's County and the Town of Cheverly. Property is assessed by the State of Maryland. Tax bills are mailed in July, and are due on or before September 30th. A reduction in your County taxes is made for services provided by the Town instead of the County. For information call Prince George's County Office of Assessments & Taxation (301-952-2500).



INCOME TAX NOTE: When filling out your MARYLAND TAX RETURN, please remember to fill in the COUNTY AND CITY boxes just under your address label. It is important that you print in CHEVERLY as your city, so that the town gets its correct share of Maryland Income Taxes.



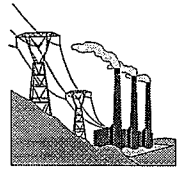
UTILITIES:
