Shaping the Future of Hospital Hill:



If you are currently operating a business out of your home, you are required to obtain a Town Residential Business License.




Home occupations are under (Chapter 9 of Town Code) and (subtitle 27 of the Prince George’s County Code) and do not include any retail business or trade, etc.

Town Residential Business Licenses are issued annually for the Fiscal Year (July 1 to June 30). Please call the Town Clerk at 301-773-8360 or stop by the Town Office to pick up an application form.

The yearly business license fee is \$20.

Message from the Chief

Although the days are “allegedly” getting longer as we move toward Spring, many of us still spend a considerable amount of time driving to and from work, school, and entertainment during darkened hours, walking our pets during early morning or late evening hours, and, when weather permits, children still play outdoors. Visibility is obviously lessened and the need to be more attentive is heightened. On January 1st, a pedestrian was tragically struck and killed while crossing Landover Road with the driver of the striking vehicle leaving the scene. This tragedy highlights the importance of exercising caution when being out during these times. Add poor weather conditions, lighting conditions, distracted driving, distracted walking (wearing earbuds or headphones) and other similar factors, and the hazards are only exacerbated.

Criminal activity also takes advantage of the darkness. We see reported crimes, especially thefts from auto, rise. Recently, there has been increased media coverage across the country regarding theft at gas stations. The unique setting allows thieves to catch their victims by complete surprise — when they are pumping gas or paying their tab inside the station. Most of the time, gas station customers leave their car doors unlocked and items like purses and wallets are often left in plain view. A thief can drive up next to the victim’s car, open an unlocked door, and grab any valuables within reach. Then, the thief quickly drives off. It happens in a matter of seconds.

But these thefts can be easily prevented if the appropriate precautions are taken. Law enforcement recommends the following tips to prevent citizens from becoming victims of theft at area gas stations.

- Pick stations that are well-lit and have video surveillance cameras at the pump.
- Always remove your keys and lock the doors while you are pumping gas.
- Keep valuables out of plain view in your vehicle and lock the doors even if you are going inside for

a moment.

- Pay attention to your surroundings.
- Don’t let your cell phone distract you.

If you do become a victim, please report this immediately to the police department. Video in the area is only as valuable as the timeliness of the reporting. Waiting until you arrive home or to work, perhaps even living or working in a different jurisdiction than where the crime occurred, makes investigating or deterrence of this activity much more difficult.

The Cheverly Police Department has implemented three recent programs to both assist our residents in preventing certain thefts and aide in investigations when crime does occur. The three programs are the:

1. Camera rebate program
2. Wheel lock program, and
3. Steering wheel lock program.

The police department is offering rebates of up to \$50.00 for those residents who purchase and install an outdoor camera system on their home. A similar rebate program to reimburse for the purchase of locking lug nuts for your vehicle is also available. Finally, the department purchased a limited supply of steering wheel locks that can be obtained directly from the police department during regular business hours. More information regarding these programs may be found on the Town’s website.

Our police staff, sworn and civilian, are committed to your safety. We welcome constructive suggestions from our residents with ideas how the Cheverly Police Service may improve to better serve and protect the citizens of Cheverly. I encourage our community to remain engaged with your police department, mindful that the first word in community policing is community.

NOTICE OF ADOPTION OF CHARTER AMENDMENT CAR-1-23
LOWING THE VOTING AGE TO 16 YEARS**

On January 11, 2024, the Council of The Mayor and Town Council of Cheverly (the “Town”) voted on Charter Amendment CAR-1-23 amending Article V section § C-18.1. - Registration of Voters to lower the voting age in the town to age 16 years old.

CHARTER AMENDMENT RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF CHEVERLY, AMENDING §18.1(A), REGISTRATION OF VOTERS, TO LOWER THE AGE AN INDIVIDUAL IS ELIGIBLE TO VOTE IN TOWN ELECTIONS

A Charter Resolution of the Mayor and Council of the Town of Cheverly adopted pursuant to the authority of Article XI-E of the Constitution of Maryland and §4-301 *et-seq.*, Local Government Article, Annotated Code of Maryland as amended.

The charter amendment shall be and become effective on Friday, March 1, 2024 (50 days), unless a proper petition for a referendum hereon shall be filed by Tuesday, February 20, 2024 (40 day), and a fair summary of the Amendment shall be posted at Town Hall for forty days following its adoption.

They will be picked on Thursdays or Fridays with Bulk Trash.**

TREE EVALUATION PROGRAM FOR TOWN RESIDENTS

Did you know you can request one tree inspection per year by the Town's Arborist?



To request a private tree inspection visit the Town website at www.cheverly-md.gov, complete and return the Tree Evaluation Agreement form and submit the \$85 inspection fee.

Fees can be made online or via mail by check. Checks should be made payable to the Town of Cheverly and mailed or dropped off at: Town Hall, Attention Public Works, 6401 Forest Road, Cheverly, MD 20785. Once the inspection is completed the resident will receive a report on their tree. Please note: checks will be cashed upon receipt.

TRASH CAN SIZE FOR COLLECTION

Just a reminder, containers are not to exceed thirty-two (32) gallon capacity.



Public Works will not pick up nor empty trash containers larger than 32-gallons. This is for the safety of our Public Works employees who manually lift each and every trash can.

*In the interim, until you purchase a 32-gallon trash can with a tight-fitting lid, please remove all trash bags from cans larger than 32-gallons and place them on the curb prior to trash collection.



Please do NOT dispose of live trees as yard waste

Artificial trees should be disposed of on bulk trash days. Please note that 'Bulk Trash' is limited to three (3) items, including any artificial Christmas Trees.

During construction of the new William Eley, Jr. Public Works Building, there is very limited space, and Public Works cannot store live or artificial Christmas trees that are discarded on the incorrect days.

No Vacuum Collections on Mondays, Wednesdays and Town Holidays.

Please do not block sidewalks or the streets with your leaves. It is important that stones, branches and other hard materials are not mixed in with the leaves. Please make clear pathways to the leaves so our vehicles can access them. Leaves not visible from the street or blocked by cars may not be collected at the time of pick-up.

If delayed due to equipment failures, inclement weather, or other schedule changes, weekly updates will be provided on the Town's website under News and Announcements and the Public Works social media pages.

Please note that the schedule is in reverse order from previous years.

CODE COMPLIANCE

PARKING COMPLIANCE

According to Code Sec. 18-4.2 and Sec. 27.5

Vehicles that have not moved for 72+ hours may be towed; all vehicles need to be operational & legally operable on both private property and on the street.

Commercial vehicles are prohibited to park in front of residential properties.



TOWN CODE - Sec. 27-10—Parking
A snow emergency shall exist whenever snow has accumulated on the streets to a depth of one (1) inch or more. The provisions of this subsection shall be effective without any notification and shall remain in effect until the street is plowed; provided, however, that when snow shall accumulate to a depth of one inch or more after 11:00PM, the provisions of this subsection shall not be effective until 7:00AM the day following and shall remain in effect until the street is plowed.



PARKING RESTRICTIONS: During a snow emergency no person shall park any vehicle as follows:

- On the cul-de-sac portion of any street,
- On any courts,
- On the even-numbered side of all streets, **(exception)** On the odd-numbered side of 59th Avenue, and one block of Inwood Street between Cheverly Avenue & Belleview Avenue.

NOTE: The snow emergency parking restrictions do not override existing no-parking zones or apply to streets where enforcement would disallow all parking because of a no-parking zone, or to streets with any barrier or strip dividing lanes of traffic.

PRIORITIES: The snow removal operations work under the following priorities: 1.) Cheverly Avenue 2.) principal connecting streets: Forest Road, Crest Avenue, Valleyway, Greenleaf Road, 62nd Avenue, State Street, Schuster Drive; 3.) all other streets.

WINTER WEATHER REMINDERS TOWN

CODE - Sec. 27-10—

Parking A snow emergency shall exist whenever snow has accumulated on the streets to a depth of one (1) inch or more.

The provisions of this subsection shall be effective without any notification and shall remain in effect until the street is plowed; provided, however, that when

snow shall accumulate to a depth of one inch or more after 11:00PM, the provisions of this subsection shall not be effective until 7:00AM the day following and shall remain in effect until the street is plowed.



PARKING RESTRICTIONS:

During a snow emergency no person shall park any vehicle as follows:

- On the cul-de-sac portion of any street,
- On any courts,
- On the even-numbered side of all streets, **(exception)** on the odd-numbered side of 59th Avenue, and one block of Inwood Street between Cheverly Avenue & Belleview Avenue.

NOTE: The snow emergency parking restrictions do not override existing no-parking zones or apply to streets where enforcement would disallow all parking because of a no-parking zone, or to streets with any barrier or strip dividing lanes of traffic.

PRIORITIES: The snow removal operations work under the following priorities:

- 1.) Cheverly Avenue

SIDEWALKS

TOWN CODE Sec. 18-4.1—SIDEWALKS



Whenever snow accumulates to a depth of one inch or more, it is the duty of each occupant to clear the snow from the sidewalk adjacent to that property, within 12 hours after the snow ceases, (unless at night, in which case it shall be removed within 12 hours after sunrise). Snow and ice removed from sidewalks shall NOT be deposited on streets or other sidewalks. When ice forms on sidewalks, occupant shall place sand, ashes or other such material on sidewalks within 6 hours, (unless at night, in which case it can be spread by noon of the next day).

Icy spots on public property can be reported to Public Works at **301-773-2666**.

VACATIONS & HOME SECURITY

Residents planning to be away for vacations should visit <https://www.cheverly-md.gov/cheverly-police-department/webforms/house-check-request> to arrange to have their homes checked while they are gone.

The following items should also be checked to make sure your residence is safe and looks as much as possible like someone is there:

- Cancel newspaper & mail delivery or have a neighbor pick it up for you.
- Arrange for lawn care.
- Store valuables, preferably in a bank.
- Store lawn mowers, bicycles, and lawn furniture inside.
- Set lights inside the house on a timer.
- Set telephone bells as low as possible.
- Draw shades and drapes.
- Lock cars left in the driveway.
- Make sure smoke detectors are working.
- Lock all windows and doors.
- Give your house key & itinerary to at least one friend or neighbor.

OUTDOOR BURNING REMINDER

Sec. 12-3.

- (a) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material on any improved street, gutter, parking strip, parkway, park, alley or any other town property within the corporate limits of the Town of Cheverly.
- (b) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material within the corporate limits of the Town of Cheverly, without first obtaining a permit from the Town of Cheverly, excluding outdoor cooking devices.

SOLID ANIMAL WASTE ORDINANCE



Sec. 4-10 (a) It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of

Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, & play areas of all other parks.

CHEVERLY RENTAL LICENSES

All single-family, multi-family, and roomer rental dwellings in Cheverly are required by Chapter 5 of the Town Code to obtain a Cheverly Rental Housing License.



Licenses are issued annually for the Fiscal Year (July 1 to June 30). Call the Code Compliance Officer at 240-770-7647 for an application.

The yearly rental license fee is \$100.00.

Note: Failure to comply with Town Code licensing laws can result in a fine of \$500.

RESIDENTIAL ZONE PARKING

2024 Residential ZONE parking permits will be available December 15th. The price of the permit is \$5 per vehicle. There is a maximum of 2 guest passes per residence. The first guest pass is free and the second guest pass may be obtained for \$2 fee. (Note: ONLY two guest passes per address.)

CHEVERLY NATIVE PLANTING PROJECT

While Community Native Planting Project would LOVE to focus only on native plants and their benefits, we spend a lot of time thinking about and working on invasive plants as well. In order to ensure we create healthy native plant communities, we need to assess and manage the damage caused by invasive species.

February 26th-March 1st is National Invasive Species Awareness Week. Invasive plants are ones that were introduced to our region through importation for landscaping, as packaging for shipping, and other variety of means. They are able to proliferate so quickly that they degrade natural habitats and water quality, threaten the survival of native plants and animals, and damage ecosystem functions like soil retention and flooding control. After habitat destruction, invasive species are the second greatest threat to biodiversity.

We can see many of the problems linked to invasive plants in our own yards. Many of our trees are at great risk of falling or dying because of being heavily weighted by invasive vines. Beneficial native shrubs and plants are crowded out or smothered by invasive ones. And, some invasives are linked to increased populations of mosquitos and ticks.

Unfortunately, for our natural areas and parks, our yards are where their problems start. It is estimated that over 80-percent invasive shrubs, trees, and vines are escapees from yards and landscaped projects. Even if the invasives on our properties may not seem like they are a problem, they may be causing damage elsewhere because their seeds are dispersed by animals and wind.

While there are too many to list here, ten of the common invasive plant species in Cheverly include:

1. English ivy - *Hedera helix*
2. Japanese and Chinese wisteria - *Wisteria floribunda* and *Wisteria sinensis*

3. Amur honeysuckle - *Lonicera maackii*
4. Barberry - *Berberis thunbergia*
5. Bamboo - *Phyllostachys aurea* and *Phyllostachys aureosulcata*
6. Callery or Bradford pear- *Pyrus calleryana*
7. Burning bush or Winged euonymus - *Euonymus alatus*
8. Wintercreeper - *Euonymus fortunei*
9. Yellow flag iris - *Iris pseudacorus*
10. Nandina or Heavenly bamboo - *Nandina domestica*

development project.





