Motion to approve the agenda as amended made by CM Bryner. 2<sup>nd</sup> by CM Dalaker. Approved unanimously.

#### **Resident Input-**

Joyce Lang – Ward 4 – On behalf of the Women's Club would like to invite everyone to the event honoring of the life of Robin McClain on 4/14/24 at the Cheverly United Methodist Church



Joel Lang – Ward 4 – Feels that Resolution R-3-24 is not in good faith and urges council to agree to mediation to resolve issue with Green Infrastructure Committee

Caroline Gomez – Ward 3 – Expressing support for Resolution R-2-24 urging for a ceasefire in Gaza.

Joyce Jones – Ward 2 – Thanks Mayor, Council and Town Administrator for using the MD Mediation sessions to express concerns on both the town's and the Green Infrastructure Committee's. Is not in favor of Resolution R-3-24.

Karen Dolan – Ward 3 – Express support for Resolution R-2-24 urging for a ceasefire in Gaza.

Laila Riazi – Ward 1 – Is not in favor of Resolution R-3-24. Explained to the public who the Green Infrastructure Committee is and the work that they do.

Julia Mosely – Ward 2 – Believes that Resolution R-2-24 should not be voted on tonight. Feels that the resolution as hastily presented at the work session. Protests how resident input is done in the meetings, and they should be able to add input on each topic.

Daniel Daughtry Wise – Ward 4 – Thanks the Council for agreeing to the mediation with the Green Infrastructure Committee via the PG County group.

Dan Smith – Ward 1 – Concerned about how resident input is being handled at the work session and the town meetings. Suggests that Resolution R-3-24 be deferred until after mediation has concluded.

Sheila Salo – Ward 2 – Urges council members to vote against R-3-24 when it comes to a vote.

#### **Committee Reports**

**Recreation Council** – CM Wade announced the Easter Egg Hunt Event on 3-23-24 @ 11 am hosted by the Rec Council.

**Planning Board** – CM Bryner -The planning board provided recommendation on property near Boyd Park.

Cheverly Day Committee – CM Watson -Monthly meetings have resumed. The date for Cheverly Day 2024 is Saturday, September 28<sup>th</sup>. Always in need of volunteers.

**Board of Elections** – No report provided.



**Ethics Commission** – Thomas Ruyle – The Ethics Commission has been reactivated and is making progress. Currently the commission has interim leaders until the bylaws have been established. The commission is working to ensure that the town gets up to date with the state laws. Financial disclosure forms will be requested of everyone who is required to complete one.

**Proclamations** – Mayor Munyeneh read the Women's History Month proclamation.

**Resolution R-3-24** - CM Fry introduced a resolution to establish an interim environment task force and explained how it came about.

CM Dalaker – Looking forward to mediation to improve communications with the town and the Green Infrastructure Committee.

CM Bryner – Wants the guidelines that apply to the advisory boards to be completed to avoid future grey areas.

CM Watson – Does not agree that it is currently the proper time to create an interim environmental task force. Requests waiting 2 months until mediation has been completed.

CM Wade – Would like to continue with mediation and is not in favor of creating an interim environmental task force.

Mayor Munyeneh – Explained the delays on why mediation has not begun. Expressed that there is a need for an interim task force because mediation may not be completed by the time the town needs advice from a green committee.

Motion to table the discussion of Resolution R-3-24 to the April work session, if still needed, was made by CM Watson and seconded by CM Dalaker. It was approved unanimously.

**Resolution R-2-24** – CM Bryner introduced Resolution R-2-24 urging state and federal elected officials to call for a permanent ceasefire in Gaza.

CM Dalaker asked that the following language be included in: "of all faiths, beliefs, races, ethnicities and nationalities".

Motion to approve Resolution R-2-24 as amended to include "of all faiths, beliefs, races ethnicities and nationalities" made by CM Bryner. CM Garces. CM Wade voted yes, CM



Watson abstained, CM Bryner voted yes, CM Dalaker voted yes, CM Garces voted yes. CM Fry has recused herself from voting.

**CAR-01-24 Redistricting** – Mayor Munyeneh read the fair summary of the charter amendment regarding redistricting. -

OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND § 4-304 OF THE
ANNOTATED CODE OF MARYLAND (1957 EDITION, AS AMENDED), TO MODIFY
TOWN BOUNDARIES PURSUANT TO THE MOST RECENT CENSUS DATA.

**Hospital Hill** – Town Administrator provided an update on the potential timeline for a traffic study on behalf of the town for the development.

Motion to authorize the Town Administrator to execute actions from the budget amendment request from today that exceed the current procurement amount made by CM Bryner. 2<sup>nd</sup> by CM Garces. Approved Unanimously.

• Air Monitoring Project with University of Maryland School of Public Health:



Researchers from the Center for Community Engagement, Environmental Justice, and Health (CEEJH) at the University of Maryland School of Public Health are conducting a health impact analysis on particulate matter (PM) and black carbon levels near residential areas in the Route 50-Sheriff Road-Kenilworth Ave Quadrant. The Town will send a News and Announcements out with the information.

- The Hospital Hill Survey results will be available to the town within 24 hours. After reviewing the results with our consultant, a public meeting will be coordinated with the Mayor and Council for review and discussion.
- MDE Meeting on Air Pollution and Noise Concerns: Meeting scheduled for April 23rd to address concerns regarding air pollution and noise.

- Police Fleet Status Four vehicles are undergoing upfitting
- Automated Enforcement The S/B E/B portable speed cameras on Landover Road went live on February 19th after the prescribed warning period.

**Feral Cats** —Representatives from A Cat's Life Rescue group provide information about their group.

Currently working to become established as a Cheverly Community Organization



- Recently approached by community members including Cheverly Cats, and Douglas
   Alexander about the growing feral cat problem in Cheverly
- Known large colonies in Wards 1, 2, and 6-but likely in other wards as well
- Pilot Project Goal of Trapping, Neutering, Releasing (TNR) 65 cats in Cheverly, MD
- Larger Goal of 100 cats by the end of the calendar year 2024

**Revisiting Homestead Tax credit** – Mayor & Council discussed the homestead tax credit.

- Currently 127 properties in Cheverly receive the state homestead tax credit.
- Provide education about the current Cheverly offered tax credit
- Maximum should be \$20,000

- House Bill 1001 Motor Vehicles Automated Enforcement Programs Privacy Protections Requiring a custodian of recorded images produced by certain automated enforcement systems to deny inspection of the images; prohibiting certain State and local agencies from using a recorded image or associated data from an automated enforcement system without a warrant, subpoena, or court order unless the use is for an appropriate traffic enforcement purpose; providing that an employee who violates the Act is subject to a fine of up to \$1,000; and establishing certain requirements and authorizations for the removal of recorded images. The loss of this data will be detrimental to law enforcement in investigations.

# CHARTER AMENDMENT RESOLUTION CAR-01-24 OF THE MAYOR AND COUNCIL OF THE TOWN OF CHEVERLY, MARYLAND AMENDING § C-6(A) OF THE CHARTER ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND § 4-304 OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION, AS AMENDED), TO MODIFY TOWN BOUNDARIES PURSUANT TO THE MOST RECENT CENSUS DATA.

WHEREAS, the Town of Cheverly has Six (6) Wards; and

**WHEREAS**, the 2020 Census data reported changes in the Town's population requiring modifications to the boundaries of the Town's wards to make certain they comply with all applicable laws; and

**WHEREAS**, the Town retained a subject-matter expert consultant to provide options to the Mayor and Council for modifying the wards based on the 2020 Census data, and to ensure compliance with all applicable laws; and

**WHEREAS**, the Mayor and Council hereby amends the Town Charter to modify the boundaries of the six wards based on the expert analysis provided; and

**WHEREAS**, after at least twenty-one (21) days advance notice, a public hearing has been held on the proposed amendment to § C-6(A) of the Charter as required by §4-304(a)(2) of the Local Government Article of the Annotated Code of Maryland before this Charter Amendment Resolution is considered for adoption;

**NOW, THEREFORE, BE IT RESOLVED,** by the Mayor and Town Council of the Town of Cheverly, Maryland, in regular session assembled:

Section 1: That § C-6(A) of the Charter of the Town of Cheverly, Maryland, be repealed and reenacted as follows:

#### § C-6. - Boundaries, election order and councilmembers holding over.

(A) The Town of Cheverly shall be divided into six (6) wards, which shall, respectively, comprise the territory contained within the boundaries of the town, the lot lines hereinafter set forth, and the center line of the streets named as follows:

First Ward: All that area lying north and west of a line beginning at the northern boundary and Cheverly Avenue and running south along Cheverly Avenue until the point where Forest Road crosses Cheverly Avenue and, then west southwest along Forest Road to Greenleaf Road and then running northwest along Greenleaf Road to Tremont Avenue, then north on Tremont Avenue to Inwood Street, then west on Inwood Street in a straight line until the line ends at the western boundary. Section 3: BE IT FURTHER RESOLVED that the date of the adoption of this Resolution is , and that the amendment to the Charter of the Town of Cheverly hereby proposed by this enactment, shall be and become effective on \_\_\_\_\_ [50 days], unless a proper petition for a referendum hereon shall be filed by [40 days], and a fair summary of the Amendment shall be posted at Town Hall for forty days following its adoption and published in a newspaper having general circulation in the Town not less than four (4) times at weekly intervals by [40 days]. Section 4: BE IT FURTHER RESOLVED that as soon as the Charter Amendment hereby enacted becomes effective, either as herein provided or following a referendum, the Clerk shall send separately to the Department of Legislative Services, the following information concerning the Charter Amendment: (1) the complete text of this Resolution; (2) the date of referendum election, if any, held with respect thereto; (3) the number of votes cast for and against this Resolution by the Mayor and Council of the Town of Cheverly or in a referendum; and (4) the effective date of the Charter Amendment. Section 5: **BE IT FURTHER RESOLVED** that the Clerk be, and he/she is specifically enjoined and instructed to carry out the provisions of Sections 3 and 4, and as evidence of compliance herewith the said Clerk shall cause to be affixed to the Minutes of this meeting (1) an appropriate certificate of publication of the newspaper in which the fair summary of the Amendment shall have been published; and (2) records of mailing referred to in Section 3, and shall further complete and execute a Certificate of Compliance.
