At its meeting of February 28, 2023, the Governor's Consulting Committee on the National Register (GCC) reviewed the Cheverly National Register nomination and tabled it, requesting the nomination be modified with terminology changes, clarifications and additional research and context. Specifically, the GCC directed that the period of significance should be revised to not include Mount Hope (already individually listed on the National Register), but not so late that any dwellings in the Fourth Ward are excluded. In addition, they directed that the nomination fully address the role of covenants and how African American residents were able to break or otherwise get around them. The GCC suggested adding Social History-Civil Rights as an area of significance under Criterion A, and to include a comparison of Cheverly to similar developments in Prince George's and Montgomery Counties.

Next Steps: The consultant will revise the nomination to conform with the GCC's direction and resubmit to M-NCPPPC and the Maryland Historical Trust staff by July 1, 2023, with the intent of presenting the revised application at the October 2023 GCC meeting (we don't have an exact date yet for this meeting).

RESOLUTION R-5-23

RESOLUTION OF THE TOWN COUNCIL OF CHEVERLY, MARYLAND IN CELEBRATION AND RECOGNITION OF ASIAN AMERICAN NATIVE HAWAIIAN PACIFIC ISLANDER HERITAGE MONTH (AANHPI) MAY 2023

WHEREAS: On October 5, 1978, President Jimmy Carter signed into law Public Law 95-419 directing 7 days, starting on May 4, 1979 were to be called "Asian/Pacific American Heritage Week"; and

WHEREAS: In 1990, Congress passed Public Law 101-283 which expanded the observance to a month for 1990; and

WHEREAS: In 1992, Congress passed Public Law 102-450 which designed May as Asian/Pacific American Heritage Month annually; and

WHEREAS, the month of May is celebrated nationwide as Asian/Pacific American Heritage Month to recognize the contributions and influence of Asian Americans, Native Hawaiians, Desi-Americans, & Pacific Islanders here in the United States; and

WHEREAS, the month of May was chosen to commemorate the immigration of the first Japanese to the United States on May 7, 1843, and to mark the anniversary of the completion of the transcontinental railroad on May 10, 1869, which was only completed due to the blood, sweat, and tears of the Chinese immigrants who laid the tracks; and

WHEREAS, the Town of Cheverly's population self-reported an estimated 5.1% as "Asian" in the 2019 Census Data; and

WHEREAS, the Town of Cheverly has had its first Asian-American Town council member as of 2019; and

WHEREAS, the Town of Cheverly has had its first Korean-American Vice Mayor as of 2020; and

WHEREAS, the Town of Cheverly has had its first Korean-American Cheverly Police Department Officer as of 2020; and

WHEREAS, since 2016 until this new administration, hateful rhetoric and damaging stereotypes were perpetuated by national leadership and specifically related to COVID-19, the use of anti-Asian terminology and rhetoric, such as the "Chinese Virus", "Wuhan Virus", and "Kung-flu" have perpetuated anti-Asian stigma and resulted in AAPI being harassed, assaulted, and scapegoated for the Covid-19 Pandemic; and

WHEREAS: there has been an increase in hate crimes targeting Asian Americans, as seen with the Atlanta Spa Mass Murders, the Fed-Ex Mass murder in Indianapolis, the violent attacks on our elders, several resulting in death, attacks on businesses nationwide, including in Maryland; and

WHEREAS, acts of hate and discrimination are antithetical to our values as residents of Cheverly and Americans. As leaders, it is our duty to promote respect, inclusion, and a welcoming community for people of all races, national origins, and ethnicities in our community and beyond; and

WHEREAS, the Town of Cheverly is committed to celebrate the diversity, progress, and achievements of the AAPI community not just in the Month of May but every day, and is committed to inclusion and advancing equity and justice for the AAPI Community and people of all races, national origins, and ethnicities; and

WHEREAS, addressing anti-Asian sentiment requires collaboration with Black, Indigenous, Latino/a, and other marginalized communities to find long-term solutions to stop systemic racism, xenophobia, and violence in all our communities; and

WHEREAS, all residents of Cheverly can play a role in establishing a safe and welcoming community by intervening and reporting instances of hate and discrimination. Reporting these incidents is critical to holding perpetrators accountable and fully addressing the issue; and

NOW, THEREFORE, be it Resolved, that the Cheverly Mayor & Town Council recognizes and acknowledges the contributions, achievements, and influence of the AANHPI community in celebration of Asian American Native Hawaiian & Pacific Islander Heritage Month and celebrates the AANHPI Community every day; and be it further

Resolved, that the Cheverly Mayor & Town Council condemns hate crimes, hateful rhetoric, and hateful acts against Asian Americans and we condemn all manifestations of expressions of racism, xenophobia, discrimination, bias sentiment, scapegoating, and ethnic or religious intolerance against anyone; and be it further

Resolved, that we encourage all residents of Cheverly who experience hate crimes or experience discrimination to report such incidents to Cheverly Police Department or other proper authorities; and be it further

Resolved, that we encourage all Cheverly residents to stand together to denounce racism and hatred of any kind and to let the world know that it will not be tolerated in Cheverly.

TOWN OF CHEVERLY ORDINANCE 2023-03 BUDGET ORDINANCE FOR THE 2024 FISCAL YEAR

An Ordinance whereby the Town of Cheverly adopts a Budget for Fiscal Year 2024 which begins on July 1, 2023, and ends on June 30, 2024.

(Uncodified)

WHEREAS, Article VII, Section C-23A(2) of the Charter of the Town of Cheverly grants to the Mayor and Council the power to appropriate and expend funds for any purpose deemed to be public; and

WHEREAS, each fiscal year of the Town commences on July 1 and ends by the following June 30, pursuant to Section C-32 of the Charter of the Town; and

WHEREAS, the Mayor and Town Council have, prior to each fiscal year, adopted a budget to govern the appropriation and expenditure of funds for the next fiscal year; and

WHEREAS, after numerous discussions and meetings, the Mayor and Town Council have prepared a budget for fiscal year 2024 containing anticipated revenues and proposed appropriations and expenditures for said fiscal year; and

WHEREAS, said budget, as discussed at numerous public meetings by the Mayor and Council, is attached hereto as Exhibit A;

NOW, **THEREFORE**, **BE IT RESOLVED**, by the Mayor and Council of Cheverly in regular session assembled that the budget for fiscal year 2024 containing anticipated revenues and proposed expenditures of the Town, which budget is attached hereto as Exhibit A, and is hereby incorporated by reference, be and hereby is adopted for the fiscal year 2024 to take effect July 1, 2023, until June 30, 2024.

AND BE IT FURTHER RESOLVED, that this budget shall govern the expenditure of funds by the Town during the fiscal year 2024;

AND BE IT FURTHER RESOLVED, that the Mayor and Town Council may, from time to time, during the fiscal year amend this budget by motions made, discussed and carried so long as any action regarding this budget is taken at a public meeting after notice and a public discussion and the amendments to the budget for entire fiscal year do not increase the total expenditures by



more than ten percent (10%) of the total expenditures figure appearing on attached Exhibit A;

AND BE IT FURTHER RESOLVED, that this Ordinance shall take effect on July 1, 2023; however, provided that a fair summary of the ordinance is published at least once in a newspaper of general circulation in the Town of Cheverly.

TOWN OF CHEVERLY ORDINANCE No.: 2023-01

AN ORDINANCE OF THE MAYOR AND COUNCIL AMENDING CHAPTER 27 "VEHICLES AND TRAFFIC" OF THE TOWN CODE BY REPEALING, REENACTING AND AMENDING §27-2, "SPEED LIMITS AND SPEED MONITORING" TO AUTHORIZE THE PLACEMENT OF SPEED CAMERAS IN THE TOWN ON HIGHWAYS IN RESIDENTIAL DISTRICTS WITH A MAXIMUM POSTED SPEED LIMIT OF 35 MILES PER HOUR

WHEREAS, pursuant to The Local Government Article of the Maryland Annotated Code, §5-202 grants to municipal corporations of the State of Maryland, including the Town of Cheverly, the power to protect the health, comfort and convenience of their citizens; and

WHEREAS, the Mayor and Town Council has previously passed an ordinance pursuant to §21-809 of the Transportation Article to enable automated speed monitoring systems; and

WHEREAS, §21-809 was amended by the General Assembly to authorize municipalities in Prince George's County to place speed cameras on highways in residential districts with a maximum posted speed limit of 35 miles per hour; and

WHEREAS, the Mayor and Town Council have determined this expanded authority will promote the health, safety and welfare of its citizens.

NOW, THEREFORE, BE IT ORDAINED and ENACTED by the Mayor and Town Council, in regular session assembled, that Section 27-2 of the Cheverly Code be repealed and reenacted with amendments as follows:

Sec. 27-2. - Speed limits and speed monitoring devices.

a) Speed limits. No person shall drive a vehicle upon a highway, street or roadway within the corporate limits of the Town of Cheverly at a greater speed than is reasonable and prudent, having due regard to the traffic surface and width of the highway, and hazards at intersections and any other condition then existing. The speed of any vehicle on any highway, street or roadway shall not exceed twenty (20) miles per hour, except as may otherwise be indicated by official signs of the Maryland State Motor Vehicle Administration or the Town of Cheverly for the particular district, location or conditions.

- b) Speed monitoring systems.
 - A "speed monitoring system," as defined in Maryland law, means a device with one
 or more motor vehicle sensors producing recorded images of motor vehicles traveling at least twelve (12) miles per hour above the posted speed limit.
 - 2. []Speed monitoring systems are hereby authorized at locations, determined by the Chief of Police or his/her designee, in school zones OR ON HIGHWAYS IN RESIDENTIAL DISTRICTS WITH A MAXIMUM POSTED SPEED LIMIT OF 35 MILES PER HOUR within the Town, as established under §§ 21-803.1 AND 21-809(b)(1)(vi) of the Transportation Article of the Annotated Code of Maryland. IN MONTGOMERY COUNTY OR PRINCE GEORGE'S COUNTY, ON A HIGHWAY IN A RESIDENTIAL DISTRICT, AS DEFINED IN § 21–101 OF THE TRANSPORTATION ARTICLE OF THE ANNOTATED CODE OF MARYLAND, WITH A MAXIMUM POSTED SPEED LIMIT OF 35 MILES PER HOUR, WHICH SPEED LIMIT WAS ESTABLISHED USING GENERALLY ACCEPTED TRAFFIC ENGINEERING PRACTICES.
 - 3. Before activating any school OR RESIDENTIAL zone speed monitoring system(s) AT ANY LOCATION WHERE SUCH A SYSTEM HAD NOT BEEN PREVIOUSLY MOVED OR PLACED, the Town shall:
 - a. Publish notice of the location(s) of the speed monitoring system(s) on the Town website and in a newspaper of general circulation within the Town;
 and
 - b. Ensure that each sign that designates a school zone or RESIDENTIAL ZONE has in close proximity to it a sign that indicates that speed monitoring systems are in use in THE school zones or RESIDENTIAL ZONE and that the signage is in accordance with the manual and the specifications for a uniform system of traffic control devices adopted by the State Highway Administration.
 - 4. A speed monitoring system may operate IN A SCHOOL ZONE Monday through Friday between 6:00 a.m. and 8:00 p.m., OR ON A HIGHWAY IN A RESIDENTIAL DISTRICT WITH A MAXIMUM POSTED SPEED LIMIT OF 35 MILES PER HOUR MAY BE OPERATED 24 HOURS PER DAY, SEVEN DAYS PER WEEK.
 - 5. For a period of at least fifteen (15) days after the any speed monitoring system is placed in the Town AND THE SIGNAGE AS REQUIRED BY §21-809 of the

Transportation Articles are in place, a violation recorded by any speed monitoring system in the Town shall be enforced only by the issuance of a warning.

- 6. The speed monitoring system in the Town shall be conducted in compliance with all applicable provisions of the Maryland Vehicle Law.
- 7. The areas in Town of Cheverly within one-half (1/2) mile of the schools listed below shall be school zones:

Gladys Noon Spellman Elementary, 3324 64th Avenue;

Judith P. Hoyer Early Learning Center, 2300 Bellview Avenue;

St. Ambrose School, 6310 Jason Street;

Bladensburg High School, 4200 57th Avenue, Bladensburg, Maryland;

Fairmount Heights High School, 1410 Nye Street, Capitol Heights, Maryland.

8. The town shall name an employee as a program administrator to oversee the contract with the speed monitoring system contractor and shall also name another town employee who has not been involved in monitoring system citations, to investigate and respond to questions or concerns about the town's speed monitoring systems as outlined in §-809(b)(1)(ix)of the Transportation Article.

AND BE IT FURTHER ORDAINED that if any provision of this Ordinance or the application thereof to any person or circumstance is held invalid for any reason, such invalidity shall not affect the other provisions or any other applications of the Ordinance which can be given effect without the invalid provision or applications, and to this end, all the provisions of this Ordinance are hereby declared to be severable.

AND BE IT FURTHER ORDAINED that this Ordinance shall take effect thirty (30) days from the date of its adoption; provided, however that a fair summary of the Ordinance is published at least once in a newspaper of general circulation in the Town of Cheverly.







a Municipal Corporation organized under the laws of the State of Maryland, Grantor, and the WASHINGTON SUBURBAN SANITARY COMMISSION, a bi-county agency and public corporation of the State of Maryland, organized and existing under the laws of the said State, Grantee.

Witnesseth: That in consideration of the sum of One Dollar (\$1.00) to it in hand paid by the Grantee, the receipt of which is hereby acknowledged, the said Grantor does hereby grant and convey unto the said Grantee, its successors and assigns, an exclusive easement and right of way hereinafter described for the installation, construction, reconstruction, maintenance, repair, operation, and inspection of a water main, sanitary sewer and appurtenances thereto, including service connections within said easement and right of way, together with the right of ingress and egress along and over said right of way, for any and all of such purposes thereto; the said right of way and easement being fully described as follows:

SEE ATTACHED SCHEDULES: "A" and "B"

To have and to hold said easement and right of way, to the exclusion of all others, for a water main, sanitary sewer and appurtenances thereto, including service connections above described or mentioned and hereby intended to be granted and conveyed, together with the rights, privileges, appurtenances and advantages thereto belonging or appertaining unto and to the only proper use, benefit and behoof forever of the said Washington Suburban Sanitary Commission (Commission), its successor and assigns.

And the Grantor, for itself, its successors and assigns, covenants and agrees with the Grantee, its successors and assigns, as follows:

FIRST: that it will obtain the written consent of the Grantee before it grants an easement or right of way within the above described easement and right of way, erects, places or permits to be erected or placed any building, structure (including but not limited to fencing and pavement), underground cables and channels, or landscaping (not including a lawn), or before it fills or excavates within the above described easement and right of way (hereinafter collectively referred to as "encroachments"). The repair and maintenance of any encroachments consented to by the Grantee and installed by Grantor shall be the sole responsibility of Grantor and Grantee shall have no responsibility for them. Grantor shall bear the sole cost of removing any encroachments that are constructed, located or installed within the easement and right of way without the consent of Grantee or which are constructed in a location not approved by Grantee or moved from the location approved by Grantee in its consent. In the event Grantor fails to remove any encroachment to which Grantee has not consented within a reasonable time after notice from Grantee, Grantee shall have the right, but no obligation, to remove such encroachment at the sole cost of Grantor. In such event, Grantee shall not be liable for damage caused to any such encroachment and shall have no obligation to restore such encroachment to its original or any other location within the easement and right of way or otherwise.

SECOND: that the Grantee, its successors and assigns, shall at all times have right of ingress and egress without prior notification over said easement and right of way for the purpose of installing, constructing, reconstructing, maintaining, repairing, operating and inspecting the water and sewer lines and appurtenances thereto, including service connections within said easement and right of way, said ingress and egress to be along the line herein designated and along such other lines as the Grantor may designate. And that Grantee shall have the right to cut or remove shrubs, trees, fencing, fill, encroachments or any impediment whatsoever located within the easement and right of way, whether installed or constructed with or without Grantee's consent, in order to install, construct, reconstruct, maintain, repair, operate or inspect its pipes and appurtenances.

THIRD: that this easement and right of way shall have priority over any subsequently recorded easements or rights of way, including but not limited to public utility easements or easements granted to private companies or persons, and, by accepting the grant of such a subordinate easement, any such public utility or private company or person agrees to indemnify and hold harmless Grantee, its employees, agents and contractors, and Grantor, from any and all claims, demands, suits, losses, liabilities, damages or payments, including

reasonable attorney's fees, arising out of the repair, maintenance, inspection, or reconstruction of Grantee's water and sewer lines and appurtenances thereto, including service connections, by any such utility company, private company or person, or by the presence of encroachments within the easement and right of way pursuant to such subordinate easement.

FOURTH: Grantor agrees to execute any permit application that may be required by a local, federal or State unit for work Grantee must accomplish in the easement and right of way.

FIFTH: Grantor agrees to defend, indemnify, and hold harmless the Grantee, its employees, agents and contractors from any and all claims, demands, suits, losses, liabilities, damages or payments, including reasonable attorney's fees, arising out of the repair, maintenance, inspection, or reconstruction of Grantee's water and sewer lines and appurtenances thereto, including service connections, within the easement and right of way, caused by any damage to the water and sewer lines and appurtenances thereto, including service connections, caused by Grantor, by any person or entity directly engaged by Grantor to act on Grantor's behalf, or by the presence of encroachments constructed or installed by Grantor within the easement and right of way without Grantee's prior written consent as provided in the first paragraph above.
