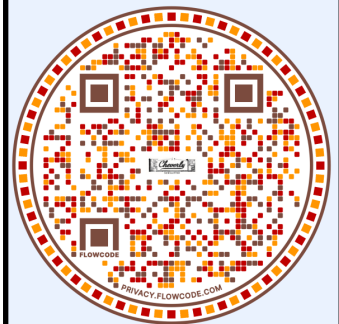

### **RESIDENTIAL BUSINESS LICENSES**

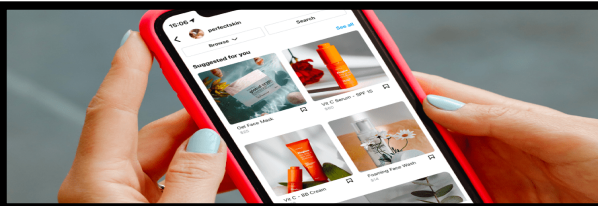
If you are currently operating a business out of your home, you are required to obtain a Town Residential Business License.

Home occupations are under (Chapter 9 of Town Code) and (subtitle 27 of the Prince George’s County Code) and do not include any retail business or trade, etc.

Town Residential Business Licenses are issued annually for the Fiscal Year (July 1 to June 30). Please call the Town Clerk at 301-773-8360 or stop by the Town Office to pick up an application form.

*The yearly business license fee is \$20.*



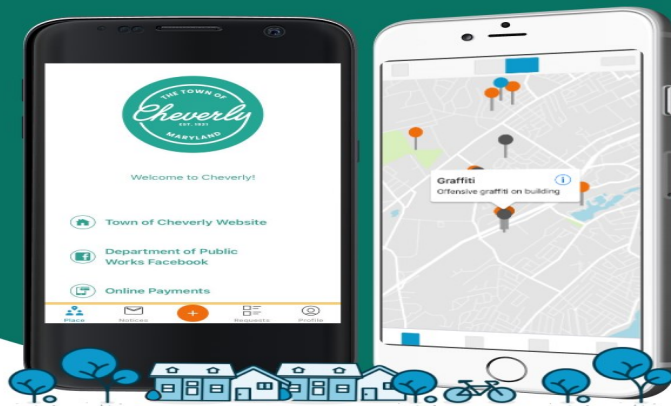

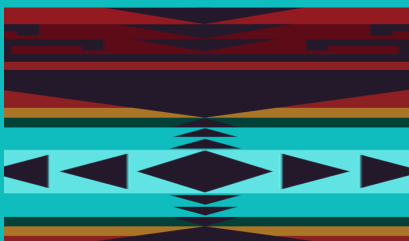

## CODE COMPLIANCE

### PARKING COMPLIANCE



According to Code Sec. 18-4.2 and Sec. 27.5

Vehicles that have not moved for 72+ hours may be towed; all vehicles need to be operational & legally operable on both private property and on the street.

Commercial vehicles are prohibited to park in front of residential properties.

### NOISE ORDINANCE

During summer months, residents are asked to be especially considerate of their neighbors' rights to peace and quiet.

During the day (8:00 am to 9:00pm) 'continuous' noise that can be heard from 30' away, and 'intermittent' noise or 'impulsive' noise that can be heard from 50' away is generally prohibited.

Continuous Noise is defined by law as noise that does not vary for at least five minutes; Intermittent Noise is noise that changes over time, but which can be heard

for more than ten seconds at any one time; and Impulsive Noise is short bursts of sound.

During the night (9:00pm to 8:00am), any noise that can be heard from 30' away from the property from which the noise is coming is prohibited.

It is also unlawful to allow a house or vehicle alarm to sound, continuously or at intervals, for 30 minutes or more. For purposes of enforcement after the 30-minute period, the owner of the house or vehicle is presumed to be aware of the sounding alarm.

Exceptions for the rule: Construction, repair or demolition of structures or public roads is allowed during the daytime, except on Sundays and Christmas Day, and during nighttime emergencies.

Daytime use of lawnmowers and other power tools is allowed; church bells, and vehicles used by public safety, government, and public utility officials are exempt from the law.

Residents may register complaints about noise by calling the county police response number, 301-333-4000. In most cases, a Cheverly police officer will be dispatched to the scene.

# CODE COMPLIANCE

## SOLID ANIMAL WASTE ORDINANCE



**Sec. 4-10 (a)** It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, & play areas of all other parks.

## VACATIONS & HOME SECURITY

Residents planning to be away for vacations should visit <https://www.cheverly-md.gov/cheverly-police-department/webforms/house-check-request> to arrange to have their homes checked while they are gone.

The following items should also be checked to make sure your residence is safe and looks as much as possible like someone is there:

- Cancel newspaper & mail delivery or have a neighbor pick it up for you.
- Arrange for lawn care.
- Store valuables, preferably in a bank.
- Store lawn mowers, bicycles, and lawn furniture inside.
- Set lights inside the house on a timer.
- Set telephone bells as low as possible.
- Draw shades and drapes.
- Lock cars left in the driveway.
- Make sure smoke detectors are working.
- Lock all windows and doors.
- Give your house key & itinerary to at least one friend or neighbor.

## PLEASE USE THE SIDEWALKS

As the weather begins to get nicer and more and more residents are walking or jogging in town, we are taking this opportunity to remind you that it is illegal to walk or jog in the street when a sidewalk is available on a road. The State law reads: 21-506

Rules for pedestrians on roadways

- (a) **Where a sidewalk is provided, a pedestrian may not walk along and or an adjacent roadway.**
- (b) **Where a sidewalk is provided, a pedestrian who walks along and on a highway may walk only on the left shoulder, if practicable, or on the left side of the roadway, as near as practicable to the edge of the roadway, facing any traffic that might approach from the opposite direction.**

We want all our pedestrians and motorists to be safe. So, please use the sidewalks. Not adhering to the above noted law may result in a fine being issued.

## OUTDOOR BURNING REMINDER:

**Sec. 12-3.**

- (a) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material on any improved street, gutter, parking strip, parkway, park, alley or any other town property within the corporate limits of the Town of Cheverly.
- (b) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material within the corporate limits of the Town of Cheverly, without first obtaining a permit from the Town of Cheverly, excluding outdoor cooking devices.

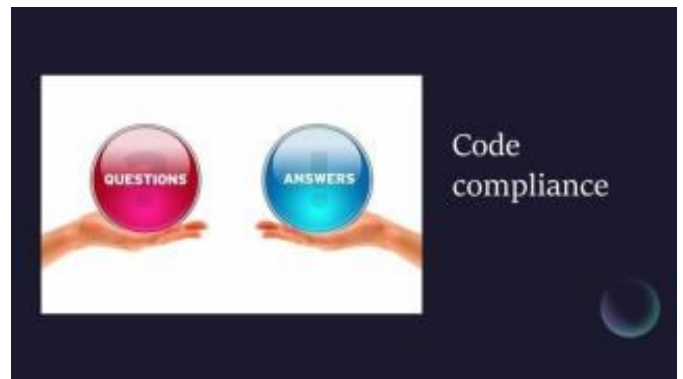

## RESIDENTIAL ZONE PARKING



Residential ZONE parking permits are now available. The price of the permit is \$5 per vehicle with 1 free guest pass per address. A second guest pass may be obtained for \$2. (Only two guest passes per address.)

Applications can be downloaded from the Town website at [www.cheverly-md.gov](http://www.cheverly-md.gov) under the Form and File tab.

Please drop completed applications in the Permits Box located at Town Hall or mail to: Code Enforcement, 6401 Forest Road, Cheverly, MD 20785.



### Cheverly Residential Zone Parking Permit Application

**Applications can be submitted at Town Hall, online, via US Mail, or placed in the permit box located on the left-side wall of the main entrance at Townhall**

- Permits can only be issued to vehicles registered to a Cheverly address
- A copy of your vehicle registration must accompany the application
- Cost of the Permit is \$5 per vehicle | 1 guest parking pass is allowed **per address** at no cost
- An additional Guest Parking Pass is available for \$2 (no more than 2 guest parking passes per address)

If you live in one of the following areas, you will need a Parking Permit: Please check the zone that applies.

- Zone 1: State St, 61st & 62nd Ave, as well as the 1800 block of 64th Ave
- Zone 3: 22-2400 block of Cheverly Avenue
- Zone 4: Arbor Street & Crestlawn Avenue (22-2300 block Parkway Eliminated)
- Zone 5: 2300 block of Belleview Avenue
- Zone 6: Benton Rd & 23-25 Lake Avenue
- Zone 7: 2400 block of Valley Way
- Zone 8: 3300 Belleview Avenue; Medical Terrace (Eliminated)
- RO: 6500 & 6600 blocks Oak Street, 6500 block Maureen Court, 3132 & 3200 block Hillside Avenue
- SR: This permit allows senior citizens 65 years of age and older to park on the odd side of the 2200 block of Cheverly Avenue in order to utilize the METRO



- Residential Parking Permits are to be displayed on the back Left Bumper area.
- If you have a regular and a SR permit, display them next to each other on the Back Left Bumper.
- Guest Parking Permits shall be hung on the REARVIEW mirror with information facing outward.
- Citation may be Issued to ANY Vehicle not in compliance with Town Code 27-5.1 Residential Zone Parking
- If you have any questions, please contact the Office of Code Compliance at 240-770-7647

To apply for a Residential Zone Parking Permit by mail, please provide the following information **AND a copy of your \*vehicle's registration**. Return this form to Residential Parking at the Town of Cheverly with the payment.

\*If you have obtained a Non-Resident Permit from MVA, you MUST send a copy of that permit along with your request.

### Electronics Pick-up

Electronic equipment will no longer be picked up with recycling on Wednesday's. They will be picked up with bulk trash on designated east or west side pick-up schedule on Thursday or Friday.

This includes flat screen TVs' (older model televisions that are not flat screens should be set out for bulk trash), computers, printers, etc.

*If you would like to dispose of an old and/or damaged recycling bin or trash can, please call Public Works (301-773-2666) to schedule a pickup. Make sure that it is all plastic with no metal parts and that it is clearly labeled with a sign saying "Dispose of Bin or Can." Then put it at the curb for pickup.*

## New Tree Evaluation Program

The Town recently rolled out a private tree inspection program. Residents may request one tree inspection per year by the Town's Arborist, Dr. Tolbert Feather. We are limiting inspections to one per address as we formally roll out this program to help ensure every address has an equal opportunity. There are 100 inspections in the budget, so limiting each address to one inspection will help cover the Town.

In order to request this service, a resident must fill out the form on the webpage and attach a check for \$85 made out to *Town of Cheverly*. And then mail to or drop off at Town Hall Attn: Public Works. Each inspection costs \$85, and the resident will receive a report on their tree. Once the form is approved, the inspection will be scheduled.

Checks won't be deposited until after the inspection report is completed.



## TRASH COLLECTION REMINDER

**Sec. 10-7** Except for household trash, which the town may collect from side or rear yards, all collectible trash shall be placed at the street side or curb, but shall not be placed there earlier than 7:00 p.m. on the day before it is scheduled to be collected. All containers or uncollected trash and waste must be removed from the street side or curb by 7:00 p.m. of the day it was scheduled for collection. Upon request of a resident to the town administrator and for good cause shown, the town may collect recyclables from a side or rear yard of the property.



## CONTAINERS NOT TO EXCEED THIRTY-TWO (32) GALLON CAPACITY.

**Just a reminder**, and as stated on the Town's website, **"Containers not to exceed thirty-two (32) gallon capacity."**

**Public Works will not pick up nor empty trash containers larger than 32-gallons.** This is for the safety of our Public Works employees who manually lift each and every trash can.

*\*In the interim, until you purchase a 32-gallon trash can with a tight-fitting lid, please remove all trash bags from cans larger than 32-gallons and place them on the curb prior to trash collection.*

## **GREEN @ HOME -- GROW, DON'T MOW**

Are you tired of mowing, watering, and even fertilizing in pursuit of a manicured lawn?

Environmental experts have been encouraging us to reduce the percentage of our yards to avoid water and air pollution and increase the biological diversity that benefits wildlife and ourselves. Some reasons to help create what entomologist Doug Tallamy calls the Homegrown National Park are:

- Save time and money that you would normally spend on mowing and fertilizing grass. Native plants require much less maintenance than turf grass.
- Areas of lawn that include only one type of plant, such as turf grass, offer little habitat value for wildlife. A variety of native plants can provide wildlife with food, cover and places to raise their young.
- Conserve water. Native plants, once established, require much less water than turf grass.
- Reduce lawn mower air pollution.
- Decrease run-off of lawn fertilizers and pesticides into local watersheds.
- Once established, native plants do not require fertilizers or pesticides

The University of Maryland extension service suggests many alternatives to lawns: native groundcovers, native grasses, natives shrubs and flowers, trees, meadows, moss, no-mow areas, even edible landscaping.

The Cheverly Green Infrastructure Plan calls for reduction of the percentage of manicured turf area, the

use of native vegetation and elimination of invasive plant species.

As with many other municipalities, Cheverly's nuisance ordinance does not encourage alternatives to lawns. However, more and more municipalities are changing their ordinances to permit and encourage such alternatives.

The Cheverly Green Infrastructure Committee has worked with code compliance officer CJ Reading to draft new nuisance code language that will permit and encourage Cheverly residents to employ lawn alternatives, give some basic guidance on native planting and removal of invasive plants, and simplify the tasks of Code Compliance.

The Cheverly Green Infrastructure Committee has encouraged the Mayor and Town Council to consider replacing the current code language with this more up-to-date code section.

## CHEVERLY NATIVE PLANTING PROJECT

As the leaves have started to change color, Cheverly just got a lot greener! With the help of the Cheverly Native Planting Project, a total of 190 native shrubs have been planted throughout town this fall. This is the culmination of our 2nd annual 2-for-1 Trade. In exchange for removing one invasive shrub, CNPP gives two native replacements for free.

In addition to the 70 shrubs we gave to 35 homes, this year we also gave five local institutions 28 shrubs! A bonus of signing up for our trade is that we are able to help participants and members order additional native shrubs at near-wholesale prices. A whopping 92 additional shrubs were purchased this fall! CNPP's work is making it more affordable to improve the ecological health of our yards.

We hold our 2-for-1 Trade in the fall because it is the best time to plant shrubs and trees. Getting them in the ground now lets them focus their energy toward establishing their roots instead of working on their above ground show. The fall's cooler temperatures are less stressful than the summer's heat which quickly

follows spring planting. And, the plants require less watering to get going at this time of year. Planting now also gives your plants a head start with an extra growing season.

Trim perennial stems about 12 inches from the ground.
