Message from the Mayor

Here we go, 2023!

We have started the year with the historic inauguration of Wes Moore and with several friends of Cheverly being elected and promoted to key positions. Congratulations all around! I know I am excited about all the blessings that hardworking elected officials near and in Cheverly have enjoyed. And now we get to work!

The town will be sending priorities for Cheverly to state and local officials. We will be advocating for more infrastructure dollars, general resources, and more involvement from external stakeholders like the State Highway Association. It has been years since the town has requested and/or received significant resources from the State of Maryland. Hopefully this year is our year to get everything we ask for! So, what are some of those things?

Remember how much I love sidewalks? We have some newly installed sidewalks on 59th and Monroe that were free, thanks to the Community Development Block Grants. We could certainly use more. I've heard requests for sidewalks on Dewey and of course off 202/Landover Road. Be sure to shoot us an email of other locations where a sidewalk would improve walkability. Sidewalks have already been included in the strategic plan and budget, but having your opinion only helps to confirm the areas.

In our first town session, we nominated election judges and clerks. We are always grateful for the support of the staff and these selections begin to gear us up for election season. If you are like me, you might be a little "elected out". We have had a few special races and unfortunately, we have had elections every year for the last three years at least. While it may feel exhausting to stay plugged in, the most important elections you will vote in are for local politics. Issues around potholes, parks, and even illegal chickens are addressed at the local level. Make sure you pay attention and reach out to your Councilmember to find out about their plans to run again for their positions. I'm sure Councilmembers would appreciate volunteers and additional help as we get closer to May as well.

BOARD OF ELECTIONS

Cheverly Municipal Election **Monday, May 1, 2023** **7 am – 8 pm**

This year Cheverly will be holding elections for all six Town Council seats.

Information for Candidates

Candidates for Town Council must be:

- At least 21 years of age on or before election day
- A citizen of the United States
- A registered voter of Cheverly
- A resident of Cheverly for not less than 6 months preceding the election
- A resident of the ward from which they are elected

Forms to file for candidacy may be obtained from the Cheverly website at

www.cheverly-md.gov/board-elections or from the Town Hall. Candidate profiles may also be submitted as a Word document no longer than 350 words and may include a close-up photo cropped to 2"x2" as a JPEG file. Please submit all required materials as separate attachments to election@cheverly-md.gov.

Completed forms and candidate profiles must be submitted by 5:00 pm on Friday, March 17, 2023.

Information for Voters

To be eligible to vote in the Town election, you

must **register to vote** in one of two ways:

- Register to vote with the state of Maryland **before April 1, 2023**. Already registered? Make sure your registration reflects your current Cheverly address. Check here: voterservices.elections.maryland.gov/votersearch

OR

- Register to vote with the Town of Cheverly. This option is available to any resident who cannot register in Maryland (examples, non-US citizens or active military with active voter registrations in another state) and who meets the eligibility requirements. Registering to vote with the Town may be done at any time, including on election day.

Any registered voter in Cheverly may **request a ballot to be mailed to them** or to be picked up in-person at Town Hall if they choose not to vote in-person. Ballots may be returned by mail or in-person at a ballot drop box which will be installed in front of Town Hall for the 30 days prior to and including election day.

RESIDENTIAL BUSINESS LICENSES

If you are currently operating a business out of your home, you are required to obtain a Town Residential Business License.



Home occupations are under (Chapter 9 of Town Code) and (subtitle 27 of the Prince George’s County Code) and do not include any retail business or trade, etc.

Town Residential Business Licenses are issued annually for the Fiscal Year (July 1 to June 30). Please call the Town Clerk at 301-773-8360 or stop by the Town Office to pick up an application form.

The yearly business license fee is \$20.

CODE COMPLIANCE

SOLID ANIMAL WASTE ORDINANCE



Sec. 4-10 (a) It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, & play areas of all other parks.

VACATIONS & HOME SECURITY

Residents planning to be away for vacations should visit <https://www.cheverly-md.gov/cheverly-police-department/webforms/house-check-request> to arrange to have their homes checked while they are gone.

The following items should also be checked to make sure your residence is safe and looks as much as possible like someone is there:

- Cancel newspaper & mail delivery or have a neighbor pick it up for you.
- Arrange for lawn care.
- Store valuables, preferably in a bank.
- Store lawn mowers, bicycles, and lawn furniture inside.
- Set lights inside the house on a timer.
- Set telephone bells as low as possible.
- Draw shades and drapes.
- Lock cars left in the driveway.
- Make sure smoke detectors are working.
- Lock all windows and doors.
- Give your house key & itinerary to at least one friend or neighbor.

OUTDOOR BURNING REMINDER

Sec. 12-3.

- (a) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material on any improved street, gutter, parking strip, parkway, park, alley or any other town property within the corporate limits of the Town of Cheverly.
- (b) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material within the corporate limits of the Town of Cheverly, without first obtaining a permit from the Town of Cheverly, excluding outdoor cooking devices and fire pits.

SIDEWALKS

TOWN CODE Sec. 18-4.1—SIDEWALKS

Whenever snow accumulates to a depth of one inch or more, it is the duty of each occupant to clear the snow from the sidewalk adjacent to that property, within 12 hours after the snow ceases, (unless at night, in which case it shall be removed within 12 hours after sunrise). Snow and ice removed from sidewalks shall NOT be deposited on streets or other sidewalks.

When ice forms on sidewalks, occupant shall place sand, ashes or other such material on sidewalks within 6 hours, (unless at night, in which case it can be spread by noon of the next day).

Icy spots on public property can be reported to Public Works at **301-773-2666**.

CODE COMPLIANCE

WINTER WEATHER REMINDERS TOWN

CODE - Sec. 27-10—

Parking A snow emergency shall exist whenever snow has accumulated on the streets to a depth of one (1) inch or more.

The provisions of this subsection shall be effective without any notification and shall remain in effect until the street is plowed; provided, however, that when snow shall accumulate to a depth of one inch or more after 11:00PM, the provisions of this subsection shall not be effective until 7:00AM the day following and shall remain in effect until the street is plowed.



PARKING RESTRICTIONS: During a snow emergency no person shall park any vehicle as follows:

- On the cul-de-sac portion of any street,
- On any courts,
- On the even-numbered side of all streets,

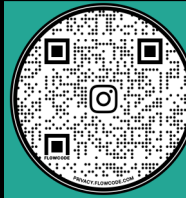
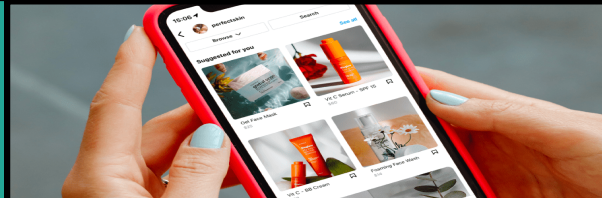
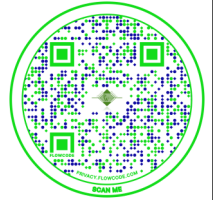
(exception) on the odd-numbered side of 59th Avenue, and one block of Inwood Street between Cheverly Avenue & Belleview Avenue.

NOTE: The snow emergency parking restrictions do not override existing no-parking zones or apply to streets where enforcement would disallow all parking because of a no-parking zone, or to streets with any barrier or strip dividing lanes of traffic.

PRIORITIES: The snow removal operations work under the following priorities:

- 1.) Cheverly Avenue
- 2.) principal connecting streets: Forest Road, Crest Avenue, Valley Way, Greenleaf Road, 62nd Avenue, State Street, Schuster Drive;
- 3.) all other streets.

PARKING COMPLIANCE

TOWN CODE - Sec. 18-4.2 and Sec. 27.5



Vehicles that have not moved for 72+ hours may be towed; all vehicles need to be operational & legally operable on both private property and on the street.

Commercial vehicles are prohibited to park in front of residential properties.

TOWN CODE - Sec. 27-10—Parking

A snow emergency shall exist whenever snow has accumulated on the streets to a depth of one (1) inch or more. The provisions of this subsection shall be effective without any notification and shall remain in effect until the street is plowed; provided, however, that when snow shall accumulate to a depth of one inch or more after 11:00PM, the provisions of this subsection shall not be effective until 7:00AM the day following and shall remain in effect until the street is plowed.

CODE COMPLIANCE

RESIDENTIAL ZONE PARKING



2023 Residential ZONE parking permits will be available December 15th. The price of the permit is \$5 per vehicle. There is a maximum of 2 guest passes per residence. The first guest pass is free and the second guest pass may be obtained for \$2 fee. (Note:

ONLY two guest passes per address.) Applications can be downloaded from the Town website at www.cheverly-md.gov under the Form and File tab. Please drop completed applications in the Permits Box located at Town Hall or mail to: Code Enforcement, 6401 Forest Road, Cheverly, MD 20785.



Cheverly Residential Zone Parking Permit Application

Applications can be submitted at Town Hall, online, via US Mail, or placed in the permit box located on the left-side wall of the main entrance at Townhall

- Permits can only be issued to vehicles registered to a Cheverly address
- A copy of your vehicle registration must accompany the application
- Cost of the Permit is \$5 per vehicle | 1 guest parking pass is allowed **per address** at no cost
- The maximum number of guest passes is 2 per address. This includes one free pass and ONE guest for a \$2 fee.

If you live in one of the following areas, you will need a Parking Permit: Please check the zone that applies.

- Zone 1: State St, 61st & 62nd Ave, as well as the 1800 block of 64th Ave
- Zone 3: 22-2400 block of Cheverly Avenue
- Zone 4: Arbor Street & Crestlawn Avenue *(22-2300 block Parkway Eliminated)*
- Zone 5: 2300 block of Belleview Avenue
- Zone 6: Benton Rd & 23-25 Lake Avenue
- Zone 7: 2400 block of Valley Way
- Zone 8: 3300 Belleview Avenue; Medical Terrace *(Eliminated)*
- RO: 6500 & 6600 blocks Oak Street, 6500 block Maureen Court, 3132 & 3200 block Hillside Avenue
- SR: This permit allows senior citizens 65 years of age and older to park on the odd side of the 2200 block of Cheverly Avenue in order to utilize the METRO



- Residential Parking Permits are to be displayed on the back Left Bumper area.
- If you have a regular and a SR permit, display them next to each other on the Back Left Bumper.
- Guest Parking Permits shall be hung on the REARVIEW mirror with information facing outward.
- Citation may be Issued to ANY Vehicle not in compliance with Town Code 27-5.1 Residential Zone Parking
- If you have any questions, please contact the Office of Code Compliance at 240-770-7647

To apply for a Residential Zone Parking Permit by mail, please provide the following information **AND a copy of your *vehicle's registration**. Return this form to Residential Parking at the Town of Cheverly with the payment.

*If you have obtained a Non-Resident Permit from MVA, you MUST send a copy of that permit along with your request.

Yard Waste and Recycling should not be put in plastic trash bags. **Electronics will no longer be picked up with Recycling on Wednesdays. They will be picked up on Thursdays or Fridays with Bulk Trash.**

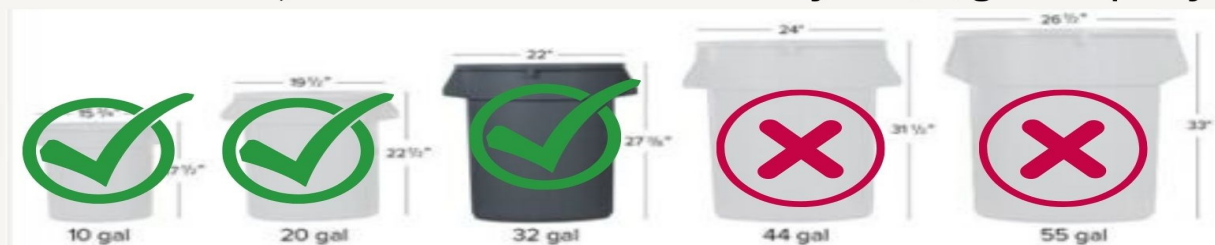

TRASH CAN SIZE FOR COLLECTION

Just a reminder, containers are not to exceed thirty-two (32) gallon capacity.



Public Works will not pick up nor empty trash containers larger than 32-gallons. This is for the safety of our Public Works employees who manually lift each and every trash can.

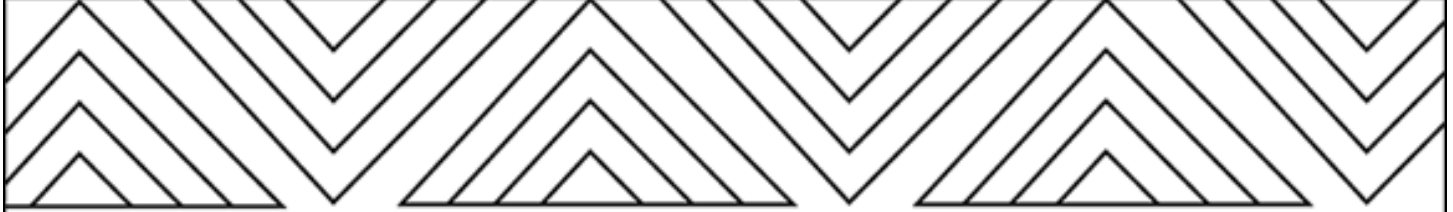


Did you know you can request one tree inspection per year by the Town's Arborist?

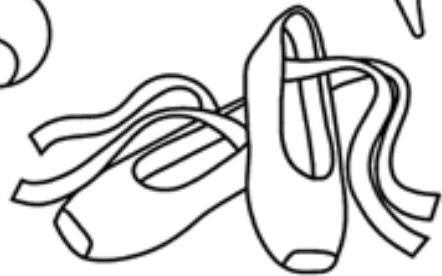
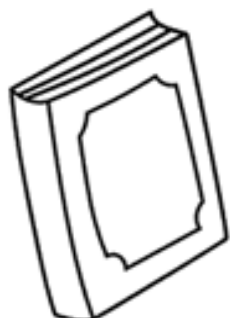

Message from the Chief

Security for Apartment Renters in Cheverly:
 Renters may feel they have limited options for adding security to their homes; however, it might surprise you that there are several easy security measures you can implement even in a large apartment complex, such as Cheverly Station Apartments. Below are a few **Tips** to help you understand the options available:

1. **Get Renters Insurance** – Despite all the safety precautions available, unfortunate events still happen. So, it’s a good idea (if possible) to obtain renters insurance. This insurance policy covers personal property like furniture, electronics, clothing, possessions, and damages to same. According to a local insurance company, the cost is ESTIMATED to be around \$20.00 per month.
1. **Meet Your Neighbors** – Knowing your neighbors is like having intelligent security cameras all around your building.
2. **Cover Your Windows** – Despite the uneasy feeling, and police patrolling the area, many intruders “shop around” for good pickings before deciding on a place to burglarize. The best way to keep your place off their list is to hide your personal possessions by covering the windows.

3. **Get A Door Security Bar** – A door jammer is a great security measure for apartment dwellers.
4. **Check the Lighting** – Apartment buildings and complexes sometimes have dark nooks and crannies, making them ideal for people to sneak around a corner to include hallways, parking lot area, storage rooms, waste management areas, stairwells, laundry rooms.
5. **Check the Entrances** – The first line of defense in renter’s security are entrances, both to and from your apartment to include the building or complex.
6. **Install a Security System** – Drilling holes in apartments is usually not permissible (can impact your whole security deposit) so many renters dismiss a security system. Fortunately, that’s not the case. Wireless alarm systems use adhesive to fix door and window sensors in place, and you can use your smartphone for monitoring. Many systems also provide freestanding sirens (no bulky keypads that mount on the wall). An added bonus, having an apartment security system MIGHT reduce your renter's insurance.

Apartment security is about routinely doing the small things that make a big difference. The Cheverly Police Department continues to value your participation and individual talents brought to this wonderful community.

The Cheverly Police Department has partnered with Major James Keleti, Commander Prince George's County Police Hyattsville Division I, and Ms. Dametrice Jones-Myers, Senior Property Manager at Cheverly Station Apartments. This collaboration is important to improving safety and security. If anyone has suggestions for any further enhancements related to security or safety, please feel free to communicate it to the Cheverly Station management office at (301) 773-0200 or visit the office at 6501 Landover Road Landover, MD 20785.

A meeting is planned with several stakeholders to discuss enhancing safety and security for those residents both living and visiting Cheverly Station Apartments. I remain hopeful, this meeting will begin an effective partnership between law enforcement and community stakeholders that are essential to public safety. It is important that government agencies, community groups, nonprofits, businesses, and private citizens all embrace public safety as a shared responsibility.

Weathering Winter Storms

If the weather outside is frightful, make sure you're prepared to safely brave snow, ice, and other winter weather hazards.

Here are some tips to help you stay safe:

- Avoid carbon monoxide poisoning. Only use generators and grills outdoors and away from windows. Never heat your home with a gas stove-top or oven.
- Stay off roads if at all possible. If trapped in your car, then stay inside.
- Limit your time outside. If you need to go outside, then wear layers of warm clothing. Watch for signs of frostbite and hypothermia.

- Reduce the risk of a heart attack by avoiding over-exertion when shoveling snow and walking in the snow.

Learn the signs of, and basic treatments for, frostbite and hypothermia.

- Frostbite causes loss of feeling and color around the face, fingers and toes.
 - Signs: Numbness, white or grayish-yellow skin, firm or waxy skin.
 - Actions: Go to a warm room. Soak in warm water. Use body heat to warm. Do not massage or use a heating pad.
- Hypothermia is an unusually low body temperature. A temperature below 95 degrees is an emergency.
 - Signs: Shivering, exhaustion, confusion, fumbling hands, memory loss, slurred speech or drowsiness.
 - Actions: Go to a warm room. Warm the center of the body first—chest, neck, head and groin. Keep dry and wrapped up in warm blankets, including the head and neck.
- **Emergency Kit for the Car:** In case you are stranded, keep an emergency supply kit in your car with these automobile extras: Water (one gallon per person per day for several days, for drinking and sanitation), Food (at least a three-day supply of non-perishable food), Jumper cables, Flares or reflective triangle, Ice scraper, Car cell phone charger, Blanket, Map, Cat litter or sand (for better tire traction).
- **Prepare Your Car for Emergencies:** Have a mechanic check the following on your car before an emergency: Antifreeze levels, Battery and ignition system, Brakes, Exhaust system, Fuel and air filters, Heater and defroster, Lights and flashing hazard lights, Oil, Thermostat, Windshield wiper equipment and washer fluid level.

Monthly meeting to report progress on Cheverly greening efforts and plan next steps and new initiatives. In implementing the Cheverly Green Infrastructure Plan, your Cheverly Green Infrastructure Committee is working on projects in education, planning, and research.

TRIBUTARY 4 (RED MAPLE RUN)

Where is Red Maple Run? Where does the water come from? Where does it go? What is being planned?

Tributary 4, or, as it is renamed provisionally, Red Maple Run, is in Cheverly's far east, Maureen Court and Oak Forest Court. It is part of the natural area network of the Cheverly Green Plan.

Storm water enters the stream from your roofs, yards, driveways, and the streets through the storm drains. It can pick up pollutants before being discharged into the stream through outfalls. The faster the water rushes through the outfalls, the more it can scour the stream bed and banks, leading to erosion and driving sediment and pollutants downstream to Lower Beaverdam Creek, the Anacostia, and Chesapeake Bay.

Reducing the water coming into the stream from the upland area leads to sustainability of the stream itself. Rain barrels, rain gardens, tree planting, and green streets are ways homeowners and the town contribute to this goal.

The Maryland Department of the Environment encourages a combination of both upland and in-stream practices.”

The Prince George's County Department of the Environment is planning a stream restoration project for Tributary 4. As of the time of this writing, the proposed project area did not include much of the upland.

The stream flows through land owned by the Town of Cheverly and by M-NCPPC. So Cheverly will have to sign an agreement to permit entry and work on the project. In its advisory role, the Cheverly Green Infrastructure Committee will submit recommendations to the Mayor and Council.

The Cheverly Green Infrastructure Committee hopes for a comprehensive watershed restoration project that follows MDE guidelines, that combines robust upland best practices, forest preservation, and meaningful community involvement with the stream restoration itself. Such a comprehensive project will contribute to

the shared goal of long-term stream sustainability and habitat health.

Do you have more questions about plans for Red Maple Run? The Cheverly Green Infrastructure Committee has plenty. You will find the questions and comments submitted to the project team at www.greencheverly.org.

Another opportunity for public comment may come when the project designers submit the permit application to the MDE and Army Corps of Engineers. Public notice will be posted at <https://www.nab.usace.army.mil/Missions/Regulatory/Public-Notices/>. You can sign up to receive notices on the same website.

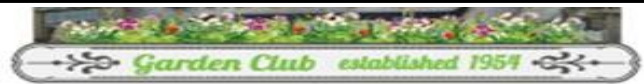

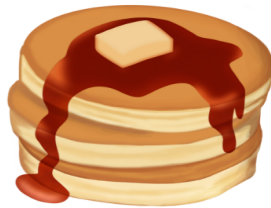

CHEVERLY NATIVE PLANTING PROJECT

Winter is the best time to tackle an invasive plant that is ubiquitous throughout Cheverly – English ivy (*Hedera helix*), a vine introduced from Europe, western Asia and northern Africa. Its shiny evergreen leaves really stand out this time of year. While attractive, the weight of its growth on trees creates hazardous trees that fall on roads and cars. You can see evidence of this here in town, for example, along Cheverly Avenue and Landover Road.

On a larger scale, English ivy is destroying native forest ecosystems by weakening and killing trees along the edges, reducing the overall size of forests. As it grows up a tree, it weakens it by preventing growth through photosynthesis. English ivy can kill a tree within 5-10 years if allowed to grow unchecked. It can also damage homes, retaining walls, and fences and, in warm months, it serves as a hiding place for mosquitoes! Getting rid of English ivy, especially growing on trees, will protect you and your property, save your trees, improve your yard, and enhance our public spaces in many important ways.

Wearing gloves to protect yourself from poison ivy that often grows alongside English ivy, use clippers or a small hand saw to cut the stems at a comfortable height all the way around the tree. For thicker vines, carefully saw through the stems, stopping when you get to the bark to avoid damaging it. A flathead screwdriver can be used to help pry the vines away. Pull the cut stems down to the ground, taking care to avoid damaging the bark. ***Do not try to remove the vines above your cut line.*** The cut ivy will soon die and eventually fall off the tree. Pull cut ivy vines out of the ground around the base of the tree, making a two-foot “lifesaver ring” around the tree.

Because English ivy grows along the surface and has shallow roots, ground infestations can be removed by hand, with help from pruning snips to cut stems, or a heavy-duty rake* to help gather the vines. *CNPP has a “fire rake” – a specially designed rake used by foresters - that we use to help grab the vine stems.

There are a number of great native alternatives that can be planted in place of ivy. The University of Maryland Extension website has a list of recommendations. The US Fish and Wildlife Service’s “*Native Plants for Wildlife Habitat and Conservation Landscaping: Chesapeake Bay Watershed*” is another great resource. A PDF is available online and CNPP can get physical copies for a small fee for those interested.

For more information on invasive plants affecting our area, get a copy of *Plant Invaders of Mid-Atlantic Natural Areas, Field Guide*, published in November 2022.
