**Call to Action – Please Read:** On November 6<sup>th</sup> the County Council, sitting as the District Council, will hold a Public Hearing to potentially modify the Cheverly Sector Plan. A development company, First Oxford Corporation, has proposed extending the Tuxedo Town Center eastward into the existing green space along Route 50 from Cheverly Avenue to Cheverly Park Drive in an effort to build a multi-story rental complex.

This area is a designated FEMA Floodplain, designated as Green Space in the County's Sub-Region 4 Sector Plan, and again designated a Green Space in the Cheverly Sector Plan. As a community we have consistently shown a preference for this land to be a green space.

The Cheverly Sector Plan was adopted and finalized on June 22<sup>nd</sup> by the County Council. However, on July 5<sup>th</sup> the First Oxford Corporation requested that the plan be amended to allow this development. This modification comes after MNCPPC conducted three large public meetings, six advisory board meetings and countless hour of work. We need everyone who is able, to attend a Public Hearing on November 6<sup>th</sup> at 7:00PM at the County Administration Building in Upper Marlboro. The hearing will be conducted the County Council chambers. A follow up announcement will be sent via News and Announcements.

**SCMAGLEV Update:** It's hard to believe how much has changed since last month. Last month, I expressed concerns about the SCMAGLEV trains passing Cheverly either on the Amtrak Route along Route 50 or in the center of the BW Parkway.



## **Mayor's FYI Con't....**

Since then the BWRR (Baltimore Washington Rapid Rail) and the FRA (Federal Railroad Administration) narrowed the choices to three potential routes and a no build option. The good news is that, due to public opinion, every route calls for the MAGLEV to be tunneled until it is outside the beltway. Therefore, we in Cheverly will not have to worry about disruption caused by the MAGLEV train being operated at surface level. I attended a meeting on the 24<sup>th</sup> which was very informative. For those concerned about the tunneling that will be near our town, there will be surface sensors deployed to detect any abnormalities that may occur during tunneling.

### **Governor Hogan Announces Highway Expansion:**

Another topic in last month's newsletter was Governor Hogan's proposal to assume responsibility for the BW Parkway from the Department of Interior, widen the Parkway, and potentially add tolls. There have been no updates on this proposal and none are expected soon. However, I wanted to clarify that there appears to be no linkage between the widening of the Parkway and the MAGLEV train (at least inside the beltway). The council will continue to monitor the situation.

**What Is the New Building on Tuxedo Road?** The most commonly asked question I get recently is regarding the new construction at Tuxedo Road and 57<sup>th</sup> Avenue. There have been some pretty fun rumors, but the truth is a little less exciting.

A Firm by the name of Design Army ([designarmy.com](http://designarmy.com)) is building a studio at this location. As you can tell they have invested a significant amount of funds in the building and it will be a wonderful asset to the area.

**Why Have so Many Trees Been Removed?** Lately this has been a very common question as well, particularly west of Cheverly Avenue. The Town had a large number of Ash trees that have been victimized by the Emerald Ash Borer. Unfortunately, over the last two years the Public Works has had to remove almost all of our Ash Trees because they had died and become a hazard to the community.

Remember, if you want to help renew our tree canopy, the town will come and plant a tree in your front or

back yard for free just call Public Works at 301-773-2666.

**6301 Kilmer Update:** OMG, how I have waited to print this in the newsletter. Yes, the fence is down and the property is open to the public. Feel free to mosey around and enjoy the property. There are so many big trees and a gold fish pond. It is a very pleasant place to meander, but please keep you dogs on leash while on the property.

**Cheverly Signs MOU for New Motel near Wyndham Gardens:** The town recently signed a Memorandum of Understanding (MOU) with a developer who plans to build a new hotel on the property where the Pointe@Cheverly was planned to be built. The Town held initial conversations with the developer and has insisted that the hotel be of a certain quality and meet standards of our community.

A hotel is a great addition to our community. Did you know that the Wyndham Hotel provides not only property tax, but also over \$70,000 in rental taxes annually? So a new hotel in Cheverly will add significantly to our tax base at a location where we are currently generating no taxes.

There is still a way to go, 5/6th's of the property is owned by the county Redevelopment Authority (RDA). Over the next couple of months the RDA, Cheverly and the developer will work on an agreement that will allow the developer to purchase the property to build a hotel.

**Metro Pointe is being constructed:** After two failed attempts and a very long period of dormancy the Metro Pointe complex is being built on Landover Road by the Landover Metro Station. This is a townhome condominium complex, with 2 BR townhouses beginning at \$280,000 and larger units priced at \$320,000.

While the town lobbied for a denser housing complex given the proximity to the metro, this housing complex will bring some much needed density to area. As we have discussed many times this area needs more commercial services, and quality housing density will help to bring them.

## **Mayor's FYI Con't...**

**A Trust Act for Cheverly:** The Council continues conversations regarding the Trust Act.

Many residents have asked "Will this change how the police department operates?" As I understand, at this time this will not change how our Police Department operates. Today, based on existing federal law our Police Department cannot require documentation from anyone in the performance of their duties.

Undocumented Cheverly residents, or non-residents, should know: that Cheverly Police will not ask for documentation from victims, individuals reporting crimes or suspicious activities or individuals being arrested.

Other residents have asked "what happens to a felon who maybe undocumented?" First, please understand that the Cheverly Police will arrest anyone who is committing a crime; documented or not. Again, the Cheverly Police Department does not get involved in documentation. However, please know that Cheverly like all surrounding municipalities does not have jail or holding facilities. So when someone is arrested and detained in a county facility that documentation status is very much considered. At this point, a municipality has no control over the process.

I have come to think of this as a front end process (our police departments) and a back end process (jails and holding facilities). Most Police Departments I have spoken with (whether they have declared Sanctuary Status or not) do not require documentation from individuals at traffic stops, who call for assistance, or in any activity. However, when an individual is detained and is placed in jail facility documentation is considered.

The council has briefly discussed two options for moving forward on this matter either passing an ordinance or a resolution. An ordinance would have the effect of law, and while it simply would state the practice as it already is, many feel that this is needed. Another option is for the Council to pass a resolution without an ordinance. A resolution would voice the intent of the council.

In the August newsletter I published a Question and Answer with Chief Robshaw regarding Cheverly's

The gist of the Q&A is that the Cheverly Police does not consider an individual's documentation in the course of their activities. To be clear, *if an undocumented individual needs help of any type from the Cheverly Police they should reach out to the police without any fear of reprisal.*

**Climate Change Resolution:** As a Maryland Municipality that has attained the status of a Sustainable Community, the council has displayed a desire to sign on to the organization's proclamation regarding Climate Change. The Town has shown consistent progress to meet the goals of Sustainable Maryland and to reduce the energy consumption and carbon footprint of the town. In effect the Town Council believes Science is Science!

This was introduced in the September Town Meeting, and read three times prior to passage. You can find the current version of the resolution on the Town Website.

**Curbside Composting:** Cheverly has a very backyard composting program, and everyone is encouraged to purchase a composter from Public Works for a reduced price. Peg and I have been composting for six years and we are shocked by the reduction in the trash we bring to the curb. And yes, there are no negative impacts such as odors or animals.

However, not everyone wants to compost in their backyard, due to space and other concerns. For these people, our resident composting expert Doug Alexander is attempting to get a curb side composting program going. The program would be simple, for a small one-time fee the town would provide you a counter top container and a 10 gallon receptacle to place your compostable waste in. Once a week you would take it to the curb and public works will pick it up. Voila! What could be easier!

To start the program we need at least 100 residents to join to make it cost effective and efficient for our Public Works staff. If you are interested please call Public Works at 301-773-2666.

**CHEVERLY PUBLIC SAFETY DAY 2017**– Every year, in lieu of the celebration of National Night Out, the Cheverly Police Department holds its annual Public Safety Day. This year's event was held on Thursday, September 21, 2017, from 5:30 PM to 8:00 PM. at the Town Park. In addition to a wide array of public safety vehicles and demonstrations, including the U.S. Park Police helicopter "Eagle 2," there was a large "Obstacle Course" for people of all ages, and a free meal provided by **Mission BBQ** for all attendees. With a count of over 600 people attending, this was by far the largest turn out for this event to date.

In addition to the great turn out, over \$500 was raised the Maryland Chapter of the Concerns of Police Survivors (C.O.P.S.). Each year, between 140 and 160 police officers are killed in the line of duty and their families and co-workers are left to cope with the tragic loss. C.O.P.S. provides resources to help them rebuild their shattered lives. There is no membership fee to join C.O.P.S., for the price paid is already too high. The CPD would like to very much to thank our law enforcement partners and the residents of Cheverly for making this event the greatest!!

**Vehicle Donations** – As we approach the end of the current tax year, we encourage all Cheverly residents who wish to donate a vehicle to the Department to do so as soon as possible. The CPD works very hard to get the most we can for every donation and we frequently use a local government website to auction vehicles. This auction process takes several weeks and has, to date, been the most profitable way to turn your donation into usable dollars for the Department. All monies from donations are spent to purchase new equipment, such as the "Street Meets" trailer, and there are no hidden administrative costs. A big thanks to everyone who has donated a vehicle this year!!!!

Cheverly has five natural areas awaiting your discoveries. Leave the car in the driveway – you can get there by bike or on foot.

Euclid Woods adjoins an active recreation area of Cheverly Euclid Park. It connects two ecologically similar areas designated for redevelopment, the Craftsman site to the south and the hospital site to the north. Euclid Woods is the richest of Cheverly's areas in both plant and animal species and thus functions as a source area for biodiversity that can generate a surplus to replenish the smaller hubs. It is especially rich in tree and shrub species and the herbaceous plant layer is slowly returning as invasive species are being removed. A deep stream ravine, gullies, scrub pine stands and prairie type grassy glades offer a diversity of vegetation.

Euclid Woods is a mid-successional hardwood mix and a woodland of diverse microhabitats. There are tulip trees, red maples, black gums (tupelos), southern magnolias, American beech, and several species of oaks and pines. Shrubs include several viburnums, spicebush, elderberry, and sweetshrub. Wild yam is an interesting vine growing here. You may also see partridgeberry and native grasses, box turtles laying eggs, deer, both red and gray foxes, strawberry bush, and spotted wintergreen. A small area, the "Red Desert," supporting vegetation typical of pine barrens, is unique in Cheverly. Among the birds seen along the stream and in the woodland are the towhee, barred owl, woodcock, ovenbird, Louisiana waterthrush, pileated woodpecker, eagles, and yellow-billed cuckoo. Tributary 1, which runs along the park's western border, drains the western portions of Greenleaf Road and Hawthorne Street, as well as Euclid Woods, hospital hill and parts of the Cheverly Industrial Park. The stream runs through a deep ravine, having plunged about 18 feet from its level at Greenleaf Road. A wall of large riprap between the upper and lower streams is intended to slow the water. Several types of ferns, dogwood, and native azaleas may be seen in and near the gorge. The soil in the stream, of mixed silt and clay, is easily eroded, and often forms picturesque but relatively short-lived grottoes and small waterfalls. The streamside area includes a spring and a freshwater wetland.

Designated by the Cheverly Green Infrastructure Plan as a natural resource area, Euclid Woods is managed as a community demonstration area for sustained natural resource stewardship. The goal is to sustain optimal conditions for native flora and fauna and eliminate invasive species. The area has been the site of youth science studies and an historical-archaeological survey. Natural-surface deer paths offer a near-wilderness experience. Matt T. Salo serves as steward, and occasionally guides tours. 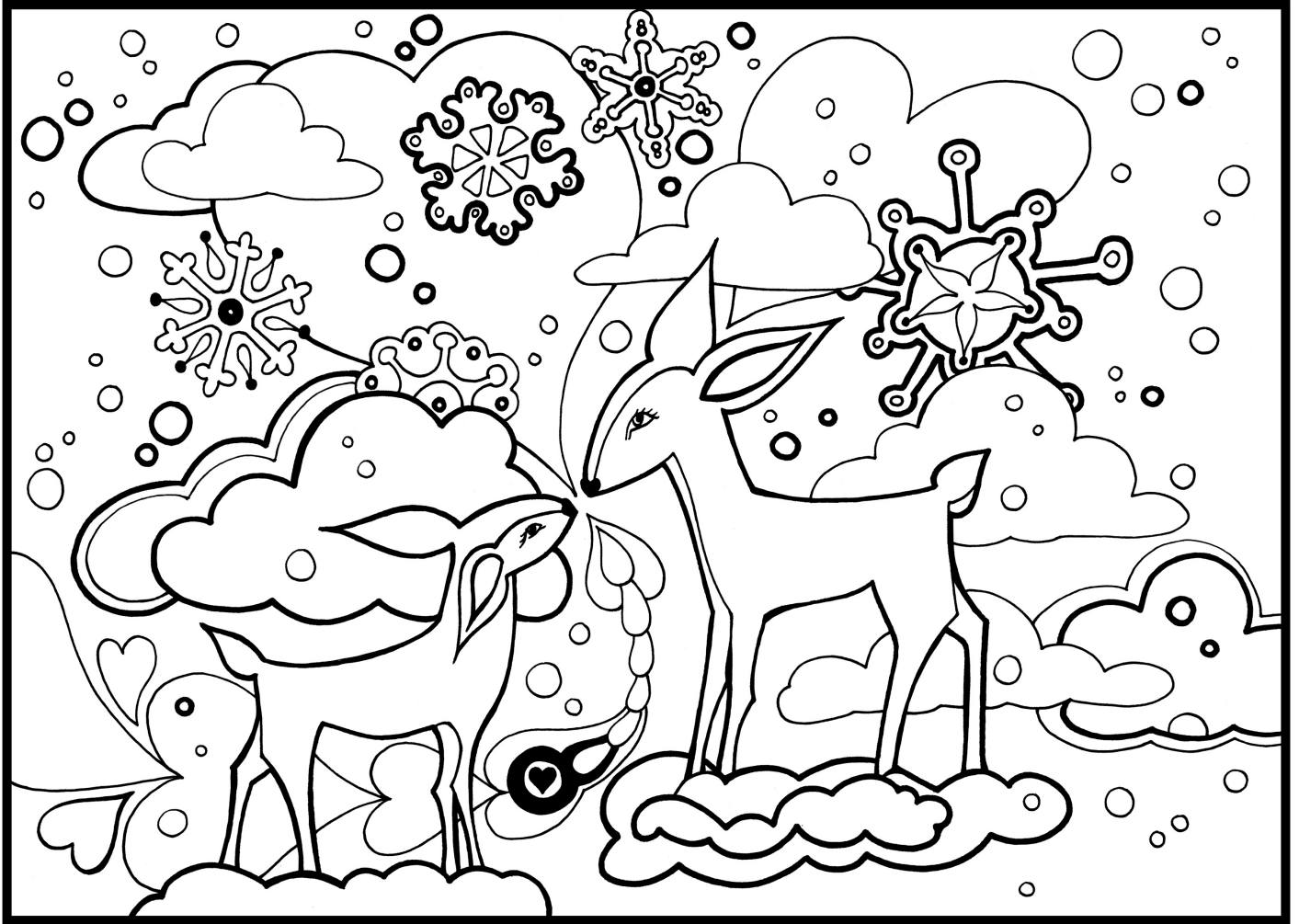

# Leaf Collection or Leaf Mulching



Every season has its beauty and specific tasks that must be performed by your department of public works. During the warm summer days, plans were made for the fall to plant trees, fix some of the flower beds, repair some sidewalks and prepare the equipment for the year's leaf vacuuming collection efforts. Somewhere in this newsletter you will find the leaf collection schedule. This is the time when the Town's crews will be in your area so that you can be ready to rake your leaves to the curb.



The leaf collection schedule is by no means perfect. Despite the yearly adjustments; the leaf collection crews cannot be at all places at the same time or when the leaves decide to fall. Some years the best scheduled plan for collection is too early, others times a little late; the leaves have yet to share their falling schedule with anyone. Nevertheless, if raked to the curb, bagged and/or containerized they will be collected. Now as you know and value, the Town of Cheverly can arguably be construed as unique within Prince Georges County. It is an eyesore to have the Town littered with bagged leaf at the curb prior to the scheduled Monday collection. Although it can be considered a violation of the Town's code this practice makes the Town look shabby over the weekend when the town has prospective buyers and visitors. Please keep the bagged leaves on your property until Sunday night.

On the other hand this might be the year that you can help with nature's perfect cycle. How about letting the trees and your lawn clippings come together to "self-fertilize?" Why not take your mower or ask the service that mows your lawn to run the mower over your leaves from north to south and from east to west? The mixture of nitrogen rich grass particles mixed with the carbon rich leaves that have fallen on your lawn make the best combination for you lawn and for the environment.



But you don't have to take just my words on this matter; read this excerpt: *"Raking and collecting leaves every autumn is a tradition without scientific basis."*

*"Based upon research at several uni-versities, the organic matter and nutrients from leaves mown into lawn areas has been proven to improve turf quality. At Michigan State, researchers set a rotary mower to cut at a height of 3 inches and then mowed an 18-inch-deep layer of leaves into test plots. That's the equivalent of 450 pounds of leaves per 1,000 square feet. The tests resulted in improved soil and healthy lawns with few remnant leaves visible the following spring."* <http://www.finegardening.com/improve-your-soil-raking-less> by Terry Ettinger.



The Department of Public Works will be picking up falls raked leaves just like last year. Once again residents will be provided with three ways to remove the leaves from the lawn: 1- bagged them in paper bags and leave by the curb for Monday's yard waste collection; 2- place them in a container for Monday's yard waste collection; 3- when your block is schedule for collection - rake them to the tree planting strip without blocking the sidewalk or allowing them to fall on the curbs and blocking the nearby storm drain.



**On the other hand: How about Nature's cycle and mulching them? This could be year that we as a Town permit the cycle to continue and thereby doing our part in the restoration and the nurturing of our piece of the earth.**
