#### **Town Council Begins Implementation of Traffic**

Study: There are many elements of the Traffic Study that will require years and significant expenditure of funds to complete. However, the Traffic Study also outlined a number of smaller steps that the Town could take that would provide benefit to the community. One small, inexpensive action has already been taken as I write this FYI. Town Staff has began re-striping all of the white lines and crosswalks in the study area. The traffic study was clear that providing drivers more visual clues to help slow down traffic was important.

The council also approved the following actions as part of the initial implementation; 1) raised crosswalks will be installed at the intersection of 64th Ave and Inwood Street, 2) raised crosswalks will be installed at the intersection of Kilmer Ave and Laurel Ave, speed humps will be installed on Jason Street and speed humps will be installed around Gast Park.

Many of these installations have long been requested by residents, and the Council had been waiting to get the results of a traffic study. As all should know it is currently a policy of the Town Council to install raised crosswalks at as many Stop signs as possible around town to encourage drivers to follow the law and come to a complete stop at Stop signs. The Town Council has asked staff to implement raised crosswalks whenever streets are repaved.

Air Quality Permit Meeting for Smith & Sons: The Town Council will continue to monitor the progress of Smith & Sons request for an Air Quality Permit from the Maryland Department of the Environment. As noted previously, Smith & Sons is revamping its operations and is placing a number of new machines on site. Smith & Sons is upgrading their metals recycling process to utilize "wet processing" in their sifting machines.

The Town has reached out to the University of Maryland professors to ask for assistance in implementing an air monitoring system that could provide detection of particulate matter. As noted by the attendees at the initial Public Meeting, MDE's nearest monitoring site is in Upper Marlboro which the audience felt was way too far to provide accurate results for our community.

The University of Maryland professor was very open to the request and as of this time the awaits a proposal. The great news is that the the cost of air monitoring sensors has decreased tremendously making a project like this obtainable for a small community.

The Town as also, based on citizen request, submitted a Freedom of Information Act request to MDE to determine if there have been any violations that should be considered.

This has become one of my favorite traditions for kicking off the holiday season. What better way to start the season than singing with your neighbors, or simply listening to them sing if your voice is like mine.

A Food Forest at 6301 Kilmer? Cheverly always runs best when ideas come from the ground up. Thanks to Anna Hawkins, and members of the Green Infrastructure Committee particularly David Kneipp and Sheila Salo, the Town Council will be considering dedicating a portion of the 6301 property to being a Food Forest.

Food Forests are popping up in municipalities

throughout the area and provide communities a nice amenity. What is a Food Forest? Well if you go to wikipedia this is what you get: "Forest gardening is a low-maintenance sustainable plant-based food production and agroforestry system based on woodland ecosystems, incorporating fruit and nut trees, shrubs, herbs, vines and perennial vegetables which have yields directly useful to humans."

Of course a simpler way of putting it is; It would be a great place to stop by and pick some fruits, berries and perennial vegetables. David Kneipp, and the Green Infrastructure Committee, requested a small grant from the town to install a teaser garden near the gates of the 6301 property this fall so that residents could get a flavor of what a Food Forest might be.

Over the winter the Town Council will consider a master plan for the 6301 property. The Park Master Plan process is what the town uses to allocate space in Town parks for various uses. The Town will consider the Food Forest as well as a pedestrian path from 6300 block of Kilmer to the 6301 property to increase to this property for Cheverly residents in the apartments.

Hey Mike, are you saying this entire property will become a Food Forest? Nope! The request is for a portion of the property in the Northwest quadrant close to the school.

Hey Mike, what about potential other uses for the 6301 property? The great thing about the Food Forest is that almost any other use will be compatible. However, if a use comes along that would require this space it is not a large financial commitment?

Hey Mike, I'm still unhappy, why did the town spend \$300,000 to purchase this property? Well, as our people say "they aren't making green space anymore?" I apologize if that seems smart alecky, but it is true. It is impossible to find two plus acres of green space anywhere near Cheverly.

Purchasing the 6301 property also provided us with control over what happens on the property. We had originally wanted to buy it in partnership with Park and Planning as well as the School System, unfortunately they were unable to participate.

Lastly, I did a little math on this, and the way I figure it each single family home paid approximately \$110 a piece for the property. Seems like a pretty good deal.

LED Street Lights for Cheverly: The Town Council has requested staff to pursue an agreement with PEP-CO to install LED Street Lights. At our recent municipal summer conference, the state detailed programs that would provide municipalities grants for converting from our existing technology to LED lighting. Initial conversations with Pepco indicate that with the grant help the town could pay back the cost of the LED lights in four to five years. That is an amazing payback, and in five years our annual cost for street lights which is approximately \$80,000 would be dramatically reduced saving us lots of money.

Certainly the Council will ensure that appropriate LED lights will be implemented, and of course we will continue to inform the public about the process. The Town Council is very a aware of concerns residents have regarding the spectrum associated with LED lights, need to protect our "dark sky" and the opportunity to potentially improving the character of our town.

Please remember, we are in the preliminary phase and as of this point have not received an official proposal from Pepco.

Town Council to review Tall Grass Policy: Based on some residents comments the Town Council will review the Tall Grass Policy to determine if it needs to be fine tuned. The policy has not been reviewed since I joined council in 2006, and probably well before that. As we all know this year was a difficult year to mow your lawn, frequent rainy days led to tall grass and little time to mow. The code enforcement officer gave out over 200 citations, however, only 23 people recieved a \$50 fine. That equates to less than 1.5% of homes receiving a fine.

Today's process allows the Code Enforcement officer to fine a home at his discretion if the home has received multiple citations, including citations from previous years. This process has caused some confusion for residents regarding the language on the citations as well as the process.

The Town Council will consider clarifying the process by: 1) only considering citations that occur within the same calendar year, 2) establishing a number of times a home can be cited for tall grass prior to the issuing a fine, and 3) clarifying the language when both a citation and a fine are issued simultaneously.

We will continue to discuss this topic in the Newsletter and ensure all are informed prior to next mowing season.

Recently on my way to work, I heard five (5) different calls for theft from auto in the Hyattsville area. Every one of them involved a newer (usually 2018) Honda Accord in which the vehicle was left on blocks and all four tires and rims were removed. There have been several of these in Cheverly, and over 100 in the Hyattsville area in the last few months.

If you own a 2017-2019 Honda Accord, especially those with Sport rims, please make efforts to secure your vehicle, if not in a garage, as close to your residence as possible. At the very least, it should be kept in a well-lighted area and please engage the alarm if so equipped. Despite the fact that many of these vehicles had aftermarket wheel locks, thieves were able to remove them in a short period of time. As new information becomes available, it will be posted.

Woman's Club – One of our members recently shared "what brings her peace" in her work in the community and her thoughts on how it applies to the daily work of peace building. She shared how, although there are those among us who are wonderfully comfortable and secure in their understanding of the power of peace, far more of us (her included) struggle with the uncomfortable perception of peace as passive and as soft and ever-patient. This perception and experience can leave many of us viewing peace building as not effectively connected to our anger, our pain, or the tangible needs of our community and our world.

She developed C.R.E.A.T.E. (Celebrate, Respect, Educate, Advocate, Together, Every day) as a tool to call herself and others to realize that there is nothing passive in peacemaking and that there is always a place for celebration. As the Woman's Club approaches its centennial, she calls us to C.R.E.A.T.E. what we want to see in the world.

**Celebrate** – Too often we engage in giving, activism, and involvement in things we value from a sense of duty, need, or obligation. Doing so weighs us down and burns us out. Approaching our giving and doing and involvement out of a sense of Celebration of what we envision, who we are and of who is with us, buoys us up, energizing us and brings us joy that sustains.

**Respect** – Respect for ourselves and those with whom we work or seek to serve is at the core of integrity of purpose for anything we want to accomplish. A shared respect broadens our world and increases our confidence and supports the voices of those too long and too often overlooked.

**Educate** – We truly cannot change what we do not understand. Educating ourselves and others calls for openness and is as much about giving as it is about receiving. Powerful action is grounded in knowledge and understanding including understanding that there is always more to be learned and understanding is not an end but a process.

**Advocate** -- #StandUpSpeakOut – Have you noticed how the youngest among us advocate for what they value so freely and sincerely? When we call for change grounded in "Celebrate, Respect and Educate," we are clear in purpose, strong in reason, and resilient

**Together** – We have seen how one voice can inspire others and call for change in the world, but sustainability is realized from adding voices and efforts Together to amplify, to carry and to do more to share and own the vision and purpose together.

**Everyday/Every day** – Sharing peace and creating positive change need not be global to be magical. Seemingly small, Everyday carings can offer the greatest of goods. Sharing a compliment can bring a light to one's eye. Stopping to listen after asking "how are you" can save a life. Our giving and doing truly comes to life when we extend it beyond events, holidays, and campaigns.

Celebrate, Respect, Educate, Advocate, Together, each and Every day to C.R.E.A.T.E. a world that embraces, sustains, comforts, restores, heals, energizes and celebrates—a world in which we are active in giving and receiving peace.
