# 2012 Year In Review

As we look forward to 2013, let's not forget what we accomplished in 2012. Thanks to the leadership of our Town Administrator, Public Works Director, Police Chief and the Town Council, Cheverly once again has much to celebrate. Please take a moment to look over the list of accomplishments:

- Cheverly survived a Microburst, a Derecho and the end of the Mayan Calendar, congratulations to all.
- Cheverly remains in good financial condition as we ended FY12 with an audited fund balance of approximately 1.5M.
- Cheverly did suffer a 21% decrease in property assessments which resulted in a 2.1M loss of revenue over three years. The Town Council developed a "balanced approach" to resolving this issue by limiting cost increases and keeping revenues stable. In spite of raising the Tax Rate from .48 to .58 per hundred dollars of assessed value, most residents saw their town property taxes either remain the same or drop slightly.
- The Cheverly Police Department continued their excellent record. Through the end of November our crime rate was down almost 40%, from the record low rates of 2011. With the exception of January and September Cheverly experienced the lowest monthly totals since statistics were recorded in January 1980. In April Cheverly experienced 9 criminal events which is the lowest monthly total ever recorded.
- The Cheverly Watch Program grew to over 75 participants, the highest number ever.

- Cheverly Investigators were recognized by the Maryland Municipal League and the Maryland Police Chief's Association for their outstanding work and provided "Outstanding Investigation" awards.
- Chief Robshaw was recognized by peers and was promoted to the position of Vice President of the Police Chief's Association of Prince George's Cnty.
- Cheverly residents donated their used cars to the Police Department allowing them to begin purchasing cameras which can be worn on their jerseys for recording personal interactions for the purpose of reducing complaints about Police stops.
- The Public Works Department worked tirelessly removing 1,430 tons of trash and 600 tons of recycling, 25 pallets of electronics and distributed 130 loads of mulch.
- The Public Works Department put in many hours of overtime cleaning our streets of debris from the major storms we encountered this summer.
- Public Works completed the Public Safety initiative near Spellman School by installing 5 new raised crosswalks on 63<sup>rd</sup> Avenue. Additionally, pedestrian crossing lights have been added to Cheverly Avenue to help folks navigate Cheverly Avenue.

• Public Works designed and installed a grease pit in the Public Works Yard to comply with county storm water regulations. - Gazillions of electronic messages passed over multiple Cheverly List Serves, allowing residents to share recommendations, trade goods, and generally disseminate information. Thanks to those individuals who run the CPRC List, the Cheverly Exchange and the Cheverly List for everything they do to foster communication.

Mayor Year in review

- Progressive Cheverly hosted 10 forums on a variety of topics in an effort to inform Cheverly residents on issues both local and national
- Weekday Nursery continues to educate our youngest children and host every child's favorite event of the year: Truck Touch.
- Cheverly Advocates for Public Schools (CAPS) hosted the 3rd Annual Cheverly Schools Fair and 11 local schools and more than 75 families participated
- The Friends of Lower Beaverdam Creek (FLBC) continued to improve the Beaverdam Creek Trail from Magruder Spring to Town Hall. They have cleared the Magruder Spring area of invasive weeds and built a new bridge in the area. Kudos to Rex Korden, Gabe Horchler, and Barry Hill who have been known to take mornings from work to spread mulch along the trail.
- Doug Alexander with contributions from the Town of Cheverly, Progressive Cheverly, Republic Properties, the Garden Club and his own non-profit continued a composting program and has now distributed nearly 270 Soil Saver compost bins in an effort to reduce Cheverly's waste stream. Doug estimates the program saved the town over \$5,000 last year.
- The Cheverly Boys and Girls Club and the Cheverly Soccer Club continue to offer opportunities to our youth to enjoy year round sporting programs.
- The Community Market, especially Liz O'Leary, Kathryn Andrews and Cathy Wintermeyer, continued to provide Cheverly residents with the opportunity to purchase local produce and gifts at fourteen markets from May to December.
- The Cheverly Garden Club held their annual Plant Sale, providing Cheverly residents the opportunity to buy plants that grow well in our soils.
- Cheverly continued two new holiday traditions the Turkey Trot and the Yule Log. Special Kudos go out to Robin Kaye, Glen Barton, Abel Olivo for starting the "Couch to 5K" helping residents to get into shape for the Turkey Trot.
- And of course thanks to the Cheverly Day Committee led by David Thorpe, Pat Nelson, Kathryn Andrews, Jim Vigen and Micah Watson for another great event.

**Cheverly "Booms" Update:** Residents throughout town reported hearing a significant "Boom" on Monday 12/3/12 at 8:30pm. This "boom" was more significant than any that have occurred recently, and covered a much larger geographic area. We heard from folks in Hyattsville, North Brentwood and Mount Ranier who also heard the "boom".

The Cheverly Police reached out to peers in other jurisdictions regarding the "boom". *There is general agreement that the source of the boom was a firework exploding at the opening of the Monday Night Football Game at Fedex Field. This event corresponds exactly to the time of the "boom".* Patrons at the stadium attest to a very large single explosion occurred. Fedex Field is positioned on a high geographic point which explains the sound and vibration carrying so far.

This event created a lot of community discussion regarding the source of Cheverly "Booms." In an effort to update the community on efforts to identify the source, we provided the summary below. The categories are not scientific; instead they represent the current thinking of town staff.

- 1. Traditional "Booms": These are most commonly heard on the West Side of town, mostly in Ward 2 but occasionally in Old Ward 4 and Ward 1. Their frequency has tapered off over the last two years but they still occur. Action: We have been working with the Smith Company to cross reference when these occur with their hours of operation. We have not yet had a correlation but we have a commitment from the company to work with us. We contact them whenever a boom is identified.
- 2. "Potential Railroad Booms": These "booms" are heard throughout town and happen much less frequently, although there have been two this year. Residents who have grown up near rail yards report that these booms are unmistakably the sound of "dead heading". "Dead Heading" occurs when train cars are let loose in a yard and then collide with other standing train cars. Two of the last three "booms" that have occurred in town would be placed in this category. Action: *The Town has reached out to CSX and is trying to establish a meeting to discuss this possibility.*

3.	"Random Booms": These are very infrequent and

**Town Council Opposes Auditorium Application for Fuego Adult Night Club:** At the November 29<sup>th</sup> Town Meeting the Town Council voted unanimously to oppose an auditorium application for the Fuego Nightclub. The nightclub is located on Jackson Street which lies in the unincorporated area between Bladensburg and Cheverly. The site is less than a mile from the Cheverly Theatre and the Cheverly Industrial Park.

Fuego has been open for more than a year and has neither a liquor nor food services license. The Town Administrator became aware of the operation in the spring and raised this issue to many county officials. Unfortunately, because the club has no liquor of food license they are allowed to continue operating.

It is unclear at this time exactly what an auditorium license would allow Fuego to do, but we feel strongly that this is not the type of business we want near our borders. We are in the process of reaching out to local municipalities as well as state and local officials to gain their support for our opposition. Bladensburg has already responded.

**Town Council will address eliminating the Tax Cap:** At the December 13<sup>th</sup> Town Meeting the Town Council introduced legislation to eliminate the Tax Cap. Cheverly is one of only 13 Maryland Municipalities (there are 157) that have a Tax Cap. In Prince George's County only Laurel and Morningside have a Tax Cap on Real Property taxes. Residents have asked "Why are we considering this change?" Changing the Tax Cap is a cumbersome process that has at times prevented the town from taking the best actions during the budget process. The Tax Cap process prevented the Council from introducing a tiered tax rate structure last year.

Additionally focusing on the Tax Cap prevents residents from focusing on what is really important which is the Tax Rate. In response to residents who ask "doesn't this allow you to just change our tax rates in secret?" The answer is no! Last year we discussed the Tax Rate from February to June, throughout the Budget Process. The Budget Process is an open process that is discussed over a three month period. In an effort to ensure that everyone can voice their opinion on this topic, the council will not vote on this initiative until February.

Crime Rate Down 40%, Robbery Up 15%: As noted in the 2012 accomplishments Cheverly's crime rate continues at historically low rates. Every category of crime is down, except theft from motor vehicles. So please take the extra minute to lock your car doors and remove valuables from your car or at least remove them from the view of people passing by (particularly GPS's). This type of theft is a crime of opportunity and it is very hard to apprehend the culprit. So please help Cheverly keep the crime rate low.

**Ruffling Some Feathers or Playing Chicken?** At the December 13<sup>th</sup> Town Council meeting members of Prince Georges' County Backyard Hens organization presented to the Town Council. This group is requesting that the Prince Georges County Council eliminate the current requirement that residents must have at least a half an acre to raise chickens. Maryland National Capital Park and Planning has already made this recommendation to the County Council in a September report on agriculture. PG Hens is asking Cheverly to send a letter to the County Council is currently out of session and this item will not come up for consideration until later in the spring, allowing the Cheverly Town Council time to adequately consider the initiative.

Cities across America have passed laws allowing residents to raise backyard chickens in an effort to respond to the natural health movement and growing local foods. Cities like; New York, Baltimore, Annapolis New Haven and Stamford have introduced ordinances allowing chickens.

However, it is important that **\*\*IF**\*\* the town council agrees to send a letter supporting this initiative it will be done in a manner that respects neighbors. While we don't expect many residents to own chickens, there must be conditions set upon chicken owners ensuring that chickens are not roaming the streets (as I've heard many say). Regulations set by other communities are:

- No Roosters
- Limit the number of chickens (6)
- Chickens reside in structurally sound coop
- Coops must have setbacks from a neighbors property line
- Coops must have setbacks from neighbors home

Please voice your opinions to your Town Councilmember and to the Mayor as we consider this matter.

**Pepco to offer LED Street Lights:** In 2010 Councilmember Coolen suggested that Cheverly should install some LED streetlights in an effort to save money. When we made the request to Pepco we were told that Pepco did not offer LED as an option. After some discussion and a request through the state legislature Pepco now offers LED streetlights. Congrats to the efforts of Councilwoman Coolen.

**Looking for a New Year's Resolution:** Cheverly is a great community, and what makes it great is residents getting involved to make a difference. 

The next joint meeting of C-PACT (Cheverly – Citizens and Police Together), Cheverly's Neighborhood Watch Organization, & the Cheverly

Watch Resident Radio Program will be held on Wed, January 9, 2013, at 7:00 PM in the Police Conference Room. We will be discussing crime in 2012 and what the police and the community can do to reduce the crime rate even further in 2013.

#### LAST CHANCE TO ENTER SLOGAN CONTEST:

Please take a minute to develop a new slogan that the Department can publicize to reduce thefts in the Cheverly. Much like our slogan "Cheverly is a L.E.W.D. (Lock Every Window and Door) Community" we successfully used to reduce burglaries, we are now looking for a slogan we can use to reduce thefts. Theft is far and away the #1 crime in Cheverly, typically accounting for nearly 50% of all reported Cheverly crime. The slogan contest winner will be announced in a future Newsletter offering and the winner will receive a \$50 gift certificate for their winning slogan.

#### **OVER-THE-COUNTER DRUG AND PRESCRIPTION DROP BOX AT THE STATION –**

The Department maintains a drug drop off box in the station lobby. All Cheverly residents are encouraged to drop off their expired prescription drugs for free disposal rather than depositing these items in the regular trash or flushing unwanted drugs down a toilet. Not only does this service improve our environment, it deters unwanted narcotics and other drugs from falling into the hands of persons for which these drugs were not prescribed.

Residents who wish to drop off expired prescription drugs, unused pharmaceuticals, or over the counter medications, may do so anonymously (no requests for identification will be made) during office hours (M-F, 9:00 AM to 5:00 PM) in the metal drop off box. Please make sure that any personal information (name, address, etc.) is blocked out on any prescription container and that the lids on all liquids are tightly closed.

# TO RECEIVE A TAX BREAK FOR 2012, YOU MUST DONATE YOUR VEHICLE BY 12-31-12:

Your vehicle donations are critical to the ability of the Police Department to maintain its high level of equipment and its access to superior training for the coming year. The advantage of donating your vehicle to the Town, aside from the tax benefit, is that you actually can see your donation dollars at work.

**REPORTING DWI AND DUI VIOLATIONS:** The State of Maryland has recently initiated a new program to reduce drunk driving violations on Maryland highways. The call to action, entitled Report Drunk Drivers, Dial 9-1-1, encourages any person who observes a drunk driver or one they believe to be a drunk driver to immediately dial 9-1-1 and report the violation to police. You do not have to provide your name, just the suspect vehicle identification information and its current location. For information on how to spot a drunk driver, visit www.reportadrunkdriver.com. Reporting this type of crime is critical given that Prince George's County leads the State of Maryland in traffic fatalities (nearly 7 deaths per month). It is also important to remember, especially in Cheverly, that pedestrian deaths occur with the same frequency as those of crash vehicle passengers (nondrivers).

# WINTER WEATHER REMINDERS

### TOWN CODE - Sec. 27-10—Parking

A snow emergency shall exist whenever snow has accumulated on the streets to a depth of one (1) inch or more. The provisions of this subsection shall be effective without any notification and shall remain in effect until the street is plowed; provided, however, that when snow shall accumulate to a depth of one inch or more after 11:00PM, the provisions of this subsection shall not be effective until 7:00AM the day following and shall remain in effect until the street is plowed.

#### PARKING RESTRICTIONS: During a snow emergency no person shall park any vehicle as follows:

- On the cul-de-sac portion of any street,
- On any courts,
- On the even-numbered side of all streets,
- (exception) On the odd-numbered side of 59th Avenue, and one block of Inwood Street between Cheverly Avenue & Belleview Avenue.

**NOTE:** The snow emergency parking restrictions do not override existing no-parking zones or apply to streets where enforcement would disallow all parking because of a no-parking zone, or to streets with any barrier or strip dividing lanes of traffic.

**PRIORITIES:** The snow removal operations work under the following priorities: 1.) Cheverly Avenue 2.) principal connecting streets: Forest Road, Crest Avenue, Valleyway, Greenleaf Road, 62nd Avenue, State Street, Schuster Drive; 3.) all other streets.

**TOWN CODE** Sec. 18-4.1—SIDEWALKS Whenever snow accumulates to a depth of one inch or more, it is the duty of each occupant to clear the snow from the sidewalk adjacent to that property, within 12 hours after the snow ceases, (unless at night, in which case it shall be removed within 12 hours after sunrise). Snow and ice removed from sidewalks shall NOT be deposited on streets or other sidewalks.

When ice forms on sidewalks, occupant shall place sand, ashes or other such material on sidewalks within 6 hours, (unless at night, in which case it can be spread by noon of the next day). Icy spots on public property can be reported to Public Works at **301-773-2666**.

### LEAF COLLECTION PROCEDURES

#### Vacuuming Leaves: Every street in Cheverly is scheduled for at least 2 vacuuming sweeps.

Rake leaves **between** the curb and sidewalk - not on the street or sidewalk.

- Keep leaves free of twigs, branches, metal, concrete and other debris that can jam or damage the equipment.
- Please do not park cars on the street on the assigned collection day
- Be considerate of your neighbors. Only rake to curb when your pick up day is imminent. Raking too early, allows the leaves to blow into your neighbors yard.

**Bag Leaves:** Yard waste is collected on <u>MONDAYS</u>. Put bags at the curb on Sunday evening. Use **CLEAR PLASTIC BAGS** only (sold at Town Hall or Public Works \$5 for 50 bags). Yard waste includes leaves, grass, brush, twigs, etc. Do not put any dirt, rocks, or other trash/debris in these bags. If you have any questions, please call Public Works at 301-773-2666.

### SOLID ANIMAL WASTE ORDINANCE

**Sec. 4-10** (a) It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the mayor and council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, and play areas of all other parks.



# **SAFETY REMINDER:**

We ask residents to remember that your neighbors who walk to Metro, or children walking to school, and the hard working Mail Carriers are exposed to dangerous conditions when sidewalks are

not cleared in a timely manner. Failure to comply with Town Code could result in fines.
