As the Holiday Season approaches we on the Town Council wish every Cheverly resident a very Happy Holiday. Holidays are special here in our little Town and I hope that each of you has the opportunity to participate in some way. The Turkey Trot will have already occurred by the time you read this but there is still more holiday fun for you and your family.

We have the Annual Holiday Concert, Tree Lighting, and Yule Log Celebration scheduled for December 6<sup>th</sup>. This event is followed on Saturday December 7, by the Rec Council Holiday Party and Santa's arrival at Town Hall. ## **Cheverly Purchases More Park Space:**

Recently the Town Council authorized the Town Administrator to purchase the dilapidated home adjacent to Pinky's Park for \$35,000. The Town Administrator is in the process of identifying firms that can deconstruct the home and return the space to park land. This action will increase the size of Pinky's Park. The Town Council is very excited to be able to purchase additional Green Space for the Town

and expand recreational opportunities.

### Seriously, No More Plastic Bags for Yard

**Waste:** Starting January 1<sup>st</sup> the Public Works Department can no longer pick up Yard Waste (Monday) in any type of plastic bag. We are really sorry about this, because the clear plastic bags have been an easy way for Public Works to pick up yard waste. Unfortunately, the county facility where we deposit the yard waste will no longer accept any form of plastic bag.

Our Town Staff is still trying to identify a source of cheap large paper bags, but we have been unable to do so. So starting January 1<sup>st</sup>, please find receptacles to place your yard waste in. Of course you can still deposit leaf piles on the curb for the town to vacuum them on your scheduled day and the Town will still pick up all sticks and debris cut to four foot lengths.

**Free Little Libraries:** Just three months ago I had never heard of a Free Little Library, now Cheverly has its first Private Property Library (word has it that more are on the way) and we are in the process of establishing Free Little Libraries on Public Property.

To visit the Private Yard Library stop by 3201 Crest Avenue. They had a Grand Opening on November 16<sup>th</sup>. The Town Council had been discussing asking some neighborhood craftsmen to build some Free Little Libraries for Town Hall and the apartments.

However, super volunteer Doug Alexander came up with a great solution: repurposed Newspaper Boxes. He has identified six boxes which we hope to deploy after the turn of the year.

Of course, this being Cheverly we would like our Free Little Libraries to be special. Wouldn't it be great if our boxes were painted with Cheverly themes? WSSC Road Repairs: I am frequently asked, "Mike when will WSSC be repairing our roads?" Of course the language is sometimes a little more colorful than that. Again, the Town appreciates your patience as you deal with the choppy streets and navigate the many roadblocks. It really is amazing how much work is happening in our little town between WSSC and the Telephone Pole replacement.

Well the bad news is it looks like spring before the roads will be resurfaced. There are two reasons for this. First WSSC attempts to get the best economies of scale, so they want to batch together as much work as possible. Second, asphalt plants close down in the winter months because the temperature cannot be too cold when laying new asphalt.

## **Washington Post Gives Cheverly Some**

**Love:** Last year our residents voted Cheverly the #1 Community in the Washington DC area. That was a lot of fun, and a great distinction. So the question was, how do we follow that up?

Well check out the November 16<sup>th</sup> Washington Post. Cheverly was featured in the "Where We Live" column in the Real Estate Section. It was a great article featuring many of our neighbors explaining why they chose to live here. What a great way to end the year. If you didn't see the article, you can look it up on the Washington Post web site.

**Dangerous Weapons Legislation:** This topic has appeared frequently in my FYI's this year and has also been a frequent item on the Town Council's agenda. To recap briefly; Cheverly's Dangerous Weapons Laws were out of sync with those of the State of Maryland. Our laws were much more restrictive than the State Of Maryland allows. Since Cheverly's authority to author dangerous weapons laws originates from the state, our laws were unenforceable. Furthermore, our Police Department had never used Cheverly's Laws (enacted in 1976) and instead

used the State of Maryland Laws. Therefore, the Town Council enacted legislation this year eliminating the existing Cheverly Dangerous Weapon Laws.

However, Maryland State Law does allow the Town to enact legislation that dictates the use of weapons on Town Properties. Therefore, the Town Council has introduced legislation that bans weapons from being carried into Town Buildings and Town Parks. This legislation was introduced during the November Town Meeting, and will be discussed in the December and January meetings.

**Audit:** Oh My Gosh, it's that time of year again. Independent Auditors have just completed the annual audit of the town for the Fiscal Year that ended on June 30<sup>th</sup> of 2013. This Audit will officially close the books on FY13, and will reconfirm the Financial Position of the Town as we entered the Fiscal Year 2014.

When the Town Council reviews the audit, it will kick off the process for Fiscal Year 2015 planning. So look forward to the January Newsletter, when we officially start the budget process.



# DID YOU KNOW THAT THE CHEVERLY POLICE DEPART. WILL DISPOSE OF, FREE OF CHARGE, THE FOLLOWING:

- 1. All unwanted firearms, magazines, ammunition, or other weapons. Please call the station first to ensure a police officer is available to receive the unloaded weapon. In cases where a resident is unable or unwilling to unload any firearm, please call the station and an officer will be dispatched to take the weapon. This applies to all handguns, rifles, shotguns, BB or pellet guns, or any other dangerous weapon. It is the policy of the Department that all such weapons will be utilized by the Department or destroyed, and not traded in for discounted law enforcement weapons or purchases.
- 2. All unwanted prescription medicines with the exception of syringes. The station maintains a prescription medicine container in the lobby and residents may utilize this service unattended. Please cross out any names or addresses on the prescription container and ensure all lids are tightly fastened. All such medicines are destroyed.
- 3. All controlled dangerous substances (marijuana, cocaine, etc.). Resident who find such substances are encouraged to call the station first to ensure a police officer is available to receive the substance. In cases where a resident is unable or unwilling to collect the substance, please call the station and an officer will be dispatched to take such substances. Confidentiality will always be employed in these circumstances. Again, all such substances will be destroyed.
- 4. Other found property. The Department makes an attempt to identify the owner of all found or recovered property. All unclaimed property is auctioned or sold, if possible, with the funds used to purchase police equipment.

REMINDER...REMINDER...REMINDER: It is illegal in the State of Maryland to handle any cellular telephone or similar device or use any such device to send or receive text or instant messages while operating a motor vehicle on the traveled portion of the roadway. There is an exception of emergency police or fire telephone calls. These laws do not apply to law enforcement officers, however, the Department has attempted to purchase hands-free cellular systems for all of its vehicles or request that officers pull over to the shoulder of the road during such use. It is also illegal to use earphones or similar devices in both ears at the same time while operating a motor vehicle.

NEW POLICE VEHICLES: The Department recently purchased two 2013 Ford Explorer all-wheel drive police vehicles. These vehicles were specifically engineered for law enforcement use and utilize fuel efficient engines. One of these purchases was purchased through the normal budget process and the other was purchased from funds derived by donated vehicles. This purchase is just another reason to donate your used or unwanted vehicle to the Town for a full tax credit and just another way you can see your donation dollars in use around the Town.

### MARYLAND'S CELL PHONE LAW

Maryland MVA Offers Faces on New Cell Phone and Seat Belt Laws.

Maryland's Cell Phone Use Ban (TR21-1124.2)

#### (Note: These laws apply to handheld cell phones only)

- Effective Oct.1, 2013. Maryland's cell phone law now prohibits a driver from using a cell phone while a motor vehicle is in motion.
- Law enforcement officers can stop a driver solely for using a cell phone no other offense is needed.
- Drivers will receive a fine of up to:

\$75 - first offense

\$125 - second offense

\$175 - third & subsequent offense

Nationally, 80% of vehicle crashes involve some sort of driver inattention.

On average, more than 30,000 people in Maryland are injured annually as a result of distracted driving crashes.

### MARYLAND'S SEAT BELT LAW

Effective October 1, 2013, Maryland has a primary seat belt law for front seat occupants AND a secondary seat belt law for back seat occupants.

- Tickets can be issued to drivers and front seat passengers even if no other violations is observed.
- Each person that is not buckled up (driver and passenger) may receive a ticket of up to \$50 for not wearing a seatbelt.
- In the case where any passenger under the age of 16 years of age is not buckled up, the driver will receive a ticket for each offense. For instance, if a driver is stopped and not wearing a seal belt, and a passenger under the age of 16 is also not restrained, the driver will receive a \$50 adult seat belt ticket for himself and a 50 ticket for the passenger.
- Seat belts save lives. Motorists are 75% less likely to be killed in a rollover crash if they are buckled up.
- For the period 2007-2011, 68,151 backseat occupants of passenger vehicles were involved in a reported crash in Maryland. Of these, there were 127 fatalities, 75% of which were reported to be unbelted. Additionally, there were 6,243 occupants who sustained a moderate or sever injury. Those who were reported as unbelted were 67% more likely to sustain a moderate to fatal injury.
- Belted drivers were 50% more likely to sustain a moderate to fatal injury as a result of a motor vehicle crash when the occupant seated directly behind them was unbelted as compared to drivers who were seated in front of a belted occupant.

### WINTER WEATHER REMINDERS

TOWN CODE - Sec. 27-10—Parking

A snow emergency shall exist whenever snow has accumulated on the streets to a depth of one (1) inch or more. The provisions of this subsection shall be effective without any notification and shall remain in effect until the street is plowed; provided, however, that when snow shall accumulate to a depth of one inch or more after 11:00PM, the provisions of this subsection shall not be effective until 7:00AM the day following and shall remain in effect until the street is plowed.

# PARKING RESTRICTIONS: During a snow emergency no person shall park any vehicle as follows:

- On the cul-de-sac portion of any street,
- On any courts,
- On the even-numbered side of all streets,
- **(exception)** On the odd-numbered side of 59th Avenue, and one block of Inwood Street between Cheverly Avenue & Belleview Avenue.

<u>NOTE</u>: The snow emergency parking restrictions do not override existing no-parking zones or apply to streets where enforcement would disallow all parking because of a no-parking zone, or to streets with any barrier or strip dividing lanes of traffic.


**PRIORITIES:** The snow removal operations work under the following priorities: 1.) Cheverly Avenue 2.) principal connecting streets: Forest Road, Crest Avenue, Valleyway, Greenleaf Road, 62nd Avenue, State Street, Schuster Drive; 3.) all other streets.

#### TOWN CODE Sec. 18-4.1—SIDEWALKS

Whenever snow accumulates to a depth of one inch or more, it is the duty of each occupant to clear the snow from the sidewalk adjacent to that property, within 12 hours after the snow ceases, (unless at night, in which case it shall be removed within 12 hours after sunrise). Snow and ice removed from sidewalks shall NOT be deposited on streets or other sidewalks.

When ice forms on sidewalks, occupant shall place sand, ashes or other such material on sidewalks within 6 hours, (unless at night, in which case it can be spread by noon of the next day). Icy spots on public property can be reported to Public Works at 301-773-2666.

# **SAFETY REMINDER:**



sidewalks are not cleared in a timely manner. Failure to comply with Town Code could result in fines.

#### GREEN @ HOME - Birds in Winter

It's time to think about keeping your yard bird-friendly through the winter. Finding food can be especially challenging for birds during days with extreme cold temperatures. Setting up a backyard bird feeder makes their lives easier and ours more enjoyable as we can observe the birds up close and in comfort. Take a look at your property from a bird's perspective. Does it provide the three basic things that all birds need from their habitats?

- FOOD: In winter, set up your bird feeder. If you don't tidy up your yard and flowerbeds in fall, birds will love you for the seeds. Rake fallen leaves under your shrubs to act as mulch -- that encourages beneficial insects which will be bird food. Throughout the year your bird-friendly landscaping will provide fruit, seeds, beneficial insects, and other small animals that birds feed upon.
- WATER: Even in winter, birds need water for drinking and bathing.
- SHELTER: Whether it's a safe place for sleeping, a protected haven from the elements, a hiding place to elude predators, or a secure nesting spot, providing shelter is an important way to make your property bird-friendly. Leave dead limbs and trees in place. Recycle dead branches to start a brush pile; add your old Christmas tree if you have one.



# LEAF COLLECTION PROCEDURES

Vacuuming Leaves: Every street in Cheverly is scheduled for at least 2 vacuuming sweeps.



Rake leaves **between** the curb and sidewalk - not on the street or sidewalk.

- Keep leaves free of twigs, branches, metal, concrete and other debris that can jam or damage the equipment.
- Please do not park cars on the street on the assigned collection day
- Be considerate of your neighbors. Only rake to curb when your pick up day is imminent. Raking too early, allows the leaves to blow into your neighbors yard.

**Bag Leaves:** Yard waste is collected on <u>MONDAYS</u>. Put bags at the curb on Sunday evening. Use CLEAR PLASTIC BAGS only (sold at Town Hall or Public Works \$5 for 50 bags). Paper Bags only beginning 1/1/14 Yard waste includes leaves, grass, brush, twigs, etc. Do not put any dirt, rocks, or other trash/debris in these bags.
