What A Great Place to Live: As most of you know I have chosen not to run again for Mayor in the upcoming May Elections. I must admit, I have truly enjoyed the last nine years working with and meeting so many wonderful folks in our community. I will miss being Mayor, but will continue to stay involved in our many great organizations.

I have said many times that while we have a great Town Council and Town Staff, they are not what makes Cheverly a great community. It is the people, organizations and volunteers that make this a great community.

I am frequently told what a beautiful place Cheverly is by visitors who have never been here. While this is true, I always reply that the real magic of Cheverly is in the people. My favorite description of Cheverly is "it doesn't matter what your family looks like or believes, there is always another family that looks like yours in our community". I wish I could remember who said this to me, but I find it a great description of our community.

**The More Things Change:** A lot has happened since I last wrote an FYI. Our Public Works Director announced his retirement, a search for a new Town Administrator has been officially launched, Dana Hallman has been appointed to the Ward 2 council seat, and Maurielle Stewart has decided to resign from Town Council effective March 1st.

That is a lot of change in a short time, and it is compounded by the recent retirements of our former Town Administrator and Police Chief as well as the upcoming elections. I've talked to some residents who express concern about all of this change occurring at once. While I agree this seems like a lot I am extremely confident in the future.

We have been extremely fortunate to have David Deutsch step in as interim Town Administrator to help us through the transition. David's years of experience as a Town Administrator in several towns in Maryland has been a tremendous asset for Cheverly. David is handling day to day affairs with the assistance of his staff, conducting the search for a new Town Administrator and Public Works Director, and assisting Town Council on organizational issues. His work has been much appreciated.

While some may see the change as chaotic, and it may be at times, a better way to look at this is as an opportunity to take a fresh approach and bring in fresh ideas. As long as residents stay involved in the process, take an active role in committees and town elections and continue to volunteer as we have always done in the past this will be a good evolution.

New administrative leadership and a new Council gives the town the opportunity to revitalize, reinvigorate and move forward. I am a tad disappointed to not be a part of all this change, but I am sure Cheverly will be even stronger in the future.

Ward 2 Vacancy Filled: In the February 14<sup>th</sup> Town Meeting the Town Council unanimously voted to seat Ms. Dana Hallman as the Ward 2 representative for the remainder of former Councilmember Ivey's term. At the end of his address, Mr. Micah Watson withdrew his application, but stated that he intended to continue to campaign for the seat in May elections.

Newly minted Councilmember Hallman was immediately seated and was actively involved in the remainder of the February 14th meeting.

**Councilmember Stewart Announces Resignation**: During the February 14th Town Meeting, Councilwoman Stewart announced that she was resigning her office of Ward 4 Councilperson, effective March 1st. Councilwoman Stewart gave a very moving speech regarding her resignation. Following a very moving speech by Councilmember Stewart, her fellow council members expressed their appreciation for her outstanding efforts while on Council and wished her well in the future.

Councilmember Stewart has always been a valued member of Council and her counsel on town matters has always been highly regarded. Her constituent services efforts on the behalf of her residents were always very focused. I will very much miss her advice and guidance.

Ward 4 Council Seat Vacancy: Cheverly's Charter calls for a vacant council seat to be filled, no matter how close to an upcoming election. While this does not happen frequently, it has now happened twice in a year. Future Councils should address this Charter deficiency.

**Public Works Director Retires:** After serving as Cheverly's Public Works Director since 1989, Juan L. Torres has submitted his retirement notice. His last day will be April 23, 2019. The Mayor and Council are extremely grateful to Juan for the many contributions he made to the quality of life in our Town. Juan leads a team of dedicated men and women who provide top notch service to our residents. You can see the impact of Juan's work throughout the Town as you travel our roads, enjoy the parks, and participate in community events.

On a personal note, I'd like to thank Juan for his commitment to Cheverly. While Juan lives in Takoma Park, he was vested in Cheverly. Juan always cared about Cheverly's infrastructure, but he also cared deeply about the people who lived here and wanted to provide the best services possible. Juan has chosen to retire to turn his focus and considerable skills to his beloved home of Puerto Rico. I know from my experience that Puerto Rico will benefit from Juan's efforts. Juan plans to attend Cheverly Day on May 18th, where he looks forward to saying goodbye to everyone in the community.

**The Budget is Coming, The Budget is Coming:** Well folks, February is the time of year when I start addressing the upcoming budget. I am very happy to say that once again the Town is in excellent financial condition as we finished FY18 with a fund balance of approximately three million dollars.

As always, I must mention that good accounting principles require the town to have a minimum of 25% of annual operating expenses in the fund balance.

Therefore, approximately one million of the three million dollar fund balance is spoken for. However, I must congratulate this Council, previous Councils and town staff for building the fund balance from approximately 650K in 2007 to today's three million dollar fund balance.

This was accomplished by adhering to a series of three year plans that are centered around the property tax assessments. Last year, was year one. If you recall property tax assessments rose significantly. In response the Town Council lowered the town tax rate from .54 to .51 cents. This action kept resident's overall tax bills stable, or maybe even slightly reduced. This also meant that town revenues from property tax remained stable.

During last year's discussions the Town Council planned on keeping the Tax Rate stable this year at .51, the result of which is that resident's tax bills will increase based on the increased assessments.

Obviously, as we build the FY19 Budget we will review this assumption in light of revenues, expenses and capital expenditures. Stay tuned as these discussions continue.

Air Quality Monitoring Update: In their February 14th Town Council Meeting the Council approved expenditures to begin the Air Quality Monitoring Program for Cheverly. We will now begin the process of working with the University of Maryland to determine specific sites where sensors will be deployed.

**Governor Hogan's Transportation Program:** As I've discussed previously in the newsletter I have been working with the Mayors of Landover Hills, Bladensburg, Riverdale Park, University Park, College Park, Greenbelt, New Carrollton and Laurel to advocate against Governor Hogan's Plan to implement a Maglev Train, expand I-495 and I-270 by installing "Lexus Lanes" and possibly to take control of the BW Parkway and expanding it with toll lanes as well.

My concerns, and those of the Town Council, originate from the continued discussions to expand the BW Parkway. However, as I met with the Mayors of other communities it was clear that each of our communities was being impacted by the Governor's program without any real communication or coordination.

As I've spent more time talking with congressional, state and county leaders I've become more concerned about financial basis for the transportation program. Our state simply does not have the funds to do this expansion themselves, and is unwilling to fund expansion through highway bonds or a gas tax increase. From the administration's perspective, this is a positive. They tout the fact that this will not cost the taxpayer any money, because they are entering into a Public Private Partnership (P3). Of course, as our Moms told us nothing is free, especially a highway. P3s will recoup the funds via tolls and there will be little governmental control over their administration.

The theory is simple, users of the toll lanes are paying for the expansion and as people use the toll lanes traffic in the free lanes will improve. Great theory, however, Virginia's experience is that traffic in the free lanes remains the same. I readily admit that this is my view, and that of my fellow mayors. I am simply bringing this to your attention is that this program is rolling forward and the time to pay attention and weigh in is NOW!

We will be hosting Maryland Department of Transportation (MDOT) at the Town Hall on March 14th at 6:30PM. They will be providing an update on the program and be available to answer questions.

**Small Cell Technology (5G Service):** I have been honored to serve as the Chair of the Maryland Municipal League's Legislative Committee this year. MML has decided "opposition to the preemption of local authority in the installation of small cell technology" was their legislative priority this year. I know, most of you are thinking what the heck does that mean. So let's have a special edition of Hey Mike.

Hey Mike, why would MML or Cheverly care about the deployment of 5G technology? Great question, and this was

exactly my opinion. However, while the world is very excited about what types of services may become available with 5G technology, no one is paying attention to the required infrastructure to deliver it. In my opinion, 5G will be the most distributed (and impactful) infrastructure since electricity. Small Cell technology requires a 50 foot pole, every 150 feet. Worse yet, each pole requires a 27 cubic foot box (think refrigerator size) at every pole. While some of these details may change, this is what the industry has stated.

Hey Mike, You can't be serious they might be a refrigerator sized box next to my existing telephone pole without my permission? This might be my shortest answer ever. YES!

*Hey Mike, what about my yard; all of my services are underground?* Obviously wireless signals do not travel underground, so in areas that do not currently have telephone poles, wireless poles will be installed with 27 cubic foot boxes.

*Hey Mike, what is MML trying to do?* MML is trying to influence state level legislation asking that 5G carriers have to work with municipalities to identify the best possible implementation. Carriers are trying to pass legislation that will limit local authority and allow them more say in how the technology is deployed.

Hey Mike, Can we simply prevent 5G carriers from coming into Cheverly? No, the FCC has passed regulations that prevent any local authority from denying service. I have had many citizens ask about this, and the answer is simply No!

Hey Mike, When is Cheverly targeted for Small Cell or 5G service? Small Cell technology has already been implemented in portions of Baltimore, Westminster and Ocean City. Next time you walk the boardwalk in Ocean City, try to identify the implementation. You simply can't see it because of the teamwork between Ocean City and carriers. The poles replaced existing light poles and the boxes have been buried. So, it is possible to have tasteful implementations, as long as the locality retains some authority.

#### SOLID ANIMAL WASTE ORDINANCE

**Sec. 4-10** (a) It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, & play areas of all other parks.

#### PLEASE USE THE SIDEWALKS, IT IS THE LAW!

As the weather begins to get nicer and more and more residents are walking or jogging in town, we are taking this opportunity to remind you that it is illegal to walk or job in the street when a sidewalk is available on a road. The State law reads:

#### 21-506 Rules for pedestrians on roadways

- (a) Where a sidewalk is provided, a pedestrian may not walk along and or an adjacent roadway.
- (b) Where a sidewalk is provided, a pedestrian who walks along and on a highway may walk only on the left shoulder, if practicable, or on the left side of the roadway, as near as practicable to the edge of the roadway, facing any traffic that might approach from the opposite direction.

The Cheverly Police have been receiving numerous complaints from residents fearing that they are going to hit a pedestrian or jogger as a result of those individuals not walking on the sidewalk.

We want all our pedestrians and motorists to be safe. So, please use the sidewalks. Not adhering to the above noted law may result in a fine being issued.



Message from the Acting Chief Jarod J. Towers (policechief@cheverly-md.gov)

#### DID YOU KNOW... That it is illegal for a pedestrian to cross a roadway in the direction of a solid "Don't Walk" or an upraised hand signal???

Over the last several weeks, you may have noticed officers at the intersection of Cheverly Avenue and Columbia Park Road, enforcing pedestrian safety laws and issuing citations to any vehicle which failed to yield to the right of way of pedestrians in crosswalks, and other pedestrian related violations.

In conducting this enforcement, it was identified that vehicles are not the violators. Please obey all pedestrian traffic signals, it is for your own safety. Over the next few weeks, officers will begin to issue notices to pedestrians who violate these laws.

#### **Criminal Investigative Division:**

In just four weeks, Detective Kvech has completed several applicant background investigations and handled several criminal investigations. After just two weeks in his new role, Det. Kvech was assigned his first robbery case. Dedicated days of witness interviews and surveillance video scouring landed Det. Kvech his first closed case. He was able to identify the suspect in the case and obtain an arrest warrant for the subject, which has been sent to the Prince George's County Sheriff's Office.

Additionally, Det. Kvech was assigned a sexual assault case that involved a male who exposed himself publicly and touched/assaulted a female with his genitals. Victim and witness interviews, in addition to surveillance videos, led to the procurement of a photo of the suspect. Requests to the public for assistance followed shortly thereafter. Thanks to many residents who stepped forward, the suspect was identified and Det. Kvech obtained an arrest warrant for a fourthdegree sex offense, indecent exposure, and disorderly conduct.

#### March Enforcement of the Month:

Avoid the fine by obeying the sign! For the month of

March, officers will be focusing on enforcing stop sign laws. Too often we get calls and emails from citizens about motorists running stop signs. Be sure to come to a complete stop and look twice to ensure there are no pedestrians, bicyclists, or oncoming vehicles.

#### Coffee with the Chief (UPDATE):

This event has been expanded to better accommodate residents who cannot, or rather not, attend at 7am. Effective in the month of March, Coffee with the Chief will be held every third Monday, from 4pm to 6pm, and every third Wednesday, from 7am to 9am. In March, these events will be held on Monday, March 18<sup>th</sup> and Wednesday, March 20<sup>th</sup>. Please stop in, have a cup of coffee, voice your concerns, ask questions, or just come meet me and your police officers. We are eager to meet you!



#### WHO WE ARE

The American Legion is a 501 (c) 19 Not for Profit, Community Based, Non-Partisan, Patriotic, Veterans Service Organization that was founded in March of 1919 and Chartered by the United States Congress in September of 1919. We are comprised of some 13,000 American Legion Posts located in all 50 States, the District of Columbia, France, Mexico, the Philippines and Puerto Rico.

In The American Legion, Department of Maryland we have a total of 137 active American Legion Posts located within each of the 23 Counties and in Baltimore City, with a Post presence in virtually every community of the State. We are by far the largest veteran's service organization in Maryland.




## Spring flea market

Imagine you are a Cheverly Village member with mobility issues. A trained Village volunteer is walking you toward his car, which is a few spaces up the street. Imagine you slip on the uneven ground next to the sidewalk and fall. You are okay but decide to skip the appointment. The volunteer helps you back inside, cancels your appointment, and reports details to the Coordinator at Cheverly Village.

Imagine that the fall leads you and your spouse to brainstorm about how to ensure your wellbeing, and she tells you that a designated Handicapped Parking (HP) place in front of your house would likely have prevented the fall. Imagine also that, in responding to a Cheverly Village message inquiring about you, she tells the Village she has obtained a form to request a HP space.

Then imagine that your spouse—always needing to provide essential support to you and the family—has found it hard to find the time to sort out the details to get the HP designation. Cheverly Village again checks in with her and offers her contact information for key people on Town staff and Council. The Village's concern spreads further to bring the issue to the attention of the Town. Imagine that you welcome the harmonious coordination and resource sharing among your family,

Cheverly Village, and the Town. All this sounds good to you, except that...*you hate signs*! While you want a safe parking spot in front of your house, you also value a beautiful Cheverly.

Freed from the stress about falling, you think big. Inspired by First Lady Ladybird Johnson's 1960s opposition to excess signage, you offer a challenge to the Village and the Town: Are there effective alternatives to signs? Things like painting the curb blue? You point out that, with other Cheverly residents enjoying aging in place at home, it may make sense to "take the time to get this pilot project right."

You also share your warmth and wit: "I think the issue will be arising more in the near future, given the good work establishing the Cheverly Village. Almost everyone becomes disabled if you live long enough!" You are the inspiring Cheverly Village member, Jeff Bridgers.




## **Daylight Savings Reminder!!**
