**No Poop in the Park:** Oh how I hate to dedicate valuable FYI space to Dog Poop, but it has to be done. Many dog owners bring their pets to our town parks early in the morning or late at night to let them run and get exercise. This makes sense to me. However, your pet must be on a leash and cannot run loose and just because your pet is in the park doesn't mean that you don't have to pick up after them.

Cheverly Children play in our parks, and I have recently received a number of comments regarding children dodging poop as they were playing soccer.

This is unacceptable. So please pick up after your pets everywhere in town, especially in our parks.

Also please note that pets are not allowed in **GAST PARK** at any time.

**Did I Actually Use Dog and Park in the Same Sentence?** By gosh, I'm pretty sure I did. With budget season coming up, this is a great time to gather interested residents to discuss the construction and operation of a Dog Park. Last summer a group of 20 residents met to discuss how we might construct and operate a dog park in town. Unfortunately, the effort didn't sustain itself.

I'd like to get interested residents together on March 21<sup>st</sup> at 7:30PM at Town Hall to discuss what would be required to establish a community organization that would assist in the operation of a dog park here in Cheverly. The actual question of "where is the dog park going to be located?" is still a question that needs to be answered. That will be a topic of conversation as well. The Town Council hopes to get a core group of Dog Owners interested in this venture to assist in the organization and management of the park

» Any qualified voter

**How do I get an absentee ballot?** You must apply for an absentee ballot, in writing, prior to seven days before election. You can obtain an Application from the Town Office. Call 301-773-8360, write to 6401 Forest Road, Cheverly, MD 20785, or come in to the Town Office. When the Cheverly Election Board processes your application and you are determined to be qualified, an absentee ballot will be mailed to you.

**EMERGENCY ABSENTEE BALLOT**

**Who may apply for an absentee ballot after the deadline?**

- » Any qualified voter who is informed within 7 days prior to the election that, as a condition of employment, the voter is required to be absent from Cheverly;
- » Any qualified voter who is unable to be physically present at the polls as a result of illness or accident occurring within 7 days prior to the election;
- » Any qualified voter who is unable to be present because of a death or serious illness in the immediate family occurring within 7 days of the election.

**Saint Patty's Day Clean the Stream:** On March 17<sup>th</sup> at Boyd Park over 400 college students from Wisconsin, the Dakota's, Montana and other points west, will be stopping by Boyd Park to clean Little Beaverdam Creek. Believe it or not, this has become an annual pilgrimage for college students on their spring break. They typically arrive between 8:30 and 9:00AM, whoop it up in the park for 30 minutes to warm up, clean the stream until noon and then eat pizza.

They remove tons of trash, tires, shopping carts, and many other items that simply don't belong in a stream. Please come by and join the fun and bring your waders.

**Special Blizzard edition of "Hey Mike":**  
**Hey Mike, exactly where were you during the blizzard?**  
Oops, caught me. I was in Palm Harbor Florida visiting mom. Who by the way sends her regards. Cancelled flights made it impossible to get home.

**Hey Mike, who the heck shoveled your walk?** You guessed it. Peg was quite a trooper and managed to clean the driveway and sidewalk.

**Hey Mike, what's with the plows?** I've heard from some in the community that our plows were unprepared and that's why we had maintenance issues. Let's be clear, the Town is prepared for normal and above average snow storms, but 24 inch storms are out of the norm. Four of our plows are Ford F-450's, which are the standard town trucks that are outfitted with plows in the winter. These vehicles are simply not designed to move that much snow.

**Hey Mike, why didn't the town go curb to curb after the snow?** Again, managing 24 inches of snow is significantly different than 8 to 12 inches. Simply finding places to put the snow becomes complicated. Two issues that Public Works dealt with were: 1) residents who shoveled their cars out but placed the shoveled snow in the road, 2) residents who were concerned about the number of times their driveways would be plowed in. Public Works could not clear the snow shoveled into the road without potentially damaging the cars parked next to the snow piles and they made the decision to not continuously plow in driveways given the upcoming weather.

**Blizzard Shout Outs:** Cheverly is an amazing town and I am continually amazed at how Cheverlians jump in and lend a hand.

**Public Works:** Our team worked for 72 hours straight clearing the streets and did an outstanding job. There were many reports of Public Works helping folks in the community. My favorite is how they rallied to get an ambulance unstuck, to get a resident to the hospital.

**Police Department:** The Cheverly Police also camped in during the storm. They took the opportunity to call many of our Senior Citizens to ensure they were okay. If you'd like to be added to their call list please contact the Police Department.

**Warming Center:** Thankfully we never had to "start up" a warming center because our power stayed on. However, I want to thank those residents that Councilmember Eldridge and I reached out to. Members of the Cheverly United Methodist Church, the American Legion, the Town Council, Saint Ambrose Church and even Prince George's Hospital were all willing to assist if we needed to establish a "warming center".

**Cheverly Cooks:** To all the wonderful people who volunteered to cook for our Public Works employees, what a wonderful show of support. Having lived up north for most of my young life, I have never seen a community rally in this way.

Lastly, a nod to PEPCO. While we will continue to work with them to minimize the impact of tree removals and pruning their three year program of pole and wire replacements, redundancy upgrades and tree trimming had a remarkable result across the region.

**Snow / Public Sidewalks / Budget Adjustment:** As you all know Cheverly's Snow emergency policy requires that all sidewalks must be cleared within 12 hours after the snow stops falling. While every citizen is responsible for their sidewalk, the town is responsible for all of the sidewalks that abut Public Property. This is a significant effort that requires a tremendous amount of physical labor and many man hours.

Furthermore, Cheverly residents have requested that the town clear state and county sidewalks as well, since neither the state nor county clear their sidewalks. Residents frequently complain about the conditions on the Columbia Park Bridge, Landover Road and Columbia Park Road. These are all state or county roads.

Town Staff do eventually clear these sidewalks, but only after our own sidewalks abutting Public Property are clear. In a significant storm, this can take days. In an effort to help town staff clear our public sidewalks AND those of the state and county faster, the Town Council passed a budget adjustment of \$40,000 to buy the appropriate equipment to clear sidewalks. Purchasing a bobcat will eliminate much of the manual labor and allow Public Works to address these critical pedestrian areas sooner.

**Cheverly Avenue Construction / WSSC / One Million Dollars:** It seems like Cheverly Ave has been under construction forever, doesn't it? Unfortunately, we are still a ways from completion. The project started last summer and will continue to early fall. We understand that this construction is inconvenient in many ways: traffic jams on Cheverly Ave, cars speeding on side roads to avoid traffic, bumpy rides, water shut downs and of course the occasional brown water. The Town Council and I appreciate your patience with this construction, and please know that these upgrades are needed.

More importantly, please know that when the project is complete and Cheverly Ave is re-paved at WSSC's expense the Town of Cheverly and its taxpayers will have saved around one million dollars. That's right, re-paving Cheverly Ave cost around one million dollars. So when you're sitting in a traffic jam, please remember that we are not only getting desperately needed new infrastructure but also a newly paved Cheverly Ave - free of charge.

**Hojo's Becomes a Wyndham:** The owners of the Howard Johnson's on Route 202 are completing a five million dollar renovation of the hotel which should be complete in the April / May timeframe. When complete, the hotel will be rebranded as a Wyndham Garden Inn.

I recently visited with the management and they indicated that the renovation included: a vastly expanded lobby, a modified exterior, renovation of every room, a small bar and bistro for customers, and an outdoor patio. When complete they will have 40 corporate suites.

This is pretty exciting news to have a quality hotel in our community. The existing Howard Johnson's has been a good neighbor, and provides over \$60,000 in occupancy fees to our annual budget. I anticipate the new Wyndham to be even a better neighbor.

**Cheverly Small Grants Program:** One budget item that I continually mean to promote, that always slips my mind, is the small grants program. The Town Council established this program five years ago as a means to regulate requests made by community organizations for support. Instead of considering every request as a "one off item" with no guidelines the Small Grant program provides clear guidelines as to who can receive grants and how much they can be for. The Small Grants program has been funded between \$8,000 and \$10,000 each year. Established community organizations can request a grant of up to 20% of the total funding. The purpose of the grant must be for something positive for Cheverly. Over the years grants have been made to: Friends of Little Beaverdam Creek, the Boys and Girls Club, Vine Corps, the Food Truck Festival and many others. We will be continuing this program in the next fiscal year.

**Did He Mention the Budget?** Yup! It's that time, and by now I've usually inundated you with lots of background info to help you fall asleep at night. If you are feeling the need, please go online and read old February and March Newsletters from 2013 and 2014 as they have lots of details on budget categories and expenditures.

The good news for this year is that we are on a very stable financial track. In past years due to dropping assessment levels we had to raise the tax rate to 58 cents just to keep tax revenues (and your tax bill) flat. Last year when assessments increased by 10% we left the tax rate at 58 cents which in effect raised taxes by 10%. This was the first increase in tax revenues the town had in over 6 years. There is little chance the tax rate will increase this year and the council will review opportunities to potentially decrease the tax rate.

As the budget season progresses we will keep you informed each step of the way. The Town Administrator will provide the council with a draft budget in late March / early April for our consideration during April and May. The Council will be reviewing the budget during April and May and the budget will be passed in June.

Please forward any comments about the budget to the Mayor and your council person.

**New Home For Public Works :** One item that will be a high priority for the Town Council during the budget deliberations will be setting aside money to begin the design of a new Public Works building. Our Public Works building is very old, susceptible to flooding and really does not have the facilities for people who are sometimes working 48 hours straight. While we would like to replace the current building as soon as possible, we need to first develop a blueprint for the future building. I am sure you will all agree that this is an important expenditure of funds.

**PARADE, PARADE, PARADE:** Cheverly Day is May 21<sup>st</sup>, be there! I hope everyone is working on their float, marching band, dance unit, or whatever. Parades only come every five years and we need to make them special so that our children remember them forever. So gather friends and organizations, put your thinking caps on and have some fun.

**6301 Kilmer Street:** There is no significant update on this property. The Town Council has requested an assessment of:

- ◇ What needs to be done to simply open the lot to the public, for passive use? There are insurance risks on the property that need remediation prior to unlocking the gate.
- ◇ What would it cost to have the house be useful to fulfill community meeting needs?

These questions drive what will be the next steps for the property. The Town has hired an architect who is currently in the process of completing this evaluation and we hope to have a report during the February 25<sup>th</sup> worksession.

In the meantime, two Cheverly stalwarts David Kneipp and Sheila Salo invited an archeologist from the Historic Preservation Commission to visit the site and assist in determining the age of the "well" on the property. The "well" dates back to the 1920's and was first used for farming a ten acre lot which was owned by relatives of the Magruder family. The 10 acre farm has been parceled up, one piece of which is where Gladys Noon Spellman is today.

**Why Did the Council Buy 6301 Kilmer?** The Town Council primarily purchased this property so that we could control the future use of the land. We agreed that you simply can't find a 1.3 acre lot inside the beltway for this price and that others may have purchased the land for the purpose of over developing. Infill development in town is frequently controversial and creates issues with existing neighbors.

Most of the residents I spoke with seemed pleased with this decision; however I also get some occasional negative feedback. I agree that those who say that any expenditure of \$300,000 is significant and requires thoughtful consideration. For example, it took us many years to purchase a trash truck that cost about the same amount. This purchase was no different.

I frequently try to come up with a metric to help folks understand better what the cost was to them. So here it is: for a resident in a single family home with an average property assessment of \$300,000 the purchase cost you approximately \$125. This is a onetime cost and does not repeat yearly.

**CRIME OF THE YEAR:** You may have noticed if you read the Newsletter regularly that the type of crime most frequently reported in the crime report is theft. The crime of theft always accounts for more than 50% of the reported monthly crime in the Town, sometimes running as high as 90%. In addition to these percentages, there are a number of other common factors that are attributable to theft in the Town:

1. The crime of theft is almost always committed under the cover of darkness.
2. Theft from auto is the #1 form of theft.
3. Most vandalism to autos is usually the result of an attempted theft and is what generally drives up the cost associated with this crime.
4. As much as 1/2 of the number of actual thefts goes unreported
5. In more than half of the thefts from auto, no force was used to enter the vehicle.
6. In more than half of the attempted thefts from auto, nothing of value was removed.
7. Most importantly, 3 out of every 4 thefts from auto could be avoided if simple deterrence measures were employed by vehicle owners.

#### **Simple Deterrence Measures to Prevent Theft From Auto**

1. Park in a lighted location whenever possible, preferably a driveway.
2. Lock all vehicle doors. Most thieves walk through the Town looking for unlocked vehicles to plunder; thieves generally use forceful entry as a last resort.
3. Hide or remove all items of value when a vehicle is left unattended. As noted just above, forced entry is promoted when the thief sees something of value from outside of the vehicle.

#### **What Can You Do?**

1. Follow the deterrence measures outlined above.
2. Keep bicycles inside the house or stored in the backyard.
3. Keep all outside sheds or similar structures locked.
4. Call the nighttime cellular police telephone (301-789-5090) if you see someone suspicious walking through your neighborhood, especially at night.

**PEDESTRIAN RIGHT OF WAY** – A question that I am frequently asked about, concerns right of way privileges between pedestrians and vehicular traffic at a crosswalk. While it would seem easy to conclude that a pedestrian should receive right of way honors in most situations, Maryland law really puts obligations on both the pedestrian and vehicle operators at crosswalk encounters. According to Maryland Transportation Article, 21-502 (a) (2), The driver of a vehicle shall come to a stop when a pedestrian crossing the roadway in a crosswalk is: on the half of the roadway on which the vehicle is traveling, or approaching from an adjacent lane on the other half of the roadway.

In addition, 21-502 (b) states: A pedestrian may not suddenly leave the curb or other place of safety and walk or run into the path of a vehicle which is so close that it is impossible for the driver to yield. Both sections of this law together put an obligation on both the pedestrian and the vehicle operator to act in unison to ensure the pedestrian's safe passage. It should also be noted that certain crosswalks with pedestrian warning signals,

such as those on Cheverly Ave at Forest Road and at Kilmer Street, do not reduce the obligation of a pedestrian to yield to an approaching vehicle just because such a warning signal was activated.

## Village Voices

### *Cheverlians look toward a Cheverly Village*

A village was home for me in the rural Northern Neck of Virginia where I spent my formative years. It was there that I learned the meaning of community. In some cases, residents spent the full span of their lives in the same house. Community residents looked out for each other and shared resources as needed, often without being asked. To be fully human, that's what was expected.

For me, the contemporary concept of a village as a means of enabling those who wish to age in place resonates as a way to foster a sense of community. The village can help all ages share the wonderful stages of life – providing material, social and emotional support as needed. Although I built a “senior friendly” house fairly recently when I returned to live in my “old” Cheverly neighborhood, I am aware of future needs that I hope a Cheverly Village could meet. These include transportation, social interaction, help with home maintenance, and referrals to vetted providers of personal or home health care.

I will do whatever I can to make the Cheverly Village a reality.

**GREEN @ HOME -- The Year of the Conifer**

The Maryland Native Plant Society has named 2016 the Year of the Conifer.

Conifers carry their seeds in cones, and most are evergreen. Examples of conifers are cedars, cypresses, pines, and junipers. Native conifers found in Cheverly's natural areas are Eastern red cedar, pitch pine, loblolly pine, and Virginia pine.

Conifers provide forage, nesting, and cover for wildlife. The seeds in their cones feed birds and small mammals. In turn, birds help spread the seeds. The needles feed moth and butterfly larvae, and these insects feed birds.

Conifers add year-round interest, texture, shape, and color to the garden, and are often used as screening. Bald cypress is available through Cheverly's tree planting program. While it does not occur in our Cheverly natural areas, it is native to Maryland.
