**Spring is here!** Welcome Spring! Hopefully, by the time you read the FYI the weather will be a little warmer. As I write the FYI on March 21st, it's still a little chilly outside.

Many residents have mentioned that the March FYI was a tad long, so I'll try to keep this one a little shorter. However, please take the time to read the March FYI because it has a lot of valuable budget information in it.

**FY14 Draft Budget Unveiled on April 8<sup>th</sup>:** The FY14 Draft Budget will be delivered to the Town Council on April 8<sup>th</sup>. If you would like a copy of the Draft Budget it will be available at the front desk of Town Hall. As of this time we expect to keep the Tax Rate at .58 per one hundred dollars of assessed value, and given that virtually every home's assessed value remains constant, the average resident's total tax bill will remain unchanged.

I will highlight any major changes in the FY14 budget in the May Newsletter. However, if you would like to learn more about the budget the most critical meeting will be the April Work Session which is scheduled for April 22<sup>nd</sup>.

Where Does The Money Go? It's important that every resident understand how their tax dollars are spent. The Town Administrator and I have frequently stated that the Town is very efficient in its delivery of services. One measure of efficiency is how much money goes directly to employee expenses or as I like to say "feet on the street" versus other costs.

Before I go into detail, I want to quickly explain the difference between Capital and Operating Costs.

**Operating Costs** are those costs that are spent yearly to keep the town running. This represents the vast majority of our budget (89%). **Capital Costs** are investments made by the town in roads, vehicles and equipment and in FY12 represented 11% of spending. The town needs to maintain a steady investment in these areas otherwise our roads and vehicles will fall into disrepair and the costs to address will spike. In reality I'd like to get this portion of spending closer to 15 to 18%.

Based on FY2012 results (the last audited numbers) Cheverly can be proud that 70% (\$3,208K) of FY2012 operating costs were spent directly on personnel costs. Of that number only 9% is dedicated to administrative personnel. This means that 91% of all personnel costs are spent on Public Safety and Public Works Staff. As I like to point out, you can even find our Police Chief out on patrol and our Public Works Director driving a plow.

I have recently benchmarked how our administrative personnel costs compare to other Prince George's Municipalities and our numbers are extremely favorable. Percentages range from 9% to 35%, and only two municipalities have lower administrative costs than ours.

Almost two thirds of the remaining 30% of operating costs can be attributed to the following categories.

- Professional Service (Legal, Computer, Auditor): \$125K
- Speed and Red Light Vendors: \*\*\* \$110K
- Various Insurances \$ 50K
- Street Lights and Trash Disposal Fees \$200K
- Building Loans and Maintenance \$200K
- Fleet Maintenance \$180K

\*\*\* These costs are offset by direct revenues.

On Council, I've analyzed immediate issues with a longterm focus, including ensuring studies and plans for the BW Parkway, 202 and 450 corridors and Metro development reflect our town's interests. I helped drive a direct, proactive approach with our business partners – securing commitments to the highest environmental, industry and labor standards, green space/storm water management and regular business/community meetings. This has eliminated noise and visual blight, kept salvage operations indoors and electronic recycling responsibly managed.

# Message from the Chief Buddy Robshaw (policechief@cheverly-md.gov)

**HOW WE CAN REDUCE CRIME BY 70%** -Take a few minutes and study the crimes reported in February listed at the end of this Message. One thing you will quickly notice is that thefts and

vandalisms account for a little over 75% of crimes reported in Cheverly during that month. In truth, almost all the thefts and vandalisms were to autos and most reported vandalisms were really attempted or interrupted thefts to start with, proving once again that theft is by far the most frequent crime in the Town. These statistics also prove how important it is that residents check the plain view contents of their vehicles before locking their vehicle doors. This type of crime clearly prompted our new slogan, "Conceal it or thieves will steal it."

Numbers high on the list of most stolen included communications devices, radar detectors, navigation tools such as Garmin GPS, Magellan GPS, and Tomtom GPS, as examples, and then cameras, loose coins, cell telephones, and music CDs. While not all thefts or vandalisms can be deterred, carefully hiding the presence of the items or removing them altogether may stop thieves visually checking vehicles as they pass by from making you their next victim.

#### STEPS ONE CAN TAKE TO DETER METRO RE-

LATED CRIMES – The CPD's definition of METRO crime is any criminal act that occurs on Metro property or between the time a victim exited a METRO train or bus until the time they reached their immediate destination away from a METRO property or stop. In other words, we tend to use the METRO as a starting point regardless of whether the criminal act was directly related to ridership or not. We use and rely on this definition heavily because if we can tie the victim to a METRO facility or bus, it is possible that the suspect used the same facility or bus just prior to the crime. The end result is that both the victim and the suspect(s) were captured on HD video employed at all METRO stations and on all METRO buses.

While this video will likely result in a valued investigative tool, it is always much easier to deter a crime than to subsequently investigate one. With this thought in mind, try to utilize the below listed steps to reduce the likelihood you could be a victim of METRO crime.

1. While riding on METRO train or bus, try not to display cell telephones, other video/communications devices (IPODs, tablets, etc., including earphones), jewelry other valuables that may increase the likelihood you could be targeted.

2. Upon exiting a METRO train or bus, walk slowing away from the vehicle and stop for a minute or so. Give the cameras an opportunity to capture you as well as any would

be criminal who may have targeted you as a victim.

3. When leaving a METRO facility, always try to walk with other people heading in your same general direction. Most would be criminals do not like witnesses to their criminal acts.

4. Try, to the degree possible, to stay in well lighted areas and away from foliage or other items that could block the view of you from the traveling public.

5. Keep a whistle (CPD has them for free) in hand and utilize this whistle if you feel you are about to be the victim of a crime or after a suspect flees your immediate vicinity. Nothing draws the public notice like a whistle.

6. If you feel you are being followed or targeted, even if it is just a hunch, go to the closest open business (i.e., 7-11 Store at Columbia Park Road and Cheverly Avenue) or the nearest house and knock at the door. Tell a store employee or the homeowner to Dial 9-1-1 or utilize your own cell telephone once you are safe. <u>DO NOT WALK OR DRIVE HOME AND THEN REPORT THE CRIME</u>.

7. If you are the victim or a crime, try your best to look closely at the suspect for a clothing or other description that may enable the CPD to identify the suspect later.

8. Do not report stolen credit cards, cell phones, or any device in which you have a serial number to your insurance company or credit card/cell phone vendor for at least 24 hours. This gives the CPD the opportunity to potentially track the use of these stolen items, perhaps even get video of their use, before the devices or cards become inoperable.

Most important, make sure to relay to any responding police officers that you used METRO facilities or vehicles even if you do not believe the instant crime is in anyway related to your ridership. Remember, even if the suspect did not target you from a METRO train or bus, he or she may well have fled the area in one.

### COMPOSTING 101

With spring and the garden season starting, it's time to consider composting. Here's a brief overview of composting plus how to order a \$20 bin. Full compost guide at: www.nieinstitute.org/compost.pdf

**WHAT TO COMPOST** (Mix of GREENS with higher nitrogen ratio & BROWNS higher carbon.):

**GREENS:** vegetables, fruits, grains, coffee grounds with filter, tea bags, nut shells, plant cuttings, weeds (no seeds), hedge trimmings, grass clippings (best to leave mowed grass in place to fertilize your lawn). Also **natural fibers** such as cotton pads/swabs, cat, dog & even human hair, worn cotton, wool, & leather cloths (cut into small pieces). You can also add manure, bonemeal, old potting soil or other ingredients to increase the fertilizer quality of your compost.

**BROWNS:** eggshells, wood chips, branches (small), straw, leaves (small amounts) pine needles. Also **soiled paper products** such as paper towels, napkins, tissue paper, compostable paper plates or cups (no coatings), pizza or other food boxes (shredded).

WHAT <u>NOT</u> TO COMPOST: meat/fish, bones, oils & fats, dairy products, pet/human feces or pet litter, whole eggs, inorganic wastes (plastic, metals, chemicals etc.). If you're not sure, don't compost it.

WHERE TO USE YOUR COMPOST: Dig compost into your vegetable or flower garden to amend the soil. Compost is a soil amendment that improves soil quality, increases water retention and adds nutrients. Compost can be used as mulch under bushes and trees. Thin amounts can be spread on lawns to add nutrients and as mulch.

#### GREEN @ HOME -- YEAR OF THE HEATH

The Maryland Native Plant Society has named 2013 the Year of the Heath. What is a heath? Azaleas, mountain laurel, blueberries, and more -- they're all heaths. The heaths (Ericaceae) belong to a relatively large family of flowering plants that include azaleas, blueberries, heathers, rhododendrons, and wintergreens. Most of the species are shrubs or trees, but one group is herbaceous and some of these plants lack chlorophyll. Most of the species in the Ericaceae are sun-loving plants that grow in acid soils. Bogs, pocosins, and moors are some habitats where Ericaceae can be found in abundance.
