The Town Council Wishes Everybody a Very Happy Fourth of July: Although the fireworks will not be as good as those on Cheverly Day the Council wants to wish everyone a happy and healthy Fourth of July.

The Cheverly Town Council Sets the Budget for **FY2019:** Last month we discussed that fact that the Town Council lowered the tax rate from .54 to .51. Increasing Tax Assessments, allowed the Town Council to lower the rate

The council was able to take this action because of the strong financial position we are in, as we currently have an almost 3M dollar fund balance. Additionally, our housing values continue to increase which translates into increased tax assessments. So while the Tax Rate was reduced, the net result was less than a 1% decrease in your overall Cheverly Tax Bill.

As everyone knows Cheverly's homes were reassessed at the beginning of the year. Due to Cheverly's strong housing market the Town can expect to see a 5 to 6 percent increase in Tax Revenue over the next two years and can expects to see a lower rate of growth in operating expenses. Therefore, the Council decided to draw down on the fund balance this year in an effort to keep taxes flat or just slightly lower.

following projects; Paving of Lake Avenue, Paving of other trouble areas, a major investment in the rehabbing our sidewalks, Dog Park, three, two Public Works Vehicles, Improvements to Town Hall and our Town Parks, a handicap accessible playground at Woodward Park, minor traffic improvements based on the results of our traffic study, and new technology.

The Police Chief's Advisory Board is formed: Congratulations to Chief Robshaw for working with the Town Council in an effort gain even greater community input into the day to day activities of the Police Department and a very special "Thank You" to those citizens who have agreed to be on the Advisory Board agreeing to work with the Chief to ensure two way communication with between the department and our citizens.

Town Council Passes Police Hiring Incentives: As one of its first actions the actions the Citizen's Advisory Board and Chief Robshaw approved a recommendation to provide incentives to attract new officers to our force. Recently, we have lost a number of officers to other police department in the area, leaving our force 3 officers down. Additionally, we have three in the academy training, so we are currently very low staffed.

The incentives include: a) priority be given to the town residents or residents of Prince George's County, 2) Increase the area that an officer can bring their vehicle home from 25 to 40 miles, 3) provide a signing bonus of \$5,000 (50% when the officer and certified and 50% six months later), 4) Any lateral transfer be given additional salary steps in recognition of their experience, 5) \$500 be given to any officer or resident who recruits an officer who becomes a certified Cheverly Police Officer.

Look for More County Police Officers in Cheverly: As noted above due to recent turnover, our Police Force is currently 6 officers from full staffing. Historically, we have never quite been at full staffing, but at this time we really are short staffed. The good news is that we have three officers in the academy, and further good news is that one of the trainees is number one in their class.

Due to this short term issue, we will be asking for county police support to help fill some shifts and perform backup. Unfortunately, this might impact response times slightly. So if you see a county officer at your door, please understand that the officer is helping us out.

"Hey, I heard the Council Went to Ocean City, What Gives?": It's true the Town Council headed off to its annual jaunt to Ocean City for the Maryland Municipal League Conference for three days. While it might seem like a junket to some, I guarantee that each Council Member attends learning sessions, visits with other councils, meets with folks providing municipal services and maybe spends and hour on the beach.

This year seemed particularly useful as Town Staff and Council Members initiated a number of projects that we hope will come to fruition over the next year or two. Projects like; beginning the conversion to LED lighting for our Street Lamps, developing a Styrofoam recycling program, developing improvements to our election process, installing electronic charging stations on town property, installing red light cameras at the Columbia Park Bridge and potentially accelerating the transfer of SHA property for the Dog Park.

If we can accomplish half of these projects, you'll have to admit it was well worth the time.

Curbside Composting... Where are we? Over a year ago the Town announced that we would begin a Pilot Program for Curbside Composting when 100 residents signed up to participate. Originally the program would have allowed residents to bring composting material to the curb once a week (Mondays) and town staff would pick it up and bring it to a county facility. Originally, the county program was free which was an incentive as avoiding the standard \$65 per ton tipping fee would have potentially offset the costs of collecting the composting and delivering it to the county facility.

Unfortunately, at this point the county raised the fee for accepting composting to \$45 per ton, dramatically impacting the cost benefit of implementing the program. We have also heard from a neighboring community that the costs of running the street side composting program are high. Therefore, we are not yet at a point where we can implement a street side composting program. Town staff is investigating other alternatives such as a private vendor.

Please remember that Cheverly has a very successful back yard composting program. We have distributed over 600 composters to residents throughout town at a subsidized price of \$20. Residents with composters are able to fruits, vegetables and non-meat items from their garbage stream saving the town thousands of dollars and creating their own fertilizer for gardens. The Town program designed by Doug Alexander has been copied throughout the county, and was mentioned at the MML conference as a best-practice. What is Happening at Town Park and Town Hall? Changes continue to happen in Town Park. Approximately five years ago the Town Council and the Green Infrastructure Committee hosted a series of well attended community meetings to modify the Town Park Plan. Some of aspects of the plan have already been implemented: a New Stage, Handicap access to the Pavilion, and with the help of the county storm water management concepts.

However, one of the biggest aspects of the plan was to move the existing basketball courts to the tennis court area. These new courts will be multi-use courts, but the primary purpose will be for basketball. This allows for increased area for the courts and two full length courts. This move also eliminates long standing issues between nearby neighbors and the existing basketball courts.

"What will happen to the area where the basketball courts are now?" This area was planned to be more of a park area where we might eventually place a pavilion. This would be a nice complimentary use to the Community Market and reduce the impervious surfaces at Town Park.

"Well, what about Town Hall?" As you all know Town Hall has received little investment over the years. Other than a new floor and a score board for the gym little has been done in the last 15 years. This year the council has allocated money to allow for keyless entry to the facility to improve security and convenience. However to implement this improvement the council needed to allocate addition funds to replace the doors as the old doors did not work with the new security system. Additionally, an automatic handicap door will be installed at the side entrance.

The council also allocated FY18 funds to replace the air conditioning in the main office and FY19 funds to replace the 1972 air conditioning unit that supports the gym. Did he say 1972? Yes, he did! This is a great example of how the town has always attempted to spend money wisely. Our talented staff has kept this system running for over 45 years.

What is Happening at the Columbia Park Bridge?: Well in the 8 years I've been Mayor I can never decide whether the Columbia Park Bridge (Metro Bridge) or the Cheverly Booms is my biggest headache. Cars, Trucks and Pedestrians make the Columbia Park Bridges a very dicey intersection and the Town Council continues to receive complaints.

Over the last 10 years, the State Highway Association (SHA) has tinkered with the timing of the lights in attempts to assist pedestrians. However, all of these changes have in some ways increased the congestion on the bridge without significantly improving pedes-

trian safety. Additionally, as the area south of the bridge continues to develop distribution centers more trucks are utilizing the bridge.

The Town Council has attempted to bring this issue to county and state officials in an attempt to radically reconstruct the bridge, but to no avail. There are so many traffic issues across the state and county that this bridge does not become a priority.

Last year at the Maryland Municipal League Conference in June, we had the opportunity to speak with the Director of SHA and ask for special attention. Since that time, our Police Department, Public Works Director, County Resources and SHA personnel have been working to identify options that would improve the intersection without major reconstruction. The process has been slow and full of interruptions. However, as I write this Newsletter we have received word from SHA that an option has been identified and will be moving to design.

Expect to hear over the next two months what changes can be expected and how they will improve the intersection.

UPDATE: Our Public Works Director is working with SHA to schematically diagram the proposal and at this time we hope to have it presented at the June 14th work session. The primary goal of the initiative is to improve pedestrian safety by reducing the amount of movement by vehicles at the same time that pedestrians are crossing.

So for those curious, please *google* "pedestrian scramble". This is a traffic management technique that has been recently re-introduced and I've seen in action in Washington, DC and California. Basically, all traffic is shut down while pedestrians are allowed to cross in any direction they desire. The good news is that it is extremely safe, potential downside is that there may be a longer waits.

Message from the Chief Buddy Robshaw (policechief@cheverly-md.gov)

TEXTING AND CELLULAR TELEPHONE USE IN A MOTOR VEHICLE: Most residents are aware that texting or using a hand-held cellular device while driving are both primary offenses and punishable by fines. Engaging in either of these activities that results in a traffic accident with serious bodily injury or death also carries drastic consequences, including incarceration and loss of driver's license. In addition, any person under the age of 18 years who is found texting while driving may have their license suspended for 90 days at a time or receive a license restriction that allows driving only to and from school or work.

What some residents have difficulty remembering is that both of these activities are prohibited while a motor vehicle is on the travel portion of the roadway. This includes when the vehicle is not moving or stopped at a traffic light, stop sign, or railroad signal, or while you are waiting for slow traffic, an accident, or while in line at a toll booth. In addition, school bus drivers and the holder of a learner's instructional permit or a provisional driver's license who is 18 years of age or older are never allowed to text or talk on a cellular while driving.

STAY LEWD: LEWD is an acronym that stands for Lock Every Window and Door. Even though the Department and the community can take great pride in the reduction of burglaries in the Town over the last few years, this type of crime happens in cycles. There are criminal groups out there right now looking to prey on Cheverly. Please continue to follow these five simple steps:

- 1. Appear to be home. Leaving a radio playing so that someone who approaches your home at the front door can hear it.
- 2. Employ lighting in your front and back yard. Low cost LED lighting on a photoelectric cell ensures light comes on at dusk and off at dawn.
- 3. Record the serial numbers of laptops, cameras, and other electronic equipment, and carefully photograph expensive jewelry items. This information is critical in tracking your stolen property.
- 4. Keep your vehicle panic alarm (on your key

chain) next to your bed at night. If you believe someone may be trying to enter your home, activate the panic alarm and call the police immediately. Dial 9-1-1 if you see a stranger in your and your neighbor's yard, alley, or private property.

RIGHT-OF-WAY ISSUES: One of the most frequent traffic violations that officers see in and around Cheverly concerns the issue of right-of-way. Right-of-way, according to the Annotated Vehicle Law of Maryland, Section 21-101, is the right of one vehicle or pedestrian to proceed in a lawful manner on a high-way in preference to another vehicle or pedestrian. The most frequent violation of this preference occurs as vehicles exit ramps from one roadway onto another. The general belief is that, once a vehicle signals a merge from the ramp onto the highway, that vehicle is somehow given preference and other vehicles must slow down or yield to the merging vehicle.

I have witnessed dozens of near crashes as merging vehicle force their way onto a roadway in lieu of slowing down or stopping until such a merge can be made safely. For the record, the preference is not given to the merging vehicle but to the traffic already traveling on the highway a vehicle is attempting to merge onto. Failure to yield the right of way while merging is a traffic offense resulting in a fine of \$90 and 1 point on the violator's driver's license. If the failure to yield results in a traffic accident, the fine is \$130 and 3 points on a driver's license. In addition to being a specific violation, recent studies of road rage incidents has found that failure to yield is a frequent catalyst for such events.

SPECIAL HOME SECURITY SURVEYS – As

you may be aware, the Cheverly Police Department regularly conducts free home security surveys for all residents of Cheverly. These surveys generally take about one hour and the cost of suggested security improvements generally ranges below \$200. In addition to regular security checks, we also have surveys tailored toward residents who live alone, who travel frequently, who are elderly, or who have been or are currently in domestic situations where there is a protective order or peace bond. PLEASE USE THE SIDE WALKS, IT IS THE LAW!

As the weather begins to get nicer and more and more residents are walking or jogging in town, we are taking this opportunity to remind you that it is illegal to walk or jog in the street when a sidewalk is available on a road. The State law reads:

- 21-506 Rules for pedestrians on roadways
- (a) Where a sidewalk is provided, a pedestrian may not walk along and on an adjacent roadway.
- (b) Where a sidewalk is not provided, a pedestrian who walks along and on a highway may walk only on the left shoulder, if applicable, or on the left side of the roadway, as near as practicable to the edge of the roadway, facing any traffic that might approach from the opposite direction.

The Cheverly Police have been receiving numerous complaints from residents fearing that they are going to hit a pedestrian or jogger as a result of those individuals not walking on the sidewalk.

We want all our pedestrians and motorists to be safe. So, please use the sidewalks. Not adhering to the above noted law will result in a fine being issued.

RESIDENTS PLEASE HELP THE RUNNERS STAY ON THE SIDEWALK BY TRIMMING YOUR BUSHES. Per Town Code:

Sec. 18-5. Nuisances.

It shall be unlawful and is hereby declared to be a public nuisance for any person or entity owning, leasing, occupying or having charge of any residential, commercial or industrial property in the town to maintain or fail to maintain such premises in such a manner that any of the following conditions are found to exist thereon:

(c) Overgrown vegetation on developed property;

Notice from the Department of Public Works

On June 5th, the town received a notice from the county reminding their customers of the regulations on what items are permitted or prohibited for disposal in the county landfill.

The following list of items are not permitted and can not be picked up by the town:

Construction and Demolition Debris

Stumps and Logs

Skids and Pallets

Drums/ tanks/ kegs/ and barrels unless emptied and flatten or crushed with lids removed prior to arrival.

<u>Drums/tanks/kegs/barrels that have held hazardous waste shall</u> be emptied properly in accordance with COMAR 26.13.02.07

Hazardous and Biohazardous/Medical Wastes (no Red Bags)

Shingles and Roofing Materials

Yard Waste

Toner/Developer/Ink Cartridges

The Prince George's County Department of the Environment, Resource Recovery Division (RRD), would like to thank you for your continued business at the Brown Station Road Sanitary Landfill (BSRSL). In an effort to continually provide excellent customer service, the RRD is reminding customers of the following policies:

- The BSRSL is increasing the number of random load inspections to ensure unacceptable material is not being delivered to the landfill. Inspections will focus on mixed loads (yard trim or recyclable mixed in with trash), yard trim, hazardous waste and any other unacceptable waste.
- For safety reasons, personnel entering the BSRSL should not be dropped off and/or picked up at any location on the landfill. This includes the White House Road entrance.

Under no circumstance should haulers mix yard trim or recyclables in with trash for disposal at the landfill. Additionally, under no circumstance should hazardous waste be delivered to the landfill. Delivering and trying to tip unacceptable materials at the landfill violates the landfill permit requirements and County code.

Please speak with your crews and monitor the materials your company is accepting for disposal at the landfill. Violations and penalties will be in accordance to County code, RRD policy, contractual penalties, and may include rejection of future deliveries, fines, and or your responsibility to remove the material from the landfill.

For your convenience, enclosed is a list of some of the more common types of unacceptable items for disposal at the BSRSL. I look forward to a continued partnership and appreciate your immediate attention to this matter. If you should you have any questions please contact Charles Schultz at (301) 582-7621.

SOLID ANIMAL WASTE ORDINANCE

Sec. 4-10 (a) It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, & play areas of all other parks.

RESIDENTIAL BUSINESS LICENSES

If you are currently operating a business out of your home, you are required to obtain a **Town Residential Business License**.

Home occupations are under (Chapter 9 of Town Code) and (subtitle 27 of the Prince George's County Code) and do not include any retail business or trade, etc.

Town Residential Business Licenses are issued annually for the Fiscal Year (July 1 to June 30). Please call the Town Clerk at 301-773-8360 or stop by the Town Office to pick up an application form. *The yearly business* license fee is \$20.

CHEVERLY RENTAL LICENSES

All single-family, multi-family, and roomer rental dwellings in Cheverly are required by Chapter 5 of the Town Code to obtain a **Cheverly Rental Housing License.**

Licenses are issued annually for the Fiscal Year (July 1 to June 30). Call the Code Enforcement Office at 301-341-1055 or see the town website for an application.

The yearly rental license fee is \$100.00

NOTE: Failure to comply with Town Code licensing laws can result in a fine.
