**New Police Program Nabs First Suspect:**

For the last two months the Chief and I have published information about a new Police Program that is an extension of the Citizen Radio Program, where you can contact the Officer on Duty. If you see something suspicious, simply call **301-789-5090**. Please don't use this for emergencies, as the call won't go through if the officer is on another call.

In August a resident who viewed a youth riding a bicycle, slowing down to check out car windows, called the Officer on Duty. The suspect was apprehended, with stolen goods that had been removed from Cheverly vehicles!

## **New Property Tax Assessments are in our**

**Future:** Property Assessments in Maryland are performed every three years. Our last property Assessment was done in 2012, so the next assessments will be finalized on July 1<sup>st</sup>, 2015 and the tax assessment process is now underway.

In late December you will receive a letter from the Tax Assessment office informing you of your new property assessment value. This letter is very important because your property assessment is 1/2 of the equation used to calculate your property taxes.

Once you receive your Assessment Letter you have 45 days to appeal. We will continually discuss this in the Newsletter so that you don't put this aside during the Holiday Season.

Dan Puma, Supervisor of Assessments, attended the August 14<sup>th</sup> Town Hall Meeting, and explained the property tax assessment process.

## **The Importance of the Homestead Tax**

**Credit:** Hopefully every Cheverly property owner, who resides in their Cheverly home, has signed up for the Homestead Tax Credit. I am sure most of you have, but you can check by going to the Maryland State Tax website: <http://sdat.resiusa.org/RealProperty/Pages/default.aspx> and keying in your home address. When your home information appears, check the bottom left portion of the screen and it should say approved.

For the past three years the Homestead Tax Credit has had little impact on your tax bill, because property assessment values decreased or stayed stable. However, in 2015 we expect property assessment values to increase.

The Homestead Tax Credit is designed to limit the impact of rapidly increasing property assessments for Owner Occupied homes. Assessments for non-owner occupied homes (rentals) increase by 33% per year, while assessments of owner occupied homes (with the Homestead Tax Credit) only increase by 10%. This yields a tremendous savings over a three year period. See the example below:

	Homeowner	Rental Home
Old Assessment:	\$190,000	\$190,000
New Assessment:	\$280,000	\$280,000
Year 1 Assessment:	\$209,000	\$220,000
Year 2 Assessment:	\$228,000	\$250,000
Year 3 Assessment:	\$247,000	\$280,000

## **Did you receive a Critical Areas Letter?**

In June many residents received a Letter from the Department of Environmental Planning regarding the Critical Areas of the Anacostia Watershed. There was much confusion from residents regarding the meaning of the letter, because most who read it felt there was no action required.

As it turns out the banks of the Anacostia are always changing and the "Critical Area" definition of 1,000 feet is constantly changing as well. Recently, the Department of the Environment had to re-measure the critical areas, and by law notify everyone within a 1/2 mile that this was occurring even though there was no effect on them.

So to all of you who received a white copy of the letter, no action is required and there was absolutely no change to the zoning of your property.

## **Unfortunately, Cheverly has a Free**

**Concert:** Much to the chagrin of many Cheverly residents, music from a concert at Capital Plaza could be readily heard for over 6 hours on August 3<sup>rd</sup>. Many of you might remember this occurring on two separate occasions last summer as well.

It is not clear, exactly how the music can carry so far, but the impact to Cheverly is quite real. Complaints made on the day of the concert were deflected with statements like; "we have all the appropriate permits." However, follow-up conversations with the Department of Permits and our local County Council Members (Harrison and Olson) have gotten a more sympathetic ear.

We are working with County officials to develop a better channel for communicating noise complaints when future concerts are scheduled at Capital Plaza. I am hopeful that we will be able to "turn down" the music if this situation occurs again.

## **Trees, Trees, Trees, Trees, Trees – Free!**

Wait a minute, did he say Free Trees? By Gosh, I think he did! Be the first to call Public Works (301) 773-2666 to get a Free Tree planted in your yard this fall! Remember priority is given to residents who request larger canopy trees!

I talk to so many people whose last memory of their 100 year old tree was the cost of removal, and they say never again. I understand the unexpected cost of removal can be jarring, but over the long term the cost / benefit of owning trees is definitely positive.

- Mature Trees can reduce your energy bills by as much as 12%.
- Mature Trees can add up to \$10,000 to the sale price of your home.
- Mature Trees attract new residents to Cheverly!

Planting Trees is like managing a financial portfolio. You must keep investing in new trees, as older trees die off. Help keep Cheverly beautiful... Plant a Canopy Tree!

## **Help Cheverly Save Money, Think Zero**

**Waste:** Are you doing everything you can to keep Solid Waste out of the Trash Stream? Did you know that Cheverly pays \$59 per ton to place Solid Waste into the Brown Station Landfill? Did you know Cheverly pays \$0.00 for every ton of recycling? Did you know that Cheverly pays a reduced fee for Yard Waste?

Cheverly Residents have been amazing over the last 5 years, even as the price of a ton of Solid Waste increases our overall tipping fees have decreased. That means that our residents are placing fewer items in the Solid Waste Stream.

However, we can still do more. Are you recycling everything that you can? Have you purchased a compost bin? Are you keeping gently used items out of the trash stream by offering them on town listservs or bringing them to the thrift stores? Each of these actions saves you money.

Look forward to a Town Survey this fall that will help us identify ways of saving even more money on tipping fees.

**Back to School Safety:** Residents in the area near Spellman and St Ambrose Schools are well aware of the many traffic issues that arise when school is in session. Unfortunately, some parents (and others) in the haste to pick up their children can be found speeding and parking in a manner that creates significant congestion.

As always the Town Council asks your consideration regarding the Safety of Our Children. However, are also planning to make the following changes:

**Raise the Speed Limit on Joslyn to 20MPH:** “What, I thought you said you were going to enhance the safety in the area?” The Speed Camera located on Joslyn Place has slowed traffic significantly. Residents report a noticeable decrease in speeding and we are issuing fewer tickets along Joslyn. However, recent changes in State Law mandate that Speed Cameras can only be used when the Speed Limit is 20MPH or greater. Therefore, we are going to raise the Speed Limit to 20MPH so that we can continue to use the Speed Camera as a tool to reduce speeding.

**Prevent cars from lining up along 63<sup>rd</sup> Avenue to pick up children:** Many residents report that Spellman parent line up along 63<sup>rd</sup> Avenue to pick up their children causing traffic jams and traffic flows that actually endanger the children crossing the road. This is not the designated pick up area for Spellman.

The Town Council will be changing the signs along this area of 63<sup>rd</sup> Avenue to prevent this practice and ask the parents to pick up their children in the designated areas. During the month of September our Police Officers will issue warnings, however tickets will be issued later in the school year.



## FALL FLEA MARKET

## PLEASE USE THE SIDE WALKS, IT IS THE LAW!

As the weather begins to get nicer and more and more residents are walking or jogging in town, we are taking this opportunity to remind you that it is illegal to walk or jog in the street when a sidewalk is available on a road. The State law reads:

### *21-506 Rules for pedestrians on roadways*

*(a) Where a sidewalk is provided, a pedestrian may not walk along and on an adjacent roadway.*

*(b) Where a sidewalk is not provided, a pedestrian who walks along and on a highway may walk only on the left shoulder, if applicable, or on the left side of the roadway, as near as practicable to the edge of the roadway, facing any traffic that might approach from the opposite direction.*

The Cheverly Police have been receiving numerous complaints from residents fearing that they are going to hit a pedestrian or jogger as a result of those individuals not walking on the sidewalk.

We want all our pedestrians and motorists to be safe. So, please use the sidewalks. Not adhering to the above noted law will result in a fine being issued.

### SAVE THIS NUMBER IN YOUR CELL PHONE, MOBILE DEVICE, OR NEAR YOUR HOME TELEPHONE – 301-789-5090

A cell phone with the above number will be maintained by patrol officers working the streets of Cheverly daily, from 5:00 PM until 5:00 AM (outside of our normal office business hours). In a manner similar to the Cheverly Watch Radio Program, this cell phone can be contacted for the following reasons:

1. To report a crime in progress;
2. To report a suspicious person, vehicle, or circumstance;
3. To report an emergency situation (traffic accident, tree or wire down, fire, etc.);
4. To report a solicitor;
5. To obtain a vehicle impound release when the office is closed; or,
5. To provide a tip about a previous crime, a wanted person, or criminal activity (rewards are available).

This telephone shall not be called for the following:

1. To report a routine call for service or a call requiring a report only;
2. To seek information about an outstanding case or obtain a copy of a report;
3. To seek legal advice or general assistance.

Note: The non-emergency telephone number for routine calls for service is 301-352-1200 and the number for the Department's daytime hours is 301-341-1055.

**C-PACT/CHEVERLY WATCH RESIDENT RADIO PROGRAM MEETING** – The next joint meeting of C-PACT (Cheverly – Police And Citizens Together), Cheverly's Neighborhood Watch Organization, and the Cheverly Watch Resident Radio Program is scheduled for Wednesday, September 10, 2014, at 7:00 PM in the Department's conference room. We will be making preparations for Public Safety Day.

**FOR OUR YOUNGER DRIVERS** – Just a reminder, it is illegal for any person under the age of 18 years to text or use a wireless communications device while driving. The penalty, which is not the same for people 18 years and older, is a suspension of the young driver's license for a period of not more than 90 days and/or the imposition of a license restriction that limits the young driver's ability to operate a motor vehicle in the course of the individual's employment, driving to and from that employment, or driving to and from school.

## Recycling & Refuse Containers



While driving behind the refuse truck, I witnessed two Town employees struggling to empty a very large refuse container into the back of the refuse truck. When the container was finally able to be tipped over the edge of the truck two thoughts came to my mind; how much recycling material was in the two black bags placed in the container? Does this resident know that the Town regulates the size of the refuse containers?



### **The Town of Cheverly not only encourages recycling it has made it mandatory.**

It is possible, and by the directives of the Mayor and Town Council, that a refuse collector may open suspect refuse containers and upon finding recyclables requests their separation from the regular trash. In some recent instances this has taken place, when it was obvious that cardboard was not being recycled.

**Recycling disposal is free.** Help the Town save some funds and thereby help the environment. Put a stop to burying recyclable items, limiting the life of the landfill and increasing the Town's tipping fees. If you need the list of what can be recycled call us a P.W. 301-773-2666 or check it on line at [cheverly-md.gov](http://cheverly-md.gov).



### **Refuse container larger than thirty-two gallons violates the Town's code.**

These large containers also jeopardize the health and well-being of those that remove the Town's refuse. If they cannot tip the container they have to put their hands in your container to make it lighter. Have you disposed of needles? Glass? Sharp objects? Diapers? Animal litter? Would you handle that which you disposed of? What if the Town's employee while attempting to empty your container hurts his back and we lose him for one week, a month, six months, forever?

Please read the regulation that follows in its entirety and if your container does not comply replace it with one that does comply and any other regulation that applies.

**Sec. 10-6. Garbage and trash receptacles and collection generally.** In addition to recycling bins and other receptacles containing recyclables each residence shall maintain a suitable metal or plastic container that is intact and without holes, **not to exceed thirty-two (32) gallons' capacity** covered with a tight-fitting intact lid, for the storage of garbage and **trash**. The abovementioned recycling bins, recyclables, and containers shall, from 7:00 p.m. on the day prior to collection until 7:00 p.m. of the day of collection, be placed at the curb or on the outside of the building and at a place which is readily accessible to the collector. If these bins, recyclables, and containers are kept on the outside of the building at any other times, they should be placed to the rear of the front building line and in the case of **trash** containers kept covered with a tight-fitting intact lid.

## SOLID ANIMAL WASTE ORDINANCE

**Sec. 4-10 (a)** It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, Town Park & play areas of all other parks.

## FINES FOR ILLEGAL DUMPING

The Public Works Department will be issuing \$400 fines for any dumping/leaving hazardous waste on Town Property (Outside Public Works Yard). We accept used motor oil only.

The County offers free hazardous waste disposal days for County residents every Thursday, Friday and Saturday from 7:30am—3:30pm. Items accepted include:

Cleaners, Paint Thinners, Solvents, Oil Based paints, Insecticides, Herbicides, Used Motor Oil, antifreeze, brake fluid, car batteries, chemistry sets. Photographic chemicals, swimming pools chemicals, cooking oil, and appliances. Scrap Tires—maximum 5 tires no larger than 17" in size per year.

Non Commercial Vehicles only.

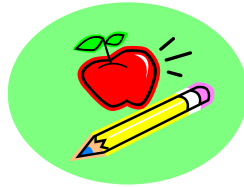
