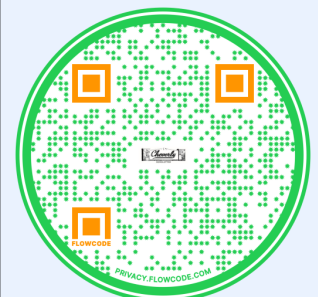
What's Up with the Pavilion?

RESIDENTIAL BUSINESS LICENSES

If you are currently operating a business out of your home, you are required to obtain a **Town Residential Business License**.

Home occupations are under (Chapter 9 of Town Code) and (subtitle 27 of the Prince George's County Code) and do not include any retail business or trade, etc.

Town Residential Business Licenses are issued annually for the Fiscal Year (July 1 to June 30). Please call the Town Clerk at 301-773-8360 or stop by the Town Office to pick up an application form.

The yearly business license fee is \$20.

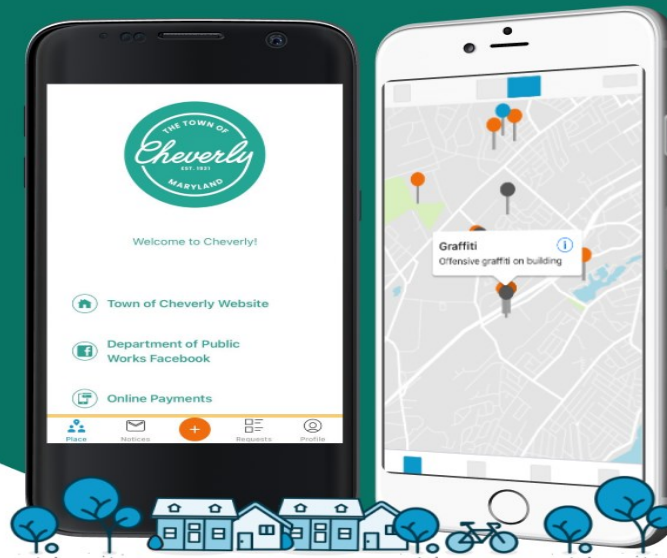

CODE COMPLIANCE

CHEVERLY RENTAL LICENSES

All single-family, multi-family, and roomer rental dwellings in Cheverly are required by Chapter 5 of the Town Code to obtain a **Cheverly Rental Housing License**.



Licenses are issued annually for the Fiscal Year (July 1 to June 30).

Call the Code Compliance Office at 240-770-7647 for an application.

The yearly rental license fee is \$100.00

NOTE: Failure to comply with Town Code licensing laws can result in a fine of \$500.

PARKING COMPLIANCE



According to Code Sec. 18-4.2 and Sec. 27.5

Vehicles that have not moved for 72+ hours may be towed; all vehicles need to be operational & legally operable on

both private property and on the street.

Commercial vehicles are prohibited to park in front of residential properties.

OUTDOOR BURNING REMINDER:

Sec. 12-3.

- (a) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material on any improved street, gutter, parking strip, parkway, park, alley or any other town property within the corporate limits of the Town of Cheverly.
- (b) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material within the corporate limits of the Town of Cheverly, without first obtaining a permit from the Town of Cheverly, excluding outdoor cooking devices.

CODE COMPLIANCE

SOLID ANIMAL WASTE ORDINANCE



Sec. 4-10 (a) It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, & play areas of all other parks.

VACATIONS & HOME SECURITY

Residents planning to be away for vacations should visit <https://www.cheverly-md.gov/cheverly-police-department/webforms/house-check-request> to arrange to have their homes checked while they are gone.

The following items should also be checked to make sure your residence is safe and looks as much as possible like someone is there:

- Cancel newspaper & mail delivery or have a neighbor pick it up for you.
- Arrange for lawn care.
- Store valuables, preferably in a bank.
- Store lawn mowers, bicycles, and lawn furniture inside.
- Set lights inside the house on a timer.
- Set telephone bells as low as possible.
- Draw shades and drapes.
- Lock cars left in the driveway.
- Make sure smoke detectors are working.
- Lock all windows and doors.
- Give your house key & itinerary to at least one friend or neighbor.

GRASS, WEEDS AND OVERGROWTH

Obstructions:

1. Residents are reminded that with the nice weather more and more residents are out walking. Please keep the walkways and sidewalks clear of overgrowth, obstructions and hanging limbs.
2. If the tree obstructing the sidewalk or roadway is in the planting box, please contact the Department of Public Works.
3. Keep vegetation from obstructing the view near intersections.



Lot Maintenance:

1. Residents are reminded to make sure your grass is cut before it reaches 8 inches in height.
2. Also, the planting strip between the sidewalk and the street is your responsibility to maintain
3. If you are going on vacation, make sure you make

arrangements to have your grass cut for you.

4. Be sure to take into consideration that the weather can be unpredictable, but the grass still needs to be cut.

PLEASE USE THE SIDEWALKS

As the weather begins to get nicer and more and more residents are walking or jogging in town, we are taking this opportunity to remind you that it is illegal to walk or jog in the street when a sidewalk is available on a road. The State law reads: 21-506

Rules for pedestrians on roadways

- (a) **Where a sidewalk is provided, a pedestrian may not walk along and or an adjacent**
- (b) **roadway.**
- (c) **Where a sidewalk is provided, a pedestrian who walks along and on a highway may walk only on the left shoulder, if practicable , or on the left side of the roadway, as near as practicable to the edge of the roadway, facing any traffic that might approach from the opposite direction.**

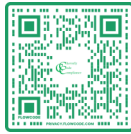
We want all our pedestrians and motorists to be safe. So, please use the sidewalks. Not adhering to the above noted law may result in a fine being issued.

REMINDERS FOR SPECIAL EVENT NEIGHBORHOOD BLOCK PARTY

1. **Canvass everyone in the neighborhood to find a date that works best.** Visit each neighbor to inform them of your plans and get feedback from them at least before you are tentatively scheduled to host the event. Complete a block party survey. Keep your neighbors informed as the event date approaches and make sure they understand they are a part of celebration. A block party letter and neighbor survey can be obtained at the Town office.
2. **Obtain necessary permits if you block off your street.** Permits must be obtained 30 days in advance for block parties. A Block Party Permit is required to block off any of a residential street for neighborhood block party purposes,
3. **Remind your neighbors 1 week before the party that the street will be closed.** It is important to keep your neighbors informed.
4. **Place the “No Parking” signs 24-48 hours prior to the party at each end of the street with the date and time of the street closure.** Town Hall can supply “No Parking” signs once the event is permitted.
5. **We recommend that you communicate with your neighbors a week prior to the Block Party.** Communicating with your neighbors help to ensure all are notified and remember not to park on the street.
6. **Your street must be clean and open to traffic no later than 10 PM.**

RESIDENTIAL ZONE PARKING



Residential ZONE parking permits are now available. The price of the permit is \$5 per vehicle with 1 free guest pass per address. A second guest pass may be

obtained for \$2. (Only two guest passes per address.) Applications can be downloaded from the Town website at www.cheverly-md.gov under the Form and File tab. Please drop completed applications in the Permits Box located at Town Hall or mail to: Code Enforcement,

Cheverly Residential Zone Parking Permit Application

Due to the Covid19 restrictions, applications for Zone Permits will only be accepted by US Mail or placed in the Permit Box located on the left-side wall of the main entrance at Townhall.

- Permits can only be issued to vehicles registered to a Cheverly Address.
- A copy of your vehicle registration must accompany the Application.
- Cost of the Permit is \$5 per vehicle | 1 Guest Parking Pass is allowed **per residence** at no cost.
- An additional Guest Parking Pass is available for \$2. (No More Than 2 Guest Parking Pass per Address)

If you live in one of the following areas, you will need a Parking Permit: Please check the zone that applies.

- ☐ Zone 1: State St, 61st & 62nd Ave, as well as the 1800 Block of 64th Ave
- ☐ Zone 2: Eliminated
- ☐ Zone 3: 22-2400 Block of Cheverly Ave
- ☐ Zone 4: Arbor St & Crestlawn Ave (22-2300 Block Parkway Eliminated)
- ☐ Zone 5: 2300 Block of Bellevue Ave
- ☐ Zone 6: Benton Rd & 23-25 Lake Ave
- ☐ Zone 7: 2400 Block of Valley Way
- ☐ Zone 8: 3300 Bellevue Ave; Medical Ter
- ☐ SR: This permit allows senior citizens 65 years of age and older to Park in the Odd Side of the 2200 Block of Cheverly Ave in order to utilize the Metro



Residential Parking Permit are to be Displayed on the Back Left Bumper area.

If you have a regular and a SR permit, display them next to each other on the Back Left Bumper.

Guest Parking Permits shall be hung on the REARVIEW mirror with information facing outward.

New Tree Evaluation Program

The Town recently rolled out a private tree inspection program. Residents may request one tree inspection per year by the Town's Arborist, Dr. Tolbert Feather. We are limiting inspections to one per address as we formally roll out this program to help ensure every address has an equal opportunity. There are 100 inspections in the budget, so limiting each address to one inspection will help cover the Town.

In order to request this service, a resident must fill out the form on the webpage and attach a check for \$85 made out to *Town of Cheverly*. And then mail to or drop off at Town Hall Attn: Public Works. Each inspection costs \$85, and the resident will receive a report on their tree. Once the form is approved, the inspection will be scheduled.

Checks won't be deposited until after the inspection report is completed.



TRASH COLLECTION REMINDER

Sec. 10-7 Except for household trash, which the town may collect from side or rear yards, all collectible trash shall be placed at the street side or curb, but shall not be placed there earlier than 7:00 p.m. on the day before it is scheduled to be collected. All containers or uncollected trash and waste must be removed from the street side or curb by 7:00 p.m. of the day it was scheduled for collection. Upon request of a resident to the town administrator and for good cause shown, the town may collect recyclables from a side or rear yard of the property.



CONTAINERS NOT TO EXCEED THIRTY-TWO (32) GALLON CAPACITY.

Just a reminder, and as stated on the Town's website, **"Containers not to exceed thirty-two (32) gallon capacity."**

Public Works will not pick up nor empty trash containers larger than 32-gallons. This is for the safety of our Public Works employees who manually lift each and every trash can.

****In the interim, until you purchase a 32-gallon trash can with a tight-fitting lid, please remove all trash bags from cans larger than 32-gallons and place them on the curb prior to trash collection.***

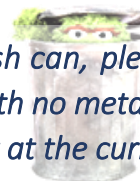

Message from the Chief

It's the end of the summer, the beginning of back to school, and pedestrian safety remains important. Here are 3D's to consider, whether going out on a run, walk or bicycle ride throughout the community, or a long summer drive:

Distracted Driving

In the smartphone age or information era people are connected more than ever but are attempting to stay connected when they shouldn't: behind the wheel. Although mobile phones are a major distraction, distracted driving is anything that takes your mind off the road, or hands off the steering wheel.

Using your mobile phone while driving around Cheverly is not only dangerous for local people and animals but illegal. In Maryland, you cannot use a mobile phone (or similar electronic communication device) while holding it in your hand. You can only use the device in a hands-free manner, such as a speaker phone or voice commands, but never while holding the device. Note: any driver under the age of 18 is prohibited from using a mobile phone or similar device for any reason (except emergency). The reason being engaging in distracting behaviors with a phone (or similar device) like dialing, talking, or texting is so dangerous and increases the risk of getting into a crash by three times.

And remember, other serious driving distractions such as eating, grooming, reading, reaching for objects on the floor, changing clothes or talking to passengers are just as dangerous and can result in a moving violation citation.

Drowsy Driving

Drowsy driving is a serious traffic safety and Safe Community concern that puts all roadway users, pedestrians and animals at risk and can lead to tragic consequences.

According to National Highway Traffic Highway Administration (NHTSA), 795 people nationwide were killed in drowsy-driving related crashes in 2017.

Here are some prevention tips to consider: get enough sleep, stick to a consistent schedule, avoid driving alone, take frequent breaks, and avoid alcohol or medication that can make you sleepy. If you are feeling sleepy, pull over in or around a safe location, if possible. Drinking caffeine isn't a long-term fix to staying awake. Lastly, if you have symptoms of a sleep disorder, such as snoring or feeling sleepy during the day, talk to your doctor or health care professional.

DUI (Driving Under the Influence)

Just like Drunk Driving, Driving Under the Influence of drugs is a crime - even if your impairment is due to prescribed medications or marijuana - medical or recreational.

I am sharing this information because we have seen an increase in these offenses every year and back to school is approaching so safety is a primary concern. By raising awareness of Distracted, Drowsy, and DUI

driving and the associated dangers, together we can both reduce and eliminate the dangers in and around our community.

Last, it must be mentioned again, as we did at the beginning of Summer Traffic Safety awareness campaign, motorist can stay alert for pedestrians when driving by:

- Scanning the street and the sides of the street ahead for people and animals.
- Looking for any foot traffic before making a turn.
- Keeping your windshield clean and utilizing your headlights in case of low visibility.

Avoid mobile phone, electronic devices or any other item that can distract you from the road.

GREEN @ HOME -- Goldenrod -- Weed or Biodiversity Superhero?

Do you think of goldenrod as a useless roadside weed?

This beautiful native plant plays an important role in our gardens. Entomologist Douglas Tallamy calls the goldenrods "one of nature's greatest gifts to animal life." They provide pollen and nectar for bees. They host many species of valuable caterpillars that feed birds. Their seeds feed birds and small mammals in winter. With its thick and intertwined roots, the plant prevents erosion and rainwater runoff, and builds topsoil.

Goldenrod belongs to the genus *Solidago*, in the aster family. There are about 100 species native to North America. The US Fish and Wildlife Service recommends 10 species for our Chesapeake Bay watershed gardens. Planting a variety of species can provide yellow blooms from June through November. And goldenrod fares well in drought.

By the way, goldenrod, pollinated strictly by animals, is *not* the culprit in hay-fever allergies. That dubious honor goes to wind-pollinated plants such as ragweed.

Do your garden and our wider environment a favor and add goldenrod to your plantings.

CHEVERLY NATIVE PLANTING PROJECT

CNPP is once again offering a 2-for-1 Native for Invasive Shrubs Trade! How the trade works is if you remove one invasive shrub from your yard, we will provide you with TWO free native shrubs. We can help with shrub identification and removal/planting for those who need it. The trade is first come, first served for up to 30 residents. There is a limit of **one trade** per home. Last year's participants can apply but will be put on a waitlist. If all the slots aren't filled, then we'll go to the waitlist.

If you have any of the following in your yard, you qualify for the trade: 1) Honeysuckle bush – any kind other than the native (*Lonicera* spp.); 2) Nandina (*Nandina domestica*); 3) Barberry (*Berberis* spp.); 4) Rose of Sharon (*Hibiscus syriacus*); 5) Burning bush (*Euonymus alatus*); 6) Privet- any kind (*Ligustrum* spp.); 7) Multiflora rose (*Rosa multiflora*); or Wineberry (*Rubus phoenicolasius*).

The shrubs we are targeting for removal cause harm to the environment. Some are so bad they can't be sold in many states. Native shrubs, on the other hand, provide a variety of benefits including increasing biodiversity and requiring less resources.

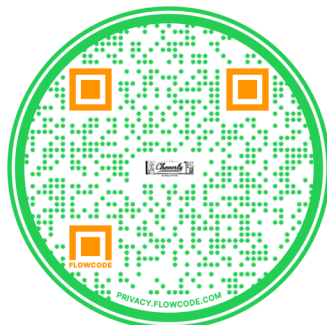
