# Odors and Booms, oh my!—how to report, air quality project, and next steps.

We need your help in logging extreme noise (booms) and foul odor incidents. Your first-hand reports help us establish a record of nuisance complaints. This reporting may also reveal any possible connections to specific industrial operations and connect data from our hyperlocal air quality monitors as we continue to install them throughout the Town. For odors, I, again encourage

you to help bring greater attention to the situation by calling the MDE (Maryland Department of the Environment) complaint line (410-537-3215) and following the prompts to report any significant odor in your area. For booms, please follow this link <a href="https://forms.gle/kvVWwE2a3wrtSoZv5">https://forms.gle/kvVWwE2a3wrtSoZv5</a> to report the incident via a google form. Note! Reports of the same incident from multiple individuals who personally experienced/observed a boom or foul odor is helpful, so please don't only rely on others reporting!

# Our Public Works facilities—a special presentation on the scoping phase of the project.

As I understand, "scoping" is the phase in the Project Development process that moves a recognized problem from an idea to the development of alternatives and preliminary screening of the situation for challenges. We have to continue moving forward on the construction of a new Public Works facilities. We are planning a special meeting in January focused on the scoping study results and next steps in the design and construction process.

## Redevelopment of Hospital Hill—your participation is critical!

The University of Maryland Prince George's Hospital Center is scheduled to relocate this spring. The County is prioritizing the redevelopment of this property into a premier housing/hotel / retail site. People are often surprised to learn that the properties that make up the Hospital Complex are not actually within the Town of Cheverly. Yet, this is the most-critical development matter to come before Cheverly in decades. I am committed to making sure that residents are informed and empowered and that Cheverly is a full partner in this process. I look forward to sharing the extraordinary opportunity that Cheverly offers with prospective developers and extending an invitation that we directly partner in the development process.

# Find out if you might have been exposed to COVID-19 while preserving your privacy!

On November 10, the Maryland Department of Health (MDH) announced MD COVID Alert, the official COVID-19 Exposure Notifications System for Maryland, available at no cost.

## Utility shutoffs are beginning – you have rights and need to take action now!

The Maryland Public Service Commission (PSC) prohibition on residential utility service shutoffs of WSSC, Washington Gas, Pepco, and landlines ended on November 15, 2020.\*\*

## PLEASE DO NOT DELAY! Reach out for assistance NOW to avoid utility shutoffs!

- Residential customers in arrears have 45 days from receipt of a notice to work out a payment plan with their utility or to apply for energy assistance programs.
- Customers who take either action will not have service disconnected.
- Utilities must offer a minimum payment plan of 12 months (or 24 months for those customers receiving energy assistance from the Office of Home Energy Programs).
- Utilities cannot require a down payment or deposit as a condition of beginning a payment plan for any residential customer, including both current and new customers.

Programs are available to assist with bill payment, and those who are facing termination have certain rights. Customers behind on their bills and facing a shutoff should first contact their utility to ask about extended payment plans, budget billing, or other measures to avoid service termination. If all of this is confusing and you need help, please call or email me, and I will assist in connecting you.

\*\*Mobile phone, internet, and VOIP are not protected from termination (shutoff); however, **if you have a student in PGCPS, WiFi assistance continues to be available!** PGCPS is covering the cost of the Comcast Internet Essentials program, which provides affordable high-speed internet at home for families eligible for free and reduced-price meals (FARMS). Non-FARMS families may obtain a Verizon hotspot for home internet access. Please make a request through your school or by calling the PGCPS Distance Learning Hotline at 240-696-6229, Monday through Friday, from 9 AM to 5 PM.

TOWN OF CHEVERLY CHARTER AMENDMENT RESOLUTION R-06-20

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OFCHEVERLY, MARYLAND, adopted pursuant to the authority of Article XI-E of the Constitution of Maryland and Title 4, Subtitle 3 of the Local Government Article of the Annotated Code of Maryland (2013 Edition, as amended), to amend the Charter of the said Town, said Charter being a part of the public local laws of Maryland (1963 Edition, as amended), which Article contains in whole or in part the Charter of the Town of Cheverly, Maryland, whereby the Mayor and Town Council increase the number of the Board of Supervisors of Elections from Three (3) to Five (5), permit early voting, same day voter registration and voting, and mail-in voting.

#### WINTER WEATHER REMINDERS

**TOWN CODE - Sec. 27-10—Parking**A snow emergency shall exist whenever snow has accumulated on the streets to a depth of one (1) inch or more. The provisions of this subsection shall be effective without any notification and shall remain in effect until the street is plowed; provided, however, that when snow shall accumulate to a depth of one inch or more after 11:00PM, the provisions of this subsection shall not be effective until 7:00AM the day following and shall remain in effect until the street is plowed.

PARKING RESTRICTIONS: During a snow

emergency no person shall park any vehicle as follows:

- On the cul-de-sac portion of any street,
- On any courts.
- On the even-numbered side of all streets,
- **(exception)** On the odd-numbered side of 59th Avenue, and one block of Inwood Street between Cheverly Avenue & Belleview Avenue.

**NOTE:** The snow emergency parking restrictions do not override existing no-parking zones or apply to streets where enforcement would disallow all parking because of a no-parking zone, or to streets with any barrier or strip dividing lanes of traffic.

**PRIORITIES:** The snow removal operations work under the following priorities: 1.) Cheverly Avenue 2.) principal connecting streets: Forest Road, Crest Avenue, Valleyway, Greenleaf Road, 62nd Avenue, State Street, Schuster Drive; 3.) all other streets.

TOWN CODE Sec. 18-4.1—SIDEWALKS Whenever snow accumulates to a depth of one inch or more, it is the duty of each occupant to clear the snow from the sidewalk adjacent to that property, within 12 hours after the snow ceases, (unless at night, in which case it shall be removed within 12 hours after sunrise). Snow and ice removed from sidewalks shall NOT be deposited on streets or other sidewalks.

When ice forms on sidewalks, occupant shall place sand, ashes or other such material on sidewalks within 6 hours, (unless at night, in which case it can be spread by noon of the next day).

Icy spots on public property can be reported to Public Works at 301-773-2666.

- **Motion to Support the Third Recommend of** the Cheverly Green Infrastructure which is that the Town of Cheverly Receive Periodic Notifications from MDE from the Developer: CM Munyeneh, seconded by CM Bryner.
- CM Munveneh clarified motion. Motion to Accept the Recommendation of the Cheverly **Green Infrastructure, That is Recommendation** Number Three and Make No Reference to the Comment Period: CM Munyeneh, seconded by CM Bryner. In favor, CM Garcia and CM Fry. Opposed by CM Watson. Abstained CM Radloff.
- Motion to Cheverly Council to Adopt the Reso**lution in Support of Black Lives: CM** Munyeneh, seconded by CM Garcia. Approved unanimously.

During the COVID-19 pandemic you may call Town Hall if you are unable to reach someone in Code Compliance.

**Residential Business License Program has** been suspended for Fiscal Year 2021 (July1 2020- June 30, 2021). We anticipate relaunching the program for FY22. Watch this space for more information to come in the Spring of 2021.

Homeland Security investigators are working with dozens of drug companies to identify scams. Over the last year, law enforcement has seen plenty of scams ranging from phony personal protective equipment, false cures and extortion schemes. With the Vaccine now available, it is important that we are aware of the potential scams that come with it. Keep an eye out for scam calls, text messages, and solicitors offering you quick or easy access to the vaccine. Please do not purchase any kind of coronavirus vaccine or treatment on the internet or from any online pharmacy.

As we do, new policies will become available in the Policy Manual and the old ones will be removed from "General Orders."

### **CPD Hiring**

The department continues to seek the right officers for the position of patrol supervisor. Residents who refer a candidate who receives a final offer of employment will receive a check for \$500.00!

## **Online Reporting**

In response to the COVID-19 pandemic, the department implemented an online reporting system for some non-emergency calls for service. These calls include auto tampering, destruction of property/property damage, lost property, theft from autos, and certain other thefts that don't rise to the level of burglary. Residents are encouraged to utilize this system, in lieu of the non-emergency number, for incidents that meet the requirements.

Tips@cheverlypolice.org is an email address that residents can use to send non-emergency tips or information to the department. Our investigators are constantly working to investigate criminal cases in which our residents have been victimized. If you have, or believe you have, information, photographs, or video that could assist the department, and you don't want to call, please send us an email. If you see someone in immediate danger, or a crime being committed, dial 911.

Cheverly's Mass Notification System is here! CodeRED allows residents to receive emergency alerts via text, email, or phone call. Upon signing up for the service, users can create a Managed Account, which allows the user to create a username and password and control the following:

- 1. Types of alerts received:
  - a. Emergency Alerts (Mandatory)
  - b. General Alerts (Optional)
  - c. Weather Alerts (Optional, as provided by the National Weather Service)

# HOW TO STAY SAFE WHEN A WINTER STORM THREATENS: Prepare NOW

- Know your area's risk for winter storms. Extreme winter weather can leave communities without utilities or other services for long periods of time.
- Prepare your home to keep out the cold with insulation, caulking and weather stripping. Learn how to keep pipes from freezing. Install and test smoke alarms and carbon monoxide detectors with battery backups.
- Pay attention to weather reports and warnings of freezing weather and winter storms.
- Gather supplies in case you need to stay home for several days without power. Keep in mind each person's specific needs, including medication.
- Remember the needs of your pets. Have extra batteries for radios and flashlights. If you are able to, set aside items like soap, hand sanitizer that contains at least 60 percent alcohol, disinfecting wipes, and general household cleaning supplies that you can use to disinfect surfaces you touch regularly.
- Create an emergency kit for your car. Include jumper cables, sand, a flashlight, warm clothes, blankets, bottled water and non-perishable snacks. Keep a full tank of gas.

# The Air We Breathe - Air Quality Monitoring Workshop



During 2020 Cheverly teamed with Univ. of Maryland's Community, Engagement, Environmental Justice, and Health Lab (see <a href="www.ceejhlab.org">www.ceejhlab.org</a>) to develop an Air Quality Monitoring (AQM) project led by Dr. Sacoby Wilson and PhD student Jan-Michael Archer. Purple Air sensors are now monitoring particulate matter air pollution levels at Town Center, the Cheverly Pool and Boyd Park. The monitors stream data to a map at <a href="www.greencheverly.org">www.greencheverly.org</a>. In January the AQM network will be expanded to include several places where people congregate and more host homes with proximity to industrial zones
