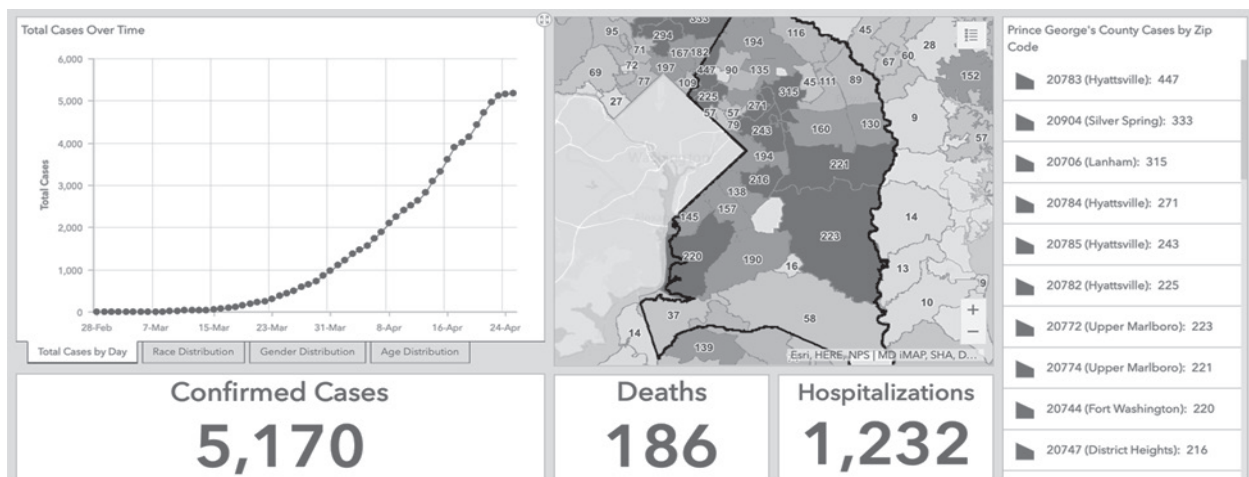
Mayor's Corner

Hello Cheverly Neighbors and Friends—Thank you for helping keep each other safe!

It appears our individual and collective actions may be flattening the curve, but this is NOT over. COVID-19 continues to pose a serious threat to public health and both the State of Maryland and Prince George's County are continuing to operate under a State of Emergency.

**Physical distancing and staying home as much as possible is helping.
Let's Keep it Up—Let's Not Give in to COVID-19 Fatigue!**

When you MUST go out, please COVER YOUR FACE and continue to PRACTICE PHYSICAL DISTANCING by maintaining at least six (6) to eight (8) feet between you and others (outside of those who live with you).

Understanding your COVID-19 protections and accessing support—please reach out!

I have heard from residents who are facing financial hardship and having difficulty accessing resources and support. If you are unable to pay your bills, I encourage you to make contact with your landlord, your mortgage servicer, credit card company, etc. Many companies are standing ready to help. This financial situation is

not your fault, and you do not have to go through this alone. If you are having trouble connecting or need a hand, reach out to me, and I will do my best to assist and partner with our county, state, and federal elected leaders to meet your needs.

Planning for COVID-19 impact on the Town of Cheverly—we need to take this seriously.

State officials are predicting a **\$2.8 billion loss in Maryland's general fund revenue** for just this fiscal year, and **Prince George's County forecasts a \$134 million drop in revenues**. The Town of Cheverly will not escape the financial impact of COVID-19. When Cheverly residents and businesses suffer losses and our county and state lose funding, the Town is hit hard as well. We are deep into our FY21 budget process. From everything we've seen, the effects of COVID-19 will impact both our current and FY21 budget. As part of our budget process, our Town Administrator outlined a "best-estimate" of impact across a half a dozen revenue sources that could result in close to a **\$500,000 loss in revenue for FY21**. Cheverly's fiscal year runs July to June, and the Mayor and Council will vote on the FY21 budget at the June 11 Town Meeting.

We are fortunate that our past Mayor and Councils built up a healthy fund balance, as we will need to draw upon some of these resources to help us continue to provide excellent services and plan through this next fiscal year. As we built out staffing in all departments in FY20 (a decidedly good thing), our operating expenses correspondingly increased. The list of projects in our draft budget—from audiovisual upgrades, to replacing the air conditioning in the gym, building a stone "Cheverly" sign to mark the entrance to the Old 4th Ward, fulfilling our commitment to building a new Public Works facility, and building a Cheverly Dog Park—represents governmental and community needs and wants. Still, the truth is that we can't afford to do all we planned. If we regard this next budget as "business as usual," we will dive so deeply into our fund balance as to leave us vulnerable for what could well be a tough FY22.

So, what does this say about property taxes?

My last year on Council (FY19), we lowered the single-family property tax rate from 54 to 51 cents for every 100 dollars of assessed value. We were in a sound financial position, and at .51, we could responsibly budget to provide excellent services and tackle needed projects. In FY20, we maintained the .51 rate to be prepared for increased staffing and project goals.

Considering the uncertainty of the financial situation leading into FY21, Mayor and Council voted to continue to hold the single-family tax rate steady at .51. As most property assessments increased, maintaining the rate at .51 will yield the Town an additional \$174,375 in revenue—*meaning we will exceed constant yield*. As a result, homeowners will experience an approximate \$70 increase in the Cheverly portion of their property taxes (or around \$6 per month).

I would have loved to have lowered our tax rate again this year, but the potential budget situation before us is serious. I believe the Council is coming to an agreement to postpone most projects, and I am advocating a hiring freeze across departments for FY21. I aim to cut close to \$1M from the draft budget and still fund some critical needs. We must take steps to become "shovel ready" for replacing the Public Works building, as our PW staff both deserve and need better working conditions. Residents of Cheverly Station deserve to have the Town newsletter delivered to their mailboxes, just the same as every other Cheverly resident, instead of stacked in the hallway. We must fund the removal, planting, and maintenance of trees. We have a list of "priority" trees that need cut or pruned due to hazard and decay; residents need access to a consulting arborist, and; we have fallen behind to a troubling degree on replacing trees lost to age, disease, and zealous removal. With every corner plagued by "water woes," we need to invest money in consulting an engineer to help us develop sustainable approaches. Thankfully, we have some road money to spend from FY20. We are also seeking opportunities, as by partnering with M-NCPPC to try to acquire land and fund and build a Cheverly Dog Park, something we otherwise could not afford.

I welcome your budget questions and your thoughts on approaching this next fiscal year. Thanks to the "can-do" spirit of our staff and the support of community, we've shown before just how well Cheverly can meet this challenge. Together, we will come out the other side stronger.

As a resident, you have essential protections during the State of Emergency in Maryland.

- Utilities: electric, gas, water, sewage, phone, cable TV, and internet service providers are prohibited from shutting off residential service or charging residential late fees.
- Maryland courts are prohibited from moving forward with a foreclosure or ordering the eviction of any tenant who can show that their failure to pay rent was the results of COVID-19, or because they are diagnosed with, or under investigation for, COVID-19.
- All licenses (including driver's licenses), permits, registrations, and other authorizations that would expire, are extended under the Governor's order.
- There is no waiting period to file for unemployment in Maryland, and you can file for full or partial unemployment for a number of COVID-19 related reasons. Businesses are also eligible for COVID-19 assistance <https://govstatus.egov.com/md-coronavirus-business>.
- The Maryland Health Benefit Exchange is establishing a special enrollment period through Maryland Health Connection specifically for the coronavirus (through June 15).



NOTICE

This notice is given by Dylan Galloway, Town Administrator, of the Town of Cheverly, Maryland, acting pursuant to the Proclamation of Governor Lawrence J. Hogan, Jr. (the "Governor") dated March 5, 2020, proclaiming a state of emergency and a catastrophic health emergency related to COVID-19, as it may be amended or renewed from time to time, and the Order of the Governor dated March 12, 2020, entitled "Extending Certain Licenses, Permits, Registrations, and Other Governmental Authorizations, and Authorizing Suspension of Legal Time Requirements," as it may be amended from time to time, after finding that the actions described herein will not endanger the public health, welfare, or safety.

The legal time requirements imposed upon the Town by Maryland Code, § 4-203 of the General Provisions Article, more commonly referred to as "Maryland's Public Information Act" are suspended until thirty (30) days have elapsed from the expiration of the state of emergency and public health catastrophe as determined by Governor Hogan. Section 4-203(b)(1) states "[a] custodian who approves the application [for a public record] shall produce the public record immediately or within a reasonable period that is needed to retrieve the public record, but not more than 30 days after receipt of the application." Accordingly, Maryland's Public Information Act ordinarily requires the Town to respond to approved requests for public information within ten (10) or thirty (30) days of receipt. These time requirements are hereby suspended.

This Notice is effective immediately and shall remain in effect until thirty (30) days after the state of emergency has been terminated and the proclamation of the catastrophic health emergency has been rescinded.

**TOWN OF CHEVERLY NOTICE
OF A PROPOSED
REAL PROPERTY TAX INCREASE**

The Mayor and Council of the Town of Cheverly proposes to increase real property taxes.

1. For the tax year beginning July 1, 2020, the estimated real property assessable base will increase by 5% from \$684,995,238 to \$719,186,376.
2. If the Town of Cheverly maintains the current tax rate of \$.51 per \$100 of assessment, real property revenues will increase by 5% resulting in \$174,375 of new real property tax revenues.
3. In order to fully offset the effect of increasing assessments, the real property tax rate should be reduced to \$.4858, the constant yield tax rate.
4. The Town is considering not reducing its real property tax rate enough to fully offset increasing assessments. The Town proposes to adopt a real property tax rate of \$.51 per \$100 of assessment. This tax rate is 5% higher than the constant yield tax rate and will generate \$174,375 in additional property tax revenues.

A public hearing on the proposed real property tax rate increase will be held at 7:30PM on May 7, 2020 at Cheverly Town Hall.

The hearing is open to the public, and public testimony is encouraged.

Cheverly's Mass Notification System is here!

CodeRED allows residents to receive emergency alerts via text, email, or phone call. Upon signing up for the service, users can create a Managed Account, which allows the user to create a username and password and control the following:

Types of alerts received:

Emergency Alerts (Mandatory)
General Alerts (Optional)
Weather Alerts (Optional, as provided by the National Weather Service)

Method alerts are received:

Via text message
Via email
Via phone call

Users can also perform a quick signup however, doing so would require the user to call CodeRED's customer service line in order to make any changes to the account.

Users are required to have either a residential or business address, within the Cheverly limits, in order to sign up for an account. The system supports multiple addresses, phone numbers, and emails.

TEMPORARY TRASH/YARD WASTE/ RECYCLING SCHEDULE

To support public health and safety of residents and employees, as well as further promote social distancing of Town employees, the Town of Cheverly will be temporarily changing trash collection to ONCE per week. Report Street Light Problems to Pepco

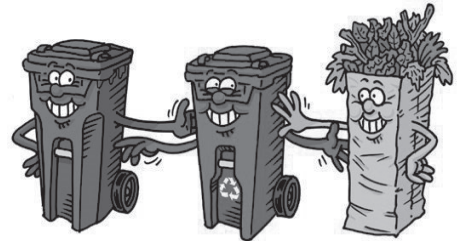

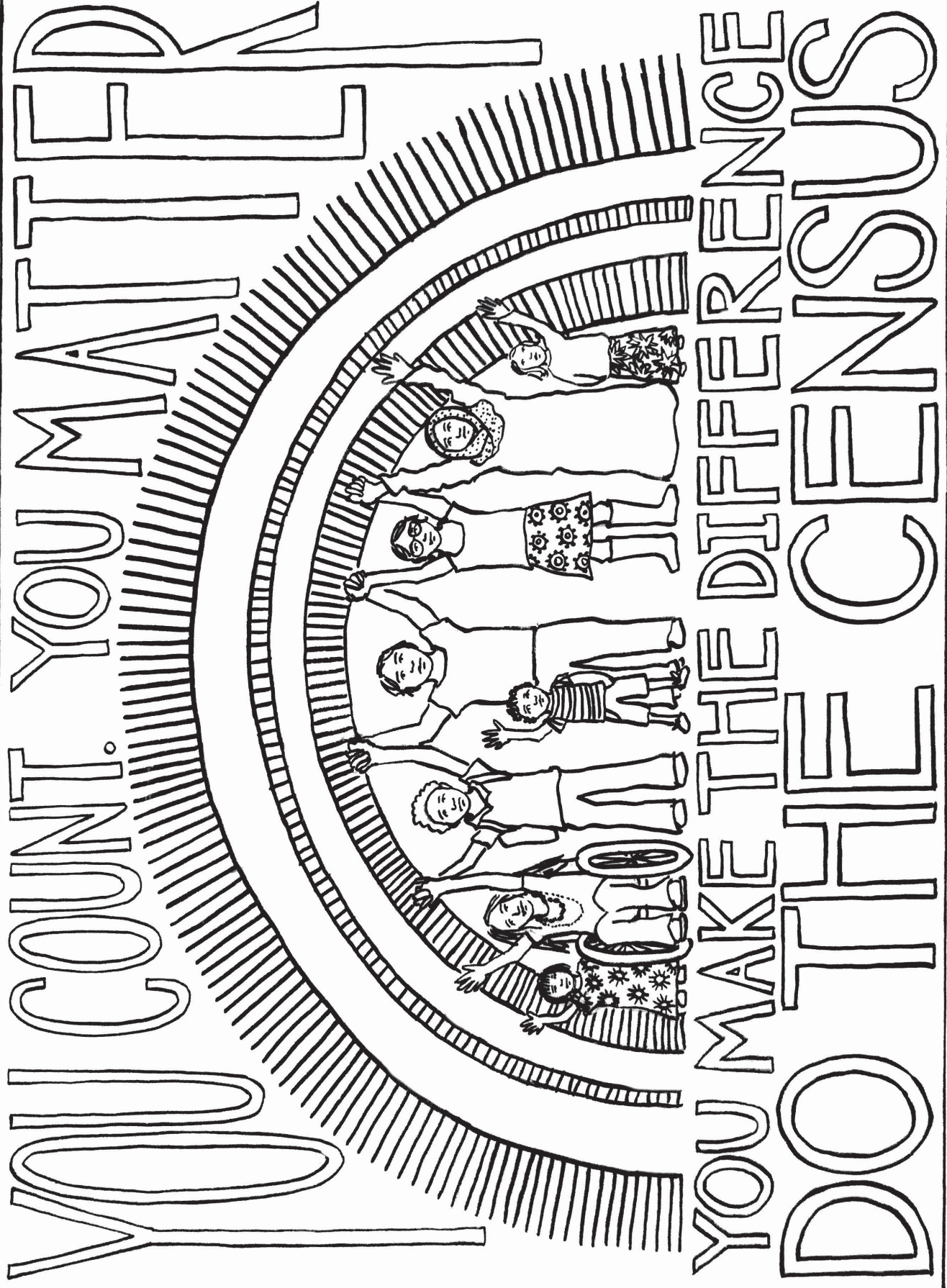

CLASS OF 2020

As a result of COVID-19, Town Hall is closed. However, we will continue to process Building Permits.

The Town's Code states that the erection, construction, alteration, or repair of any building or structure or the excavation therefor (except as provided below), or of any wall or fence, or of any artificial pond, pool or lake; or install or replace gutters, leaders and downspouts, drainage lines, private sidewalks, driveways, awnings or canopies, outdoor electronic broadcasting and receiving equipment, satellite dishes, carports, slabs, outside handrails, outside storage sheds, concrete or asphalt or brick (or combinations thereof) patios or paved areas of more than one hundred fifty (150) square feet, or undertake any other construction, alteration, repair, DEMOLITION, installation or replacement work requiring a Prince George's County building permit* unless such person shall first make application to and obtain a permit for such work from the town.

(*The Town of Cheverly requires a town building permit for all fences or barriers regardless of height, even if the county does not issue one.)

Please email your approved Prince George's County Permit, County Application and Site Plan to codecompliance@cheverly-md.gov for review. Code Compliance will verify the information and then forward it to the Town Clerk. The Town Clerk will inform you of the permit fee payable to the Town of Cheverly via check or money order. Once payment is received you will receive your Town of Cheverly Permit electronically. You will need to display the permit in a prominent location so it can be easily viewed.

To expedite the process, you may drop off your payment in the box in front of Town Hall labeled PERMITS. Code Compliance will check the box Mondays, Tuesdays, Thursdays, and Fridays between the hours of 8:00 am and 12:00 pm. Please contact Code Compliance to confirm they have received your permit fee: work can only begin after you have received your permit from the town.

How Are You Doing?

What about your family? How can we help? These are questions we have always asked Cheverly Village members, and now we are asking our volunteers as well. During the COVID-19 emergency we—like

many other Cheverly residents—have stepped up the frequency of those questions and we are responding with specific actions when necessary.

Twenty Village “Check-in Project” volunteers are making regular, sometimes daily, phone calls to Village members to check on their wellbeing and encourage their full compliance with the state-wide stay-at-home order. The volunteers assure members that they are not alone and that their medications and groceries can still be delivered to them in safe, no-contact ways. A shared spreadsheet and map help the Village ensure that all members are being reached.

The Village has found new ways to do other things, too. Team planning meetings now take place on Zoom. So do volunteer training sessions and the Village’s book club gatherings. We are trying to figure out how to move the “Scrabble and Games” sessions to some online tool (any ideas?)

While the Village’s most requested service, transportation to appointments, is severely curtailed, our second-most favorite service, tech support, is blooming. Tech volunteers have set up the tools to keep track of the Check-in calls, and they are providing one-on-one help to members unfamiliar with how to use the Zoom app. They are also helping all volunteers get signed onto our new website platform, which will offer greater opportunities for connection.

While the Village’s bi-monthly Tea Parties and our occasional potlucks have been suspended, we are enjoying a weekly “Virtual Happy Hour” on Fridays at 5 pm. Reminders are sent to members and volunteers. If you are neither yet and would like to make social isolation less isolating by joining us as a guest, let us know and we will make sure you get an invitation to this friendly Zoom event.

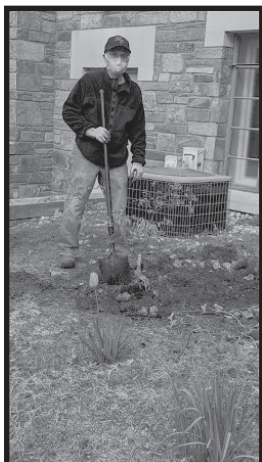

Mark your calendars for a JUNETEENTH CELEBRATION, co-sponsored by the Ward 4 Civic Association and the African American Community Organization (CAACO). The event **date has changed to Sunday, November 1, 2020** out of an abundance of caution concerning COVID 19 but also to honor the authentic date the slaves were freed in Maryland! There will be a flag raising ceremony at Town Park starting at 3 PM. Immediately following the flag ceremony, we will gather at Boyd Park to resume the Juneteenth celebration activities ending at 7 PM.

The celebration is free and will include dancing, singing, drumming, face painting, pouring of a libation, African storytelling, food vendors and other novel and interesting activities.

What is "Juneteenth" you might ask. It is a celebration of the day (June 19, 1865) that marked the end of chattel slavery for some slaves in the United States. Even though President Lincoln issued the Emancipation Proclamation in 1862, it did not affect slave holding states that remained in the Union. The official freeing of ALL slaves in Texas took place in 1865 when a Union general arrived in Galveston, Texas and issued General Order No.3. Whereas the official freeing of ALL slaves in Maryland took place on November 1, 1864.
