Sign Up Now!—We're bringing Cheverly Vaccine Clinics!

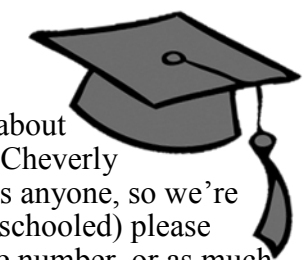

We hope to offer both clinics based out of our Cheverly Community Center and a mobile vaccine unit stationed outside of Cheverly Station Apartments. We are also looking to bring vaccines directly to homebound residents. In order to make this happen, we need everyone who has not yet been vaccinated to sign up, as in right now! Signing up expresses interest and you will receive a follow-up call to register for the clinic. Currently, we are looking to the

latter half of May to schedule the clinics, but it begins with having enough residents signed up as interested. Note! Do not be concerned--signing up for this opportunity does NOT affect any other registration lists, it's all about you receiving your vaccine as soon as possible. information as you have, so the team can follow up. Further questions or needs? You can call or text Cindy at 301-442-6025. Grad Bag delivery is planned for the first week of June and the team will continue with deliveries to grads as needed.

Redevelopment of Hospital Hill is happening—your participation is critical! Join your neighbors Tuesday, May 18, 2021 at 6:30 p.m. for a *second* community-wide meeting on the redevelopment in our backyard! What do you want the RDA to seek in a future developer?

The University of Maryland Prince George's Hospital Center is scheduled to relocate this spring. The County is prioritizing the redevelopment of the Hospital Hill property into a premier housing and retail site. People are often surprised to learn that the properties that make up the hospital complex are not actually within the Town of Cheverly! Yet, this is the most-critical development matter to come before Cheverly in decades. We last came together for a community-wide meeting to understand more about the redevelopment process, share our concerns, and offer our suggestions, in the beginning of March 2021 and the residents of Wards One and Two had the opportunity to more closely engage questions of the impact of possible hyperlocal vehicular, pedestrian, and bicycle connections through their wards. I have asked the RDA to return for a second community-wide Special Meeting because it is important that we again engage after having had some time to better understand what is asked of us at this time and the key requests we want reflected when the RDA sends out a Request for Proposals (RFP) for interested developers. TOWN OF CHEVERLY NOTICE OF A PROPOSED

REAL PROPERTY TAX INCREASE

The Mayor and Council of the Town of Cheverly proposes to increase real property taxes for real property excluding apartments.

1. For the tax year beginning July 1, 2021, the estimated real property assessable base will increase by 4.1% from \$752,547,772 to \$783,431,260 for real property excluding apartments.
2. If the Town of Cheverly maintains the current tax rate of \$.51 per \$100 of assessment, real property tax revenues will increase by 4.1% resulting in \$157,505 of new real property tax revenues.
3. In order to fully offset the effect of increasing assessments, the real property tax rate should be reduced to \$.4899, the constant yield tax rate.
4. The Town is considering not reducing its real property tax rate enough to fully offset increasing assessments. The Town proposes to adopt a real property tax rate of \$.51 per \$100 of assessment for real property excluding apartments. This tax rate is 4.1% higher than the constant yield tax rate and will generate \$157,505 in additional property tax revenues.

A public hearing on the proposed real property

tax rate increase will be held at 6:30 PM on May 11, 2021 over Zoom.

The hearing is open to the public, and public testimony is encouraged.

VACATIONS & HOME SECURITY

Residents planning to be away for vacations should call the Cheverly Police **(301-341-1055)** to arrange to have their homes checked while they are gone.

The following items should also be checked to make sure your residence is safe and looks as much as possible like someone is there:

- Cancel newspaper & mail delivery or have a neighbor pick it up for you.
- Arrange for lawn care.
- Valuables should be stored, preferably in a bank.
- Store lawn mowers, bicycles, and lawn furniture inside.
- Lights inside the house should be set on a timer.
- Set telephone bells as low as possible.
- Shades and drapes should be drawn.
- Cars left in the driveway should be locked.
- Make sure smoke detectors are working.
- All windows and doors should be locked.
- Give your house key & itinerary to at least one friend or neighbor.

SOLID ANIMAL WASTE ORDINANCE



Sec. 4-10 (a) It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person

without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, & play areas of all other parks.

TRASH COLLECTION REMINDER

Sec. 10-7 Except for household trash, which the town may collect from side or rear yards, all collectible trash shall be placed at the street side or curb, but shall not be placed there earlier than 7:00 p.m. on the day before it is scheduled to be collected. All containers or uncollected trash and waste must be removed from the

street side or curb by 7:00 p.m. of the day it was scheduled for collection. Upon request of a resident to the town administrator and for good cause shown, the town may collect recyclables from a side or rear yard of the property.

GRASS, WEEDS AND OVERGROWTH

Obstructions

1. Residents are reminded that with the nice weather more and more residents are out walking. Please keep the walkways and sidewalks clear of overgrowth and obstructions.
2. Keep vegetation from obstruction of the view near intersections.

Lot Maintenance

1. Residents are reminded to make sure your grass is cut before it reaches 8 inches in height.
2. The planting strip between the sidewalk and the street is your responsibility to maintain.
3. If you are going on vacation, make sure to make arrangements to have your grass cut for you.
4. Be sure to take into consideration that the weather can be unpredictable, but the grass still needs to be cut.

RESIDENTIAL BUSINESS LICENSE

Residential Business License Program has been suspended for Fiscal Year 2021 (July1 2020- June 30, 2021). We anticipate re-launching the program for FY22. Watch this space for more information to come in the Spring of 2021.

Soliciting in the Town of Cheverly is prohibited without a Town permit. Hand delivered advertisement is not considered a solicitation. If an unpermitted solicitor is in your neighborhood or you need a Town soliciting permit contact Code Compliance at 240-770-7647. During the COVID-19 pandemic you may call Town Hall if you are unable to reach someone in Code Compliance

REPORT STREET LIGHT PROBLEMS TO PEPCO

- If you are having any problems with street lights, they are out, blinking on and off, etc., you can contact Pepco directly. Go to www.pepco.com, go to Outages, and click on Report a Street Light Outage. Then you will be asked for either the address or pole number. It will then come to a map showing the street lights in the area, click on the street light you wish to report, and lastly they will ask you for some information about the light and your contact information.

RESIDENTIAL ZONE PARKING

Residential ZONE parking permits are now available. The price of the permit is \$5 per vehicle with 1 free guest pass per address. A second guest pass may be obtained for \$2. (Only two guest passes per address.)

Applications can be downloaded from the Town website at www.cheverly-md.gov under form and file center tab.

Please drop completed applications in the permits box located at Town Hall or mail to: Code Enforcement, 6401 Forest Road, Cheverly, MD 20785.



Cheverly Residential Zone Parking Permit Application

Due to the Covid19 restrictions applications for Zone Permits will only be accepted by US Mail or placed in the mailbox located on the left-side wall of the main entrance at townhall.

- Permits can only be issued to vehicles registered in a Cheverly Address.
- A copy of your vehicle registration must accompany the Application.
- Cost of the Permit is \$5 per vehicle | 1 Guest Parking Pass is allowed **per residence** at no cost.
- An additional Guest Parking Pass is available for \$2. (No More Than 2 Guest Parking Pass per Address)

If you live in one of the following areas, you will need a Parking Permit:

Zone 1: State St, 61st & 62nd Ave, as well as the 1800 Block of 64th Ave

Zone 2: Eliminated

Zone 3: 22-2400 Block of Cheverly Ave

Zone 4: Arbor St & Crestlawn Ave (22-2300 Block Parkway Eliminated)

Zone 5: 2300 Block of Belleview Ave

Zone 6: Benton Rd & 23-25 Lake Ake

Zone 7: 2400 Block of Valley Way

Zone 8: 3300 Belleview Ave; Medical Ter

SR: This permit allows senior citizens 65 years of age and older to Park in the Odd Side of the 2200 Block of Cheverly Ave in order to utilize the Metro

Residential Parking Permit are to be Displayed on the Back Left Bumper area.

If you have a regular and a SR permit, display them next to each other on the Back Left Bumper.

Guest Parking Permits shall be hung on the REARVIEW mirror with information facing outward.

Town Code 27-5.1 Residential Zone Parking**

TRASH SCHEDULE

Mondays (Town Wide) Yard Waste Pick Up

Mondays (East Side) Trash Pick Up

Tuesdays (West Side) Trash Pick Up

Wednesdays (Town Wide) Recycling Pick Up

Thursdays (East Side) Trash Pick Up, including Bulk Trash Pick Up (**3 Items Limit**)

Fridays (West Side) Trash Pick Up, including Bulk Trash Pick Up (**3 Items Limit**)

Note: Bulk Trash is limited to 3 items and only on the days listed above.

Please have your Regular Trash, Bulk Trash, Yard Waste and Recycling at the curb before 7AM. Crews will start 7:30 AM. Please help the Public Works crew out by not parking in front of the yard waste, trash, recycling, and bulk trash. The picture below, shows how difficult it can be for the crew when there's a vehicle parked. Please do not put Yard Waste and Recycling in plastic trash bags.

The Cicadas are Coming, The Cicadas are Coming: The Truth About the Brood X Periodical Cicada

Information from the Town Arborist Dr. Tolbert Feather

The periodical cicada in this area, Brood X, will emerge this year and is one of many broods that reappear every 17 years. The periodical cicadas have black bodies and red eyes and emerge in mid-May (when ground temperatures reach $>64^{\circ}\text{F}$) completing their life cycle by the end of June.

Although the adults do feed on woody plants, potential damage to trees and shrubs occurs when the female cicadas insert eggs into the tips of twigs. Sufficient damage can cause the loss of the tips of branches. On large trees, this loss is not noticeable. On smaller trees, it can significantly reduce the canopy, but even smaller trees do recover.

Residents can isolate young trees with screening in May (netting with 1-cm or 3/8-inch mesh) to prevent damage, but there are no treatments to manage the cicadas. Cicadas have little interest in annuals and perennials. Newly emerged cicadas may be seen resting or emerging on non-woody plants, but they will soon thereafter move up into the trees.

The distinctive “singing” or mating call is the first sign that the little wide-eyed creatures are active. Although their appearance may seem ominous, cicadas do not bite people or carry or transmit any diseases. They are a true wonder of nature and a great food source for birds and small mammals.

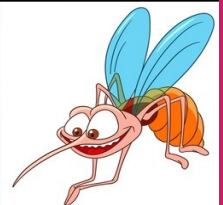

Online Reporting

In response to the COVID-19 pandemic, the department implemented an online reporting system for some non-emergency calls for service. These calls include auto tampering, destruction of property/property damage, lost property, theft from autos, and certain other thefts that don't rise to the level of burglary. Residents are encouraged to utilize this system, in lieu of the non-emergency number, for incidents that meet the requirements

All reports can be requested, via email, at reports@cheverlypolice.org. When submitting your request, please include as much information as possible, that pertains to the report. In addition, for identification

purposes, a photocopy of the requesting party's ID will need to accompany the request. In response to the state of emergency, all fees associated with report requests have been waived.

Tips@cheverlypolice.org

Tips@cheverlypolice.org is an email address that residents can use to send non-emergency tips or information to the department. Our investigators are constantly working to investigate criminal cases in which our residents have been victimized. If you have, or believe you have, information, photographs, or video that could assist the department, and you don't want to call, please send us an email. If you see someone in immediate danger, or a crime being committed, dial 911.

Cheverly's Mass Notification System is here! CodeRED allows residents to receive emergency alerts via text, email, or phone call. Upon signing up for the service, users can create a Managed Account, which allows the user to create a username and password and control the following:

1. Types of alerts received:
 - a. Emergency Alerts (Mandatory)
 - b. General Alerts (Optional)
 - c. Weather Alerts (Optional, as provided by the National Weather Service)
2. Method alerts are received:
 - a. Via text message
 - b. Via email
 - c. Via phone call

Users can also perform a Quick signup however, doing so would require the user to call CodeRED's customer service line in order to make any changes to the account.

Users are required to have either a residential or business address, within the Cheverly limits, in order to sign up for an account. The system supports multiple addresses, phone numbers, and emails.



The Air We Breathe -- Do You Smell What I Smell?

Periodically Cheverly experiences bad smells in various neighborhoods. We hope we might be able to correlate the bad smells with particulate matter detected by our Purple Air sensors. To do so we need residents to record bad smell events with location, date and time of events. There's an app for that, and we encourage everyone with a smartphone to download the free Smell MyCity app, [https://](https://smellmycity.org)



smellmycity.org. When you experience a bad smell, the app lets you easily record key features in a pull down menu and capture the GPS location and time of the event. Data is sent to the Smell MyCity public website where it can be aggregated with other shared reports and downloaded for further analysis. Collecting bad smell event reports, combined with the air quality data from our network may provide some insights to our air quality challenges.

Get Smell MyCity for your phone today. Share your reports as they happen and help solve the bad smell problems.

Cheverly's Air Quality Monitoring Project

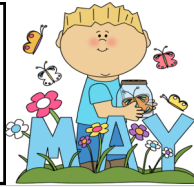
The Cheverly Green Infrastructure Committee continues its work with the University of Maryland's Community, Engagement, Environmental Justice, and Health Lab (www.ceejhlab.org) to develop the Air Quality Monitoring (AQM) Purple Air sensor network. You can read the air quality index values throughout town by visiting www.PurpleAir.com and view the map for Cheverly. You can also find the map at www.greencheverly.org. We are well on our way to developing our air quality baseline data set. In January and February 2021 the UMD team led three workshops giving an overview of the Cheverly AQM project, the role of community engagement, air quality and public health, and guidance on ways to access our Purple Air data. The workshops were recorded and can be found at www.greencheverly.org. More informative events are anticipated, especially when we can safely get together to learn more about our air quality and what we can do to protect our health.
