MAYOR'S CORNER

Pushing back on COVID-19 fatigue—staying physically protected and socially connected.

Over these next few months, I ask each of us to work together to find ways we can be both physically protected and socially connected. National and local COVID-19 trends are concerning. As I write the Mayor's Corner, our state has experienced its highest daily death toll since late August, and Prince George's County is accounting for the largest share of new cases. Seeking the togetherness, we crave (especially indoors) can increase our physical risk. Just as important, as we physically separate ourselves from those we love and are forced to break familiar traditions, our mental well-being can suffer. It is okay not to be okay with all of this. It is healthy to reach out to family, friends, community, and mental health wellness professionals for support and for us to encourage each other to do so. Stay safe and be well.

WSSC Unidirectional Flushing—focusing on resolving ongoing brown water concerns.

This work will focus on the west side of Cheverly. Residents in the area of Dewey, Carlyle, and Crest have experienced repeated occurrences of brown water, dating back at least five years. Until now, the response from WSSC has been limited to local hydrant flushing and has proven absolutely inadequate in addressing resident concerns. Over the past several months, CM Ward 2 Micah Watson, Town Administrator Galloway, Public Works Director Brayman, and I have worked together to impress upon WSSC the continuing unacceptability of this situation—and WSSC is listening. This "heightened" response will involve a couple of weeks of evening flushing (or scouring) of the water lines in 1200ft sections throughout much of Cheverly's west side. If you will be affected, you should receive a letter with information on the work and on how to properly flush your cold-water lines afterward. You should also receive additional notice more immediately prior to work on your particular stretch of water line. Although you may experience a reduction in water pressure, there should be no interruption in service due to this process. This unidirectional flushing has offered extended relief to other communities facing water conditions similar to ours, and I hope we enjoy the same success.

Tired of the stink?—requesting timely response and state and county support.

Regarding the noxious odors we keep experiencing, I am asking you to help bring greater attention to the situation by calling the MDE (Maryland Department of the Environment) complaint line (410-537-3215) and following the prompts to report any significant odor in your area. I understand that we have become conditioned to believe that we know the odors' source, but County and direct observation have not tied the odors to any of the "known" sites. We are reaching out to both the state and county environmental departments (MDE and DoE) to ask for direct attention to this recurring nuisance and health concern. I apologize that we have to keep experiencing this. It's absolutely unacceptable that we can't enjoy our outdoors and understandable that people are concerned about what all of us are breathing!

National Register of Historic Places Nomination—welcoming an expanded survey!

Please look to a letter from me asking you to welcome the Ottery Group as they return to our community for an expanded survey at the Town's request. The Ottery Group staff will be photo-documenting houses and streetscapes to prepare an inventory of our historically significant resources. This inventory is part of an effort to nominate Cheverly to the National Register of Historic Places, with financial assistance from the Prince George's County Planning Department and support from Prince George's County. As you may recall, following the original nomination's completion in the winter of 2020, the Town requested additional funding for survey and research to expand the geographic boundaries included in the nomination. The nomination is scheduled for completion in the spring of 2022. Review the letter for more information.

Election legislation before Mayor and Council—charter amendments, hearings, and votes.

A proposed Charter amendment to establish non-citizen voting will have its third and final reader and go before Council for a vote at our 12 November 2020 Town meeting. The hearing remains open, and resident input is encouraged. Cheverly's Board of Election Supervisors has asked that the Mayor and Council consider four additional Charter amendments to allow for same-day registration, early voting, vote-by-mail balloting, and two additional supervisors to the board. Charter amendments require a dedicated hearing with a minimum 21-day notice so residents can speak to the issues involved and ask questions for follow-up. Watch for a possible special meeting in November to begin the hearing and reader process. Staff will make the proposed amendments and

timeline available via "News and Announcements" and social media. Preparing for the Monday, 3 May 2021 Town elections will be a multi-month process and will require a great deal of collaboration between Town staff and the Board of Election Supervisors.

Community Caring and Sharing and Town Tree Lighting—think creative connections!

Even though we won't be able to gather as we have become accustomed, we are definitely looking for ways to be "Cheverly connected" and offered some most-loved traditions. This year, we will shift to an entirely outdoor (masked and distanced) DAYTIME celebration on Saturday, 5 December, from 2–4:25 PM at American Legion Park. We are considering offering bulletin boards throughout the park for everyone to leave season's greetings and uplifting messages for 2021, an opportunity to record and share video greetings, and to continue our tradition of bringing non-perishables to help those in need and greeting cards for the Veterans Hospital. We believe that we can safely support packaged gingerbread cookies and are examining how we might safely offer warm cider. We would also like to provide an outdoor "Cheverly in winter" photo opportunity since Santa Claus is observing COVID-19 precautions. Please reach out! We welcome your ideas and support in making this year's event "all things fun and community!"

Veterans Day—options to connect and honor Cheverly servicemembers past and present.

Cheverly American Legion will hold a physically distant Veterans Day Ceremony, organized by the Sons Squadron, at Legion Park at 10 AM on Wed 11/11. Attendees should maintain six feet distance from others and wear a mask. Veterans who plan to attend should contact Micah Watson at 240-603-9366 to be recognized for your service. The event will also be live-streamed.

It feels good to have community in the room, even if it is virtual.

Utility shutoffs are beginning – you have rights and need to take action now!

The Maryland Public Service Commission (PSC) prohibition on residential utility service shutoffs of WSSC, Washington Gas, Pepco, and landlines ends 15 November 2020.**

PLEASE DO NOT DELAY! Reach out for assistance NOW to avoid utility shutoffs!

- Residential customers in arrears have 45 days from receipt of a notice to work out a payment plan with their utility or to apply for energy assistance programs.
- Customers who take either action will not have service disconnected.
- Utilities must offer a minimum payment plan of 12 months (or 24 months for those customers receiving energy assistance from the state's Office of Home Energy Programs).
- Utilities cannot require a down payment or deposit as a condition of beginning a payment plan for any residential customer, including both current and new customers.

Programs are available to assist with bill payment, and those who are facing termination have certain rights. Customers behind on their bills and facing a shutoff should first contact their utility to ask about extended payment plans, budget billing, or other measures to avoid service termination. If all of this is confusing and you need help, please call or email me, and I will assist in connecting you.

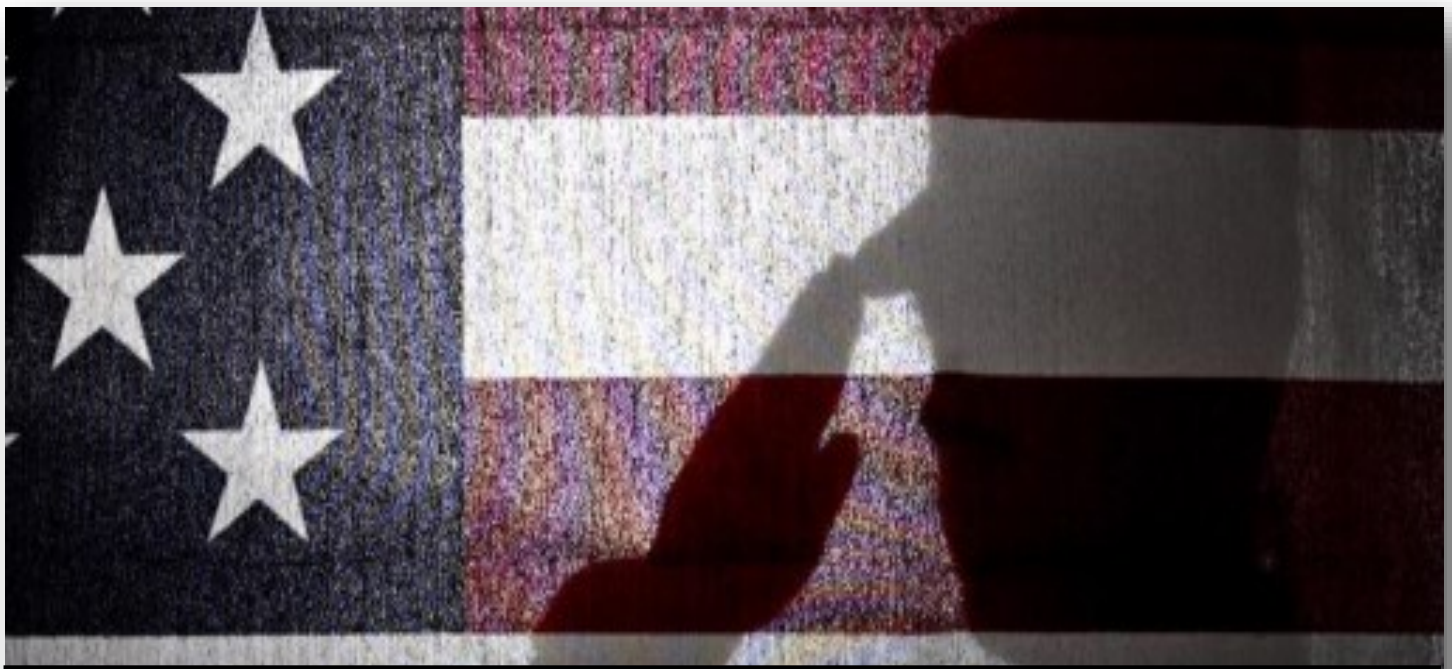
****Mobile phone, internet, and VOIP are not protected from termination (shutoff); however, if you have a student in PGCPS, WiFi assistance continues to be available!** PGCPS is covering the cost of the Comcast Internet Essentials program, which provides affordable high-speed internet at home for families eligible for free and reduced-price meals (FARMS). Non-FARMS families may obtain a Verizon hotspot for home internet access. Please make a request through your school or by calling the PGCPS Distance Learning Hotline at 240-696-6229, Monday through Friday, from 9 AM to 5 PM.

NOTICE OF PUBLIC HEARING **DECEMBER 10, 2020** **AT 7:00 PM VIA ZOOM**

The Mayor and Town Council have received and reviewed the Petition Request for have a traffic analysis at the intersection of Lockwood Road and Crest Avenue.

Also, included is that section of the Town Code that describes the procedures to be utilized during the processing of the request. If you have any questions, please feel free to contact the Town Offices at 301-773-8360.

(d) Procedures for public hearing on traffic calming petitions:

(1) Conduct of public hearing:

a. After having been notified by the town clerk that a valid petition has been received, the mayor will schedule a public hearing to solicit the opinions of the entire neighborhood and the town at large.

b. The town clerk shall send notice of the public hearing to all residents of the street, or block as the case may be, which is proposed to receive speed hump action, and to the local neighborhood citizen association. The public hearing shall be advertised in the Cheverly Newsletter.

c. After conducting the public hearing and declaring the hearing record closed, the mayor and council shall announce its decision within fifteen (15) days of the close of the hearing record. Under extraordinary circumstances, this time limit may be extended by majority vote of the council.

d. The mayor and council may approve, approve with modifications, or deny the requested speed hump installation.

e. The town clerk shall notify the petitioners, and their neighborhood or civic association of the mayor and council's decision, which shall also be published in the Cheverly Newsletter.

(2) Guidelines for evaluating public hearing.

The following criteria are intended to guide the mayor and council in determining whether a request for speed hump action is reasonable and justified. These shall not be considered exclusive criteria:

a. The street proposed for a speed hump installation has an identified speeding problem which cannot be alleviated in any other reasonable way than by a speed hump installation. Such a problem can be identified through a combination of resident complaints, police radar surveillance and ticketing practices, accident statistics, or history of previous efforts to control speeding on the street.

b. The street carries a higher volume of non-residential traffic than would normally be expected.

c. The street has not been identified and is not used by the fire departments serving Cheverly as the primary fire and rescue route into Cheverly.

d. The installation of speed humps be assessed for their potential impact on public transportation.

e. The potential impact of speed humps on adjacent neighborhoods be assessed.

f. A technical study provided by the director of public works commenting on any hill, curve or street conditions of concern in the placement of the desired hump(s) will be assessed.

CPD's Video Communications Trailer

As discussed in our Town Meeting on October 8th, 2020, the department has obtained possession of our new video communications trailer. This new piece of equipment was obtained as part of the town's COVID-19 grant funds and when fully functional, will provide the department with the capability to provide information to the residents without actually dispatching officers to the area or subjecting residents or officers to potential exposure. Some of you may have experienced similar equipment while out shopping since the outbreak of COVID-19. Walmart, Home Depot and several other big box stores have very similar trailers in their parking lots.

Use of Force Policy

The draft Use of Force Policy is now available on our website at CheverlyPolice.org, Cheverly Police Department's Facebook page, and has been disseminated via News and Announcements. Our consultant, Ms. Ganesha Martin has diligently worked to draft and stage a new Use of Force Policy. She will host a community discussion by early December. We will update you on our website, Facebook, and via News and Announcements on the date and time of that community discussion. Residents who wish to provide feedback on the policy may do so confidentially by sending an email to Ganesha@meetmeinthemiddle.com. This is an extremely important policy that guides and restricts how our police department operates in Cheverly. We ask that residents please take the time to review the policy and provide Ms. Martin with feedback. One of the goals of our department is to ensure that its Use of Force Policy is indicative of Cheverly's values while providing our officers the necessary framework to protect the community and themselves.

Online Reporting

In response to the COVID-19 pandemic, the department implemented an online reporting system for some non-emergency calls for service. These calls include auto tampering, destruction of property/property damage, lost property, theft from autos, and certain other thefts that don't rise to the level of burglary. Residents are encouraged to utilize this system, in lieu of the non-emergency number, for incidents that meet the requirements.

In response to the state of emergency, all fees associated with report requests have been waived.

Tips@cheverlypolice.org is an email address that residents can use to send non-emergency tips or information to the department. Our investigators are constantly working to investigate criminal cases in which our residents have been victimized. If you have, or believe you have, information, photographs, or video that could assist the department, and you don't want to call, please send us an email. If you see someone in immediate danger, or a crime being committed, dial 911.

Cheverly's Mass Notification System is here! CodeRED allows residents to receive emergency alerts via text, email, or phone call. Upon signing up for the service, users can create a Managed Account, which allows the user to create a username and password and control the following:

1. Types of alerts received:
 - a. Emergency Alerts (Mandatory)
 - b. General Alerts (Optional)
 - c. Weather Alerts (Optional, as provided by the National Weather Service)
2. Method alerts are received:
 - a. Via text message
 - b. Via email
 - c. Via phone call
 - d.

Users can also perform a Quick signup however, doing so would require the user to call CodeRED's customer service line in order to make any changes to the account.

Progressive Cheverly *Celebrating 15 years of community engagement in 2020*

As a follow up to the Sep. 25 Legislative Forum with Maryland District 47 representatives Senator Malcolm Augustine and Delegates Julian Ivey, and Diana Fennell, Progressive Cheverly hosted a discussion on legislative priorities in response to their request for input for the upcoming 2021 General Assembly. Highlights included overrides of the Governor's vetoes in 2020, addressing COVID response, enacting sources of revenue to support the Kirwin and HBCU legislation and community schools, criminal justice reform, behavioral health initiatives, addressing climate change, protecting the environment, emphasizing public transportation (esp. Purple line) and expanding social infrastructure (e.g., child care voucher assistance) to allow people to work.

Obviously 2021 will be challenging year on a number of fronts, most especially because of the financial repercussions of the pandemic. As the General Assembly gets underway we may be able to tie our recommendations to specific bills. Indeed, Senator Augustine noted specific legislation regarding behavioral health and banning of single use plastics as examples where we might follow up. Both he and Delegate Ivey specifically encouraged people to communicate your own priorities or concerns to your representatives directly.

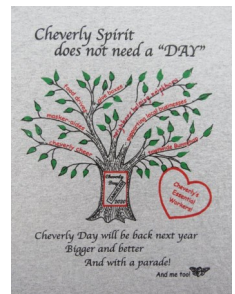

Cheverly Police Chief Advisory Board

(PCAB) During the October 2020 PCAB meeting we discussed the need to have scheduled Voices of Our Community, which will allow 30 minutes for Residents only, to speak with the Board about their public safety concerns. We have used this information to help guide discussions with the police chief. Thank you to those who have utilized this resource. Our Monthly Meeting will start at 7:30pm, all are invited. PCAB is excited to announce its Doorbell Camera Rebate Program which will subsidize the cost of outdoor security cameras for Cheverly residents, please see the information below.

PCAB Doorbell Camera Rebate Program: The program incentivizes Cheverly residents to install outdoor cameras to improve surveillance and security within our community. It will be available to all residents of Cheverly, including renters if allowable by the terms of their lease. One of the important aspects of CPD is to conduct Home Security Surveys, and implementation of this program will increase the opportunity for CPD to conduct those surveys and to provide residents with useful tips to increase security in and around their homes. Applications are accepted on a first-come, first-served basis, and are not to be submitted until AFTER cameras have been installed. Those who apply must provide proof of purchase documents that detail the date, number, type, and cost of cameras, as well as documentation of payment made. This program is limited to cameras purchased and installed within the past 6 months of the application date.

To apply for a rebate, the following steps must be completed:

1. Purchase and install the camera(s).
 2. Complete the Private Security Camera Rebate Program Application: <https://forms.gle/oZXKkNF13LfYdSSr6>
 3. Submit this application.
 4. Sign up for a Home Security Survey
- Submissions are kept confidential, all information is required.

Upon submission and acceptance of a completed application residents will be contacted by the Police Department to schedule a Home Security Survey, which will include testing of the installation to determine whether the camera is working properly and functioning as intended. Upon approval of the camera installa-

tion and function, the resident will be issued a check for \$50 per camera installed, up to \$100 per household.

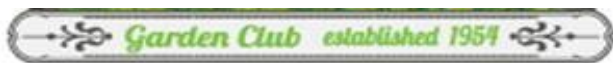
