Message from the Mayor

Movember is an annual event involving the growing of moustaches during the month of November to raise awareness of men's health issues, such as prostate cancer, testicular cancer, and men's suicide. Don't forget to encourage the men in your life to get medical checkups and consider well visits for their own health.

I want to be sure to highlight the Prince George's County Beautification Awards. The Cheverly Police Department received The Prince George's County Beautification Award for Community Entrances and/or Common Areas. Many kudos go to the Cheverly Native Planting Project, which designed, planted, and maintained an entrance garden for the police department. We received that award and many others. Our residents really took home the prizes, and many kudos to Yard of the Year, which went to Diane Beedle!

Now, speaking of the police. Many of you participated in our second Public Safety Forum. We had a robust discussion about methods we can use to work as a community to keep Cheverly safe, and we also talked about recruitment and retention for the Cheverly Police Department. I want to thank everyone who participated in the discussion, especially the victims and survivors of crime. As a survivor, I know the old adage that time heals all wounds does not always apply to victimization. Being the victim of a crime forever changes your sense of safety and significantly impacts your worldview. You are never the same. That being said, I know that Chief Morris is working to onboard several new officers to bring the police department back to capacity. As you heard, CPD has been authorized to take necessary steps to provide compensation packages that both recruit and maintain quality officers. I feel confident that we will continue to see improvements in staffing issues.

I am also confident that our community's response to crime will thwart any opportunistic bad actor. In no way do we want to encourage vigilantism. The worst thing that could happen is that our neighbors feel unsafe because community members take the law into their own hands. That erodes the sense of community we need to fortify safety. But we can plug in and engage. We had over two hundred participants in the Public Safety Forum. You heard me commit to having the forums quarterly and continue to work to improve communication about crime in our area. I will reiterate that our community is one of, if not the safest, in the near vicinity of the District of Columbia. Our violent crime increased from eight victims last year to twenty this year. When you compare that to the municipalities around us, it pales in comparison. Now, it is important to note that it only pales if you are not one of the twenty victims who experienced victimization. Nothing can make someone feel safer after they have experienced crime more than catching the perpetrator. I am happy to report that we were able to announce one day after the Public Safety Forum that the perpetrator of the shooting on Cheverly Avenue was apprehended.

The Cheverly community has a great deal to do with the arrest of this perpetrator. I am so thankful we live in a place where neighbors were forthcoming and shared camera footage. This was a tremendous help in evidence collection and, ultimately, in catching the perpetrator. Please remember that it is not just a catchphrase or cliché; if you see something, say something. Some of you agreed to sign up for our Neighborhood Watch and Police Chief's Advisory Board. We need way more volunteers to really flesh out these programs. If you are interested, please shoot me an email at Mayor@cheverly-md.gov. As promised, you can look out for a short weekly communication with updates about the town, including public safety matters. I will also encourage you to attend our town meetings or join us online. We are often discussing some of the very issues that are of concern to you.

We don't want to forget that November includes Indigenous Peoples Heritage Month, sometimes referred to as Native American Heritage Month. It is a time to celebrate the rich histories, diverse cultures, and significant contributions of our nation's first people. Look for ways to learn about and honor our American Indians and Alaska Natives.

Lastly, every year, I ask: What are you thankful for? I never get a lot of responses, but I am always encouraged by what you share! Let's see if I can get more this year. What are you thankful for? Drop me a note at Mayor@cheverly-md.gov.

Mayor's Mention is to those who won the Jack Wheat and Volunteer of the Year Awards: Ahjah Prom, Josue Reyes, Ms. Vee Carter, and Gabe Horchler. Mayor's Mention is also to the Cheverly Police Department, they may be few in number, but they still handle the majority of our calls and seek to be the assets to our community we so appreciate. Here is to the start of a safe and happy holiday season!

RESIDENTIAL BUSINESS LICENSES

If you are currently operating a business out of your home, you are required to obtain a Town Residential Business License.



Home occupations are under (Chapter 9 of Town Code) and (subtitle 27 of the Prince George's County Code) and do not include any retail business or trade, etc.

Town Residential Business Licenses are issued annually for the Fiscal Year (July 1 to June 30). Please call the Town Clerk at 301-773-8360 or stop by the Town Office to pick up an application form.

The yearly business license fee is \$20.

Message from the Chief

On behalf of your Police Department, I would like to personally thank all our residents who participated in the Town's Public Safety Forum on Thursday, October 19th. The community showing was awe-inspiring, with those in attendance, both in person and virtually, offering suggestions, recommendations, and, most importantly, support for their neighbors. A special shoutout to those residents who attended and courageously expressed their feelings about being personally victimized by crime. Doing so was not easy, and I commend each of you! I also wish to thank those who attended and have since taken the opportunity to contact me either by email or phone. reaffirming their commitment to support the Police Department and the Town to ensure Cheverly remains a safe place for all. The men and women of your Police Department look forward to continued engagement, reestablishment of an effective community watch program, and enhanced communication, to mention just a few of the ideas proffered that evening.

The following are some personal safety measures offered as a gentle reminder:

- Call 9-1-1 upon witnessing any crime in progress or any situation that poses an imminent threat to life or personal safety.
- For non-emergencies and general police service information, contact the Cheverly Police Department at 301-341-1055. This line will be answered during normal business hours. After hours, callers may leave a message that will receive a return call on the next business day.
- Be aware of your surroundings and avoid distractions such as talking on your cell phone. Walk in groups whenever possible and report suspicious

- activity by calling 9-1-1.
- Secure your belongings by locking your doors and windows, including properly locking your vehicle and keeping valuables out of sight.
- Do not leave valuables unattended, such as backpacks, laptops, or cellphones.

Please take advantage of the services offered by the Police Department, including home vacation checks and home security surveys. As mentioned during the Public Safety Forum, the Department is initiating programs to obtain wheel-locking devices, steering wheel-locking devices, and a reimbursement program for the purchase of home security cameras. More to follow as these programs get underway.

Please remember that Daylight Saving Time is fast approaching. "Fall Back" is a common term to denote the fall time change. It is also a reminder that we move our clocks back one hour. On Sunday, November 5, 2023, at 2:00:00 a.m., clocks are turned backward 1 hour to 1:00:00 a.m. local standard time. Don't forget to adjust your clocks to stay on schedule and enjoy the benefits of the time change.

With this time change, please be mindful of pedestrian traffic after dark. Drivers, please slow down and pay attention. Pedestrians, please wear bright-colored or reflective clothing if venturing out after dark. Traffic and pedestrian safety are everyone's responsibility. Thank you for your continued partnership as we strive to create the safest possible community for all who call Cheverly home and to make welcoming for those who work, play, and visit our town.

To request a private tree inspection visit the Town website at www.cheverly-md.gov, complete and return the Tree Evaluation Agreement form and submit the \$85 inspection fee.

Fees can be made online or via mail by check. Checks should be made payable to the Town of Cheverly and mailed or dropped off at: Town Hall, Attention Public Works, 6401 Forest Road, Cheverly, MD 20785. Once the inspection is completed the resident will receive a report on their tree. Please note: checks will not be deposited until after the inspection report is completed.

TRASH CAN SIZE FOR COLLECTION

Just a reminder, containers are not to exceed thirty-two (32) gallon capacity.



Public Works will not pick up nor empty trash containers larger than 32-gallons. This is for the safety of our Public Works employees who manually lift each and every trash can.

Vehicles that have not moved for 72+hours may be towed; all

vehicles need to be operational & legally operable on both private property and on the street.

Commercial vehicles are prohibited to park in front of residential properties.

REMINDERS FOR SPECIAL EVENT NEIGHBORHOOD BLOCK PARTY

- 1. Canvass everyone in the neighborhood to find a date that works best. Visit each neighbor to inform them of your plans and get feedback from them at least before you are tentatively scheduled to host the event. Complete a block party survey. Keep your neighbors informed as the event date approaches and make sure they understand they are a part of celebration. A block party letter and neighbor survey can be obtained at the Town office.
- 2. Obtain necessary permits if you block off your street. Permits must be obtained 30 days in advance for block parties. A Block Party Permit is

- required to block off any of a residential street for neighborhood block party purposes,
- 3. Remind your neighbors 1 week before the party that the street will be closed. It is important to keep your neighbors informed.
- 4. Place the "No Parking" signs 24-48 hours prior to the party at each end of the street with the date and time of the street closure. Town Hall can supply "No Parking" signs once the event is permitted.
- 5. We recommend that you communicate with your neighbors a week prior to the Block Party. Communicating with your neighbors help to ensure all are notified and remember not to park on the street. 6. Your street must be clean and open to traffic no later than 10 PM.

CHEVERLY RENTAL LICENSES

All single-family, multi-family, and roomer rental dwellings in Cheverly are required by Chapter 5 of the Town Code to obtain a Cheverly Rental Housing License.



Licenses are issued annually for the Fiscal Year (July 1 to June 30). Call the Code Compliance Officer at 240-770-7647 for an application.

The yearly rental license fee is \$100.00

Note: Failure to comply with Town Code licensing laws can result in a fine of \$500.

SOLID ANIMAL WASTE ORDINANCE



Sec. 4-10 (a) It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to

remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, & play areas of all other parks.

OUTDOOR BURNING REMINDER

Sec. 12-3.

- (a) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material on any improved street, gutter, parking strip, parkway, park, alley or any other town property within the corporate limits of the Town of Cheverly.
- (b) No person shall burn or cause to be burned any trash, lumber, leaves, straw, tree branches, trees, logs or other combustible material within the corporate limits of the Town of Cheverly, without first obtaining a permit from the Town of Cheverly, excluding outdoor cooking devices.

- Set lights inside the house on a timer.
- Set telephone bells as low as possible.
- Draw shades and drapes.
- Lock cars left in the driveway.
- Make sure smoke detectors are working.
- Lock all windows and doors.

"Cheverly Stream Restoration" -- Excerpts from Recommendations of the Cheverly Green Infrastructure Committee

Submitted to the Mayor and Council October 13, 2023. Find the full text at www.greencheverly.org.

The Cheverly Green Infrastructure Committee is tasked with implementation of the Cheverly Green Infrastructure Plan. The Green Infrastructure Plan designates the natural area network of hubs and corridors. The Cheverly East Park natural area is one of those hubs, and is to be managed as a community natural area.

The Prince George's County Department of the Environment, through a public-private partnership with the Clean Water Partnership, has planned a project entitled "Cheverly Stream Restoration" for Red Maple Run within the Cheverly East Park natural area.

The long-term impact of projects termed stream restorations is projected to be positive. However, the short-term loss of habitat is significant and demands offsets to the effects of that loss. As an incorporated town, Cheverly must oversee projects undertaken within its borders. We recommend that the town use its influence to help ensure a successful and sustainable project.

The Cheverly Green Infrastructure Committee makes the following recommendations to the Cheverly Mayor and Council:

- Advise the Clean Water Partnership to ensure a high survival rate of trees by planting a surplus. The recommendation provides a suggestion for planting depending on tree and shrub heights at maturity to provide sufficient surplus.
- Request details of the maintenance program. For each aspect of the program, one might ask who will carry it out, when and how much. The town may ask which of the two sets of standard maintenance monitoring criteria will be used. The recommendation outlines the two standards.
- Request post-construction educational signage. A sign would explain what was done and would provide a means to contact the agency or group responsible for maintenance through a QR code. A model might be the sign at Fletcher's Field, another CWP stream restoration project.


